An invitation is hereby made in terms of section 49(i)(a)(ii) read section 78(2) of the Act that any owner of the property or other person who desires should lodge an objection with the Municipal Manager in respect of any matter including the category, reflected in, or omitted from, the General Valuation Roll within the abovementioned period.

Persons who cannot read and write may visit room 155 on the 1st Floor Missionary Mpheni House where an explanation will be given to such persons as well as provision of assistance with regard to transcribing their comments or representation.

Attention is specifically drawn to the fact that in terms of section 50 (2) of the Act an objection must be in relation to a specific individual property and not against the General Valuation as such. 
