
**WITHDRAWAL OF CERTIFICATE OF RECOGNITION AS KGOSI OF THE BAKGATLA BA KGAFELA IN TERMS OF SECTION 14(3) OF THE NORTH WEST TRADITIONAL LEADERSHIP AND GOVERNANCE ACT 2005 (ACT NO. 2 OF 2005), ISSUED TO KGOSI JOHN NYALALA PILANE AND ISSUE OF CERTIFICATE OF RECOGNITION TO RANGWANE RAMONO PILANE LINCHWE, VALID FOR SIX MONTHS**

By virtue of the powers vested in me under section 14(3) of the North West Traditional Leadership and Governance Act, 2005 (Act No. 2 of 2005), and pursuant to the decision taken by the Bakgatla Ba Kgafela Royal Family in terms of section 14(2), read with section 14(1)(d), of the North West Traditional Leadership and Governance Act, 2005, and subject to affording Kgosi John Nyalala Pilane an opportunity to make written representations in terms of the Promotion of Administrative Justice Act, 2000 (Act No. 3 of 2000), I Tebogo Job Mokgoro, in my capacity as the Premier of the North West Province hereby, with effect from the date of publication of this notice, withdraw letter of designation as Kgosi of the Bakgatla Ba Kgafela, issued in favour of Kgosi John Nyalala Pilane.

In line with the designation dated 11 June 2020, made by the Bakgatla Ba Kgafela Royal family in terms of section 14(2) of the North West Traditional Leadership and Governance Act, 2005, and duly informed by the Royal Family, a certificate of recognition as interim Kgosi of the Bakgatla Ba Kgafela in terms of section 14(4) of the North West Traditional Leadership and Governance Act, 2005, is hereby issued to
