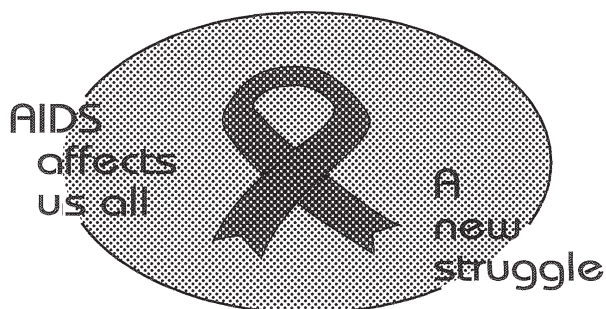

PROVINCIAL NOTICE 128 OF 2021

Department of Economic Development, Environment, Conservation and Tourism

Call for nomination for filling of three (3) vacancies of additional members to the North West Gambling Board**INTRODUCTION**

Institutions and/or individuals are hereby invited to nominate for appointment to fill **three (3)** vacancies to the North West Gambling Board in terms of Section 5(1) (c), (d), (h) and 9 (2) of the North West Gambling Board Act No 1 of 2001. The appointment of these members to the Board is until the end of the current term of office.

The North West Gambling Board is established in terms of North West Gambling Act, 2001, (Act No.1 of 2001) to oversee gambling activities in the North West Province, advise the MEC or furnish a report or recommendation to the MEC on any matter referred to the Board for consideration and arising from the application of Gambling Act regarding the control of gambling in the North West Province, to exercise such powers and perform such functions and duties as may be assigned to the Board in terms of the North West Gambling Act or any other law.

Section 14 of the North West Gambling Board Act state the Persons disqualified from being members of the board as follows:

"No person shall be appointed to or remain as a member of the Board if such person -

- (a) is not a citizen of the Republic;*
- (b) At the relevant time is, or during the preceding 12 months was, a public servant other than a person appointed in terms of section 5 (1) (c), (d), (h) or (g);*
- (c) At the relevant time is, or during the preceding 12 months was, a member of Parliament, any provincial legislature or local authority, or any council, commission or House of Traditional Leaders established in terms of the Constitution of South Africa Act 1996;*
- (d) At the relevant time is, or during the preceding 12 months was holding a position of national or provincial leadership of a political party;*
- (e) Has any direct or indirect interest in any gambling activity or any other business or enterprise that may conflict with the proper performance of his or her duties as a member of the Board;*
- (f) Or his or her partner or associate, holds an office in or with, or is employed by, any person, company, organisation or other body, whether corporate or unincorporated, which has an interest contemplated in paragraph (e);*
- (g) Is an unrehabilitated insolvent;*
- (h) Is of unsound mind, or is subject to an order of a competent court declaring such person to be mentally ill or disordered;*
- (i) Has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or any act providing for the prevention or the criminalisation of corruption, or any offence involving dishonesty, and has been sentenced therefor to imprisonment without the option of a fine or to a fine exceeding R500;*
- (j) Has at any time been removed from an office of trust on account of misconduct;*

- (k) *Failed to disclose an interest in terms of section 10 or attended or participated in the proceedings of the Board while having an interest contemplated in section 10;*
- (l) *Is not a natural person."*

Requirements

A member of the Board must be South African persons, who should be fit and proper to serve on the Board by virtue of their qualifications and experience in terms of section 5 of the North West Gambling Act, 2001 as follows:

- a. One member shall be appointed by virtue of his or her knowledge and experience in the field of welfare or socio-economic development;
- b. One member shall be appointed by virtue of his or her knowledge and active involvement in the tourism industry;
- c. One member shall be appointed on the basis of having either proven business acumen, a knowledge of the gambling industry, or who are otherwise suitable for appointment as members of the Board.

Further consideration

Nominations will be subject to the preferred candidates before assuming office make and subscribe an oath or solemn affirmation in a form determined by the Responsible Member; obtaining necessary security clearance; and Disclosure of interest.

Nomination Procedure: Written nominations must contain the full name and address of the institution and/or individual making the nomination, the nominee's signed acceptance of the nomination and his/her Curriculum Vitae, providing at least the following information: Full name, ID number and gender. Contact address, telephone and e-mail address. Previous experience (quoting dates and organisations concerned). Certified copies of academic qualifications and identity document.
