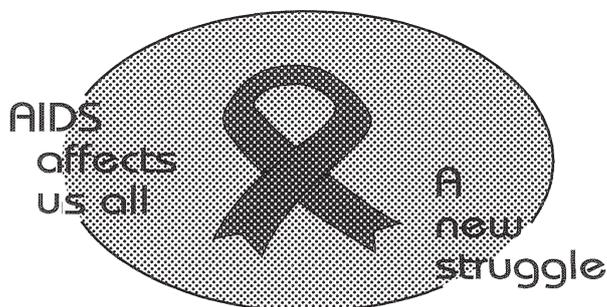



PART TWO OF THE AMENDMENTS

2. DESIGNATION OF FULL-TIME OFFICE BEARERS

Any or all the following office-bearers may be designated by the District and local councils as full-time councillors:

- (a) The Speaker;
- (b) The Executive Mayor;
- (c) Members of the Mayoral Committee and /or Executive Committee;
- (d) The Chairperson of a Committee in terms of section 79; and
- (e) A single whip.

2.2 ABOLITION OF PLENARY-TYPE MUNICIPALITY

In terms of the Municipal Structures Amendment Act, Plenary type municipality are abolished. Council elects the Mayor, and there is no executive or speaker; Mayor chairs council meetings, and council makes the decisions and plans.

PART THREE OF THE AMENDMENTS

3. BOUNDARIES AND AREAS OF JURISDICTION

The municipal boundaries and jurisdictional areas are as set out in the latest provincial General Notices as published by the Municipal Demarcation Board.

PART FOUR OF THE AMENDMENTS

4. AMENDMENTS OF POWERS AND FUNCTIONS

The powers and functions are as per section 156 of the Constitution read together with section 84 of the Municipal Structures Act and the latest gazettes on statutory allocations, divisions and devolution of powers and functions by national and provincial governments.

EXEMPTIONS

All Municipalities are not exempted from any provision of the Municipal Structures Act and related amendments.
