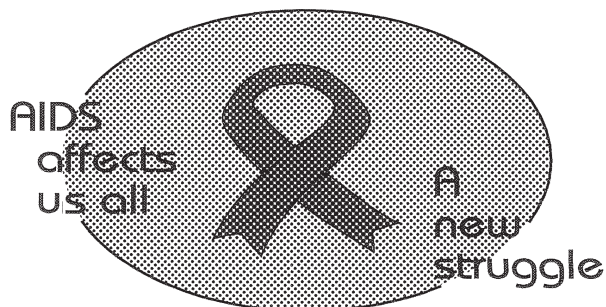

Scorebet Manufacturing (Pty) Ltd: company registered to Manufacture, supply and maintain gambling equipment. The company is incorporated in the Republic of South Africa in 2017 in terms of the Companies Act, 2008 with the following Registration No: 2017/540497/07. 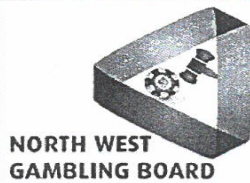
