### APPLICATIONS FOR BOOKMAKER OPERATOR LICENCES (BET EXCHANGE)

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board ("the Board") received applications for Bookmaker Licenses, as listed below.

A Bookmaker Licence shall authorise, subject to any conditions which the Board may impose, the conducting of the business of a Bookmaker in or on the premises by laying fixed odds and open bets, but not totalizator type bets
