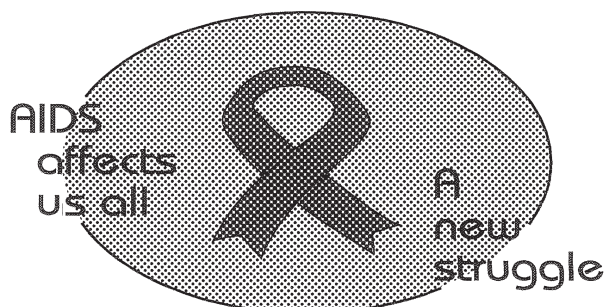

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such. The completed objection forms must be returned **by hand** to the Municipal Offices.

No form of electronic submission will be accepted. CLOSING DATE FOR OBJECTIONS IS ON 30 JUNE 2023 AT 16:00. No late objections will be accepted.
