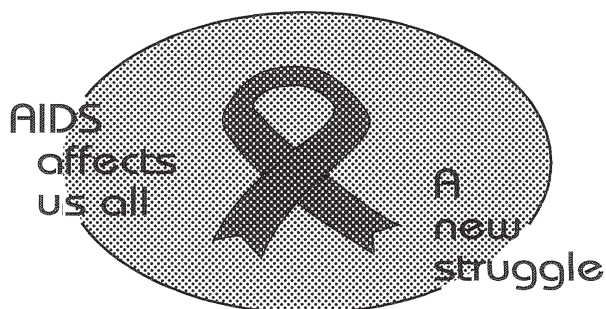

**NOTICE CALLING FOR INSPECTION OF SUPPLEMENTARY INTERIM VALUATION ROLL AND LODGING OF OBJECTION/S**

Notice is hereby given in terms of Section 49 (1) (a) (i) read together with section 78(2) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the Supplementary Valuation Roll for the financial Year **2023/2024** is open for public inspection at the **Atamelang, Delareyville, Ottosdal and Sannieshof offices** from **01 August 2023 to 12 September 2023**
