

North West Gambling Board NORTH WEST GAMBLING BOARD NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT. 2001 (ACT NO.2 OF 2001) AS AMENDED APPLICATION BY DANKOPATH (PTY) LTD TRADING AS, G-BETS NORTH WEST FOR PREMISES TO CONDUCT BOOKMAKER OPERATIONS Notice is hereby given in terms of the provisions of section 29, read together with section 57 (2) of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board ("the Board") received an application from Dankopath (Pty) Ltd, a Bookmaker Licence Holder, for premises to conduct Bookmaker operations as required by the provisions of section 57 (2) of the Act.
