**GENERAL NOTICE**

Department of Economic Development, Environment, Conservation and Tourism

**CALL FOR EXPRESSION OF INTEREST TO SERVE ON THE PANEL OF EXPERTS FOR THE NORTH WEST REVIEW TRIBUNAL IN TERMS OF THE NORTH WEST GAMBLING ACT, 2001**

I, G.T.V Tlhapi, Member of the Executive Council responsible for the Department of Economic Development, Environment, Conservation and Tourism, hereby make a call for expression of interest from persons to be appointed as members of the review tribunal in terms of Section 90(1) of the North West Gambling Act (No. 2 of 2001), within 21 days from the date of publication of this notice.

Section 90(1) of the Act provides that decisions or proceedings of the board are subject to prescribed review proceedings.

Interested individuals will be expected to undertake the following duties in line with the North West Gambling Act:

- Review decisions and proceedings of the Board
- Confirm or set aside the decisions or proceedings of the decisions; and
- Remit the matter to the Board with an order to take a decision in accordance with the correct procedure, or
- Such a decision as in its opinion ought to have been given by the Board and direct the Board to give effect to the tribunal decision.

**Minimum Requirements**

The review tribunal shall consist of three members appointed by the Responsible Member as follows:

- An advocate or retired judge with extensive legal experience;
- A person with proven business acumen (in the gambling industry) or who otherwise is suitable for appointment as a member of the tribunal.



Applications will be adjudicated in accordance with the applicable criteria as stipulated in this advertisement
