NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001 (ACT No. 2 OF 2001), AS AMENDED.

APPLICATION FOR CERTIFICATE OF SUITABILITY IN TERMS OF SECTION 78 OF THE NORTH WEST GAMBLING ACT 2001, (Act No.2 OF 2001), AS AMENDED.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application for a Certificate of Suitability by JE Gambling Corporation (Pty) Ltd to provide Consulting and Compliance services to Maponya Gaming NW(Pty) Ltd, Mawetse Gaming (Pty) Ltd, Ganhandor (Pty) Ltd, Ansino (Pty) Ltd and Central Gaming Management (Pty) Ltd.

JE Gambling Corporation (Pty) Ltd lodged the application in terms of the provisions of section 78 of the Act, which states that "*The Board may prohibit a licensee from contracting with any supplier for the purchase of goods or services in terms of this Act, including the rental of premises, or with any lender, until such supplier or lender has obtained a certificate of suitability from the Board and paid the expenses of the Board relative thereto.*"

JE GAMBLING CORPORATION (PTY) LTD is registered in terms of the Companies Act 71 of 2008, bearing registration number: 2023/925461/07. The registered business address is IE Business Center, 2nd Floor, Cnr of Buiten Street and Stateway, Welkom.
