#### A—STIGTINGSVOORWAARDEN.

##### 1. Naam.

Die naam van die dorp is Kentview.

##### 2. Ontwerpplan van die dorp.

Die dorp bestaan uit erwe en 'n straat soos aangewys op Algemene Plan L.G. No. A.797/57.

**3. Water.**

The applicants shall lodge with the Administrator for his approval a certificate from the local authority to the effect that—

- (a) a supply of potable water, sufficient for the needs of the inhabitants of the township when it is fully built up, including provision for fire fighting services, is available;
- (b) arrangements to the satisfaction of the local authority have been made regarding the delivery of the water referred to in (a) above and the reticulation thereof throughout the township; provided that such arrangements shall include the following provisions:—
  - (i) that before the plans of any building to be erected upon any erf are approved by the local authority the applicants shall cause a suitable supply of water to be laid on to the street frontage of the erf;
  - (ii) that all costs of, or connected with, the installation of plant and appurtenances for the delivery, storage if necessary, and reticulation of the water shall be borne by the applicants, who shall also be responsible for the maintenance of such plant and appurtenances in good order and repair until they are taken over by the local authority; provided that if the local authority requires the applicants to install plant and appurtenances of a capacity in excess of the needs of the township the additional costs occasioned thereby shall be borne by the local authority;
  - (iii) that the local authority shall be entitled to take over free of cost the said plant and appurtenances upon their installation;

- (c) the applicants have furnished the local authority with adequate guarantees regarding the fulfilment of their obligations under the above-mentioned arrangements.

A summarised statement setting forth the nature and quantity of the available supply of water and the major features of the arrangements entered into between the applicants and the local authority, with special reference to the guarantees referred to in sub-paragraph (c) shall accompany the said certificate as an annexure thereto.

**4. Sanitation.**

The applicants shall lodge with the Administrator for his approval a certificate from the local authority to the effect that arrangements to its satisfaction have been made for the sanitation of the township, which shall include provision for the disposal of waste water and refuse.

A summarised statement of the main provisions of the aforesaid arrangements shall accompany the certificate as an annexure thereto.

**5. Electricity.**

The applicants shall lodge with the Administrator for his approval a certificate from the local authority to the effect that arrangements to its satisfaction have been made for the supply and distribution of electricity throughout the township.

A summarised statement of the main provisions of the aforesaid arrangements shall accompany the certificate as an annexure thereto.

**6. Cemetery, Depositing and Native Location Sites.**

The applicants shall make arrangements with the local authority to the satisfaction of the Administrator in regard to the provision of a depositing site and sites for a cemetery and native location. Should such provision consist of land to be transferred to the local authority, transfer thereof shall be free of conditions restricting the use or the right of disposal thereof by the local authority.

**3. Water.**

  - (ii) dat alle koste van, of in verband met, die installering van 'n installasie en toebehore vir die levering opgaar, indien nodig, en retikulasie van die water, deur die applikante gedra moet word, en die applikante is ook aanspreklik om sodanige installasie en toebehore in 'n goeie toestand te onderhou tot tyd en wyl hulle deur die plaaslike bestuur oorgeneem word; met dien verstande dat, indien die plaaslike bestuur vereis dat die applikante 'n installasie en toebehore van 'n groter kapasiteit as wat vir die dorp nodig is, moet installeer, die ekstra koste wat daardeur meegebring word deur die plaaslike bestuur gedra moet word;
  - (iii) dat die plaaslike bestuur daartoe geregtig is om genoemde installasie en toebehore kosteloos oor te neem wanneer dit geïnstalleer word;

'n Beknopte verklaring waarin die aard en hoeveelheid van die watervoorraad beskikbaar en die hooftrekke van die reëlings tussen die applikante en die plaaslike bestuur getref, uiteengesit word, met spesiale vermelding van die waarborgs in subparagraaf (c) genoem, moet tesame met genoemde sertifikaat as 'n aanhangsel daarby ingedien word.

**4. Sanitäre dienste.**

Die applikante moet 'n sertifikaat van die plaaslike bestuur aan die Administrateur vir sy goedkeuring voorlê, waarin vermeld word dat reëlings tot voldoening van die plaaslike bestuur getref is vir die sanitäre dienste in die dorp, met inbegrip van voorsiening vir die afvoer van afvalwater en vuilisverwydering.

'n Beknopte verklaring van die hoofbepalings van voor-nomde reëlings moet tesame met die sertifikaat as 'n aanhangsel daarby ingedien word.

**5. Elektrisiteit.**

Die applikante moet 'n sertifikaat van die plaaslike bestuur aan die Administrateur vir sy goedkeuring voorlê, waarin vermeld word dat reëlings tot voldoening van die plaaslike bestuur getref is vir die levering van elektrisiteit en die distribusie daarvan deur die hele dorp.

'n Beknopte verklaring van die hoofbepalings van voor-nomde reëlings moet tesame met die sertifikaat as 'n aanhangsel daarby ingedien word.

**6. Begraafplaas-, Stortings- en Naturellelokasieterreine.**

Die applikante moet tot voldoening van die Administrateur met die plaaslike bestuur reëlings tref ten opsigte van die verskaffing van 'n stortingsterrein en terreine vir 'n begraafplaas en Naturellelokasië. As sodanige verskaffing bestaan uit grond aan die plaaslike bestuur oorgedra te word, is die oordrag daarvan nie onderworpe aan voorwaardes waarby die gebruik of die reg van vervreemding daarvan deur die plaaslike bestuur, beperk word nie.

### 7. Mineral Rights.

All rights to minerals and precious stones together with all rights which may be or become vested in the freehold owner to share in any proceeds which may accrue to the Crown from the disposal of the undermining rights of the township, including the share of claim licence moneys and any share of rentals or profits which may accrue to any owner under any mining lease granted in respect of the land covered by the township and the like shall be reserved to the applicants as follows:—

- (a) In favour of Morucone Investments (Proprietary), Limited, in respect of the land held under Deed of Transfer No. 26609/1944;
- (b) In favour of Rosina Elizabeth Ueckermann, married out of community of property to Tobias Johannes Ueckermann in respect of the land held under Deed of Transfer No. 5432/1930.

### 8. Cancellation of Existing Conditions.

The applicants shall obtain the cancellation of the existing restrictive conditions relating to subdivision, the erection of more than one dwelling-house, use and occupation of the land by coloured persons described in Notarial Deed No. 75/1942S.

### 9. Street.

(a) The applicants shall submit to the local authority for its approval a detailed scheme complete with plans, sections and specifications, prepared by a Civil Engineer approved by the local authority for the construction, tarmacadamising, kerbing and channelling of the street in the township together with the provision of such retaining walls as may be considered necessary by the local authority. Furthermore the scheme shall indicate the route and gradient by which each erf gains access to the street.

(b) Particulars of any scheme approved by the local authority shall be submitted to the Administrator for his approval.

### 10. Street Construction.

(a) The approved scheme relating to street construction referred to in clause A 9 hereof, shall be carried out by the applicants at their own expense on behalf of and to the satisfaction of the local authority under the supervision of a Civil Engineer approved by the local authority, and no erf, other than the erven referred to in clause A 12 hereof, shall be disposed of until the local authority has certified that the requirements of this clause have been complied with.

(b) The applicants shall be responsible for the maintenance of the street until such time as this responsibility is taken over by the local authority, provided that the applicants' responsibility to maintain it shall cease when one of the erven abutting thereon has been built upon.

(c) The street shall be named to the satisfaction of the local authority.

### 11. Endowment.

The applicants shall in terms of section 27 (1) (b) of Ordinance No. 11 of 1931, pay to the local authority as an endowment the sum of £1,000 (one thousand pounds) upon proclamation of the township.

### 12. Land for Municipal Purposes.

The following erven in the General Plan shall be transferred to the proper authority by and at the expense of the applicant:—

- (a) As a park: Erf No. 10.
- (b) As a transformer site: Erven Nos. 8 and 9.

NOTE.—Erven Nos. 8 and 9 shall be consolidated simultaneously with the transfer thereof to the proper authority.

### 13. Restriction Against the Disposal of Certain Erven.

(a) The following sets of two erven each shall be transferred to one and the same purchaser and shall be consolidated simultaneously with such transfer:—

- Erven Nos. 1 and 2;
- Erven Nos. 6 and 7.

### 7. Mineraleregte.

Alle regte op minerale en edelgesteentes met inbegrip van alle regte wat by die pagvry-grondbesitter berus of hierna kan berus om te deel in die geldie wat moontlik aan die Kroon kan toekom uit die verkoop van mynregte oor die dorp; asook die aandeel in kleimilisensiegelede en enige aandeel in huurgeldie of winste wat moontlik aan enige eienaar kan toekom ingevolge enige mynbrief ten opsigte van die grond binne die dorp, en dergelyke geldie, word aan die applikante voorbehou as volg:—

- (a) Ten gunste van Morucone Investments (Proprietary), Limited, ten opsigte van die grond kragtens Transportakte No. 26609/1944 gehou;
- (b) ten gunste van Rosina Elizabeth Ueckermann, buite gemeenskap van goedere getroud met Tobias Johannes Ueckermann, ten opsigte van die grond kragtens Transportakte No. 5432/1930 gehou.

### 8. Opheffing van bestaande voorwaardes.

Die applikante moet die bestaande beperkende voorwaardes betreffende onderverdeling, die oprigting van meer as een woonhuis, gebruik en okkupasie van grond deur Kleurlinge omskryf in Notariële Akte No. 75/1942S., laat ophef.

### 9. Straat.

(a) Die applikante moet 'n gedetailleerde skema volledig met planne, seksies en spesifikasies, opgestel deur 'n Siviele Ingenieur wat deur die plaaslike bestuur goedgekeur is, aan die plaaslike bestuur vir sy goedkeuring voorlê, vir die bou, teermacadamisering, voorsiening van randstene en slote van die straat in die dorp tesame met die voorsiening van sodanige steunmure as wat deur die plaaslike bestuur nodig geag word. Verder moet die skema die roete en gradiënt aanwys waarmee iedere erf toegang verkry tot die straat.

(b) Besonderhede van enige skema wat deur die plaaslike bestuur goedgekeur is, moet aan die Administrateur vir sy goedkeuring voorgelê word.

### 10. Bou van straat.

(a) Die goedgekeurde skema met betrekking tot die bou van die straat in klousule A 9 hiervan genoem, moet deur die applikante op eie koste namens en tot voldoening van die plaaslike bestuur uitgevoer word onder die toesig van 'n Siviele Ingenieur wat deur die plaaslike bestuur goedgekeur is, en geen erf, uitgesonderd die erwe in klousule A 12 hiervan genoem, mag van die hand gesit word nie totdat die plaaslike bestuur gesertifiseer het dat daar aan die vereistes van hierdie klousule voldoen is.

(b) Die applikante is aanspreeklik vir die onderhoud van die straat tot tyd en wyl hierdie aanspreeklikheid deur die plaaslike bestuur oorgeneem word; met dien verstande dat die applikante se aanspreeklikheid om die straat te onderhou, ophou wanneer op een van die erwe wat daar-aan grens, gebou is.

(c) Die straat moet tot voldoening van die plaaslike bestuur 'n naam gegee word.

### 11. Skenking.

Die applikante moet, ingevolge die bepalings van artikel sewe-en-twintig (1) (b) van Ordonnansie No. 11 van 1931, as 'n skenking by die proklamasie van die dorp aan die plaaslike bestuur 'n bedrag van £1,000 (eenduisend pond) betaal.

### 12. Grond vir municipale doeleinades.

Die volgende erwe op die Algemene Plan moet deur en op koste van die applikante aan die aangewese owerheid oorgedra word:—

- (a) As 'n park: Erf No. 10.

- (b) As 'n transformatorterrein: Erwe Nos. 8 en 9.

OPMERKING.—Erwe Nos. 8 en 9 moet gelyktydig met die oordrag daarvan aan die aangewese owerheid, gekonsolideer word.

### 13. Beperking op die van die hand sit van sekere erwe.

(a) Die volgende stelle van twee erwe elk moet aan dieselfde koper oorgedra word en moet gelyktydig met sodanige oordrag gekonsolideer word:—

- Erwe Nos. 1 en 2;

- Erwe Nos. 6 en 7.

(b) Erven Nos. 3, 4 and 5 shall be transferred to one and the same purchaser and shall be consolidated simultaneously with such transfer.

#### 14. Right Not to be Passed On.

The right of way, 40 feet wide, along the northern boundary of the remaining extent of portion of the farm held under Deed of Transfer No. 5433/1930 up to the main road traversing the remaining extent, to which the land is entitled, shall not be passed on to owners of erven in the township.

#### 15. Enforcement of Conditions.

The applicants shall observe the conditions of establishment and shall take the necessary steps to secure the enforcement of the conditions of title and any other conditions referred to in section *fifty-six bis* of Ordinance No. 11 of 1931, provided that the Administrator shall have the power to relieve the applicants of all or any of the obligations and to vest these in any other person or body of persons.

### B—CONDITIONS OF TITLE.

#### 1. All Erven.

The erf shall not be entitled to the right of way, 40 feet wide, along the northern boundary of the remaining extent of portion of the farm held under Deed of Transfer No. 5433/1930, up to the main road traversing the remaining extent, but shall be subject to existing conditions and servitudes, including the reservation of rights to minerals, but excluding the servitude of right of way, 40 feet wide, in favour of Portion 1 of portion of the farm held under Deed of Transfer No. 5431/1930, which affects Erven Nos. 1 and 2 only.

#### 2. The Erven with Certain Exceptions.

The erven with the exception of—

- (i) the erven mentioned in clause A 12 hereof;
- (ii) such erven as may be acquired for Government or Provincial purposes; and
- (iii) such erven as may be acquired for municipal purposes provided the Administrator, after consultation with the Board, has approved the purposes for which such erven are required;

shall be subject to the further conditions hereinafter set forth:—

- (a) The applicant and any other person or body of persons so authorised in writing by the Administrator shall, for the purpose of securing the enforcement of these conditions and any other conditions referred to in section *fifty-six bis* of Ordinance No. 11 of 1931, have the right and power at all reasonable times to enter into and upon the erf for the purpose of such inspection or inquiry as may be necessary to be made for the above-mentioned purpose.
- (b) The erf, or any portion thereof, shall not be transferred, leased or in any other manner assigned or disposed of to any Coloured person and no Coloured persons other than the servants of the owner or occupier bona fide and necessarily employed on the erf shall be permitted to reside thereon or in any other manner to occupy it.
- (c) The elevational treatment of all buildings shall conform to good architecture so as not to interfere with the amenities of the neighbourhood.
- (d) Neither the owner nor any other person shall have the right, save and except to prepare the erf for building purposes, to excavate therefrom any material without the written consent of the local authority.

(b) Erwe Nos. 3, 4 en 5 moet aan dieselfde koper oorgedra word, en moet terselfdertyd met sodanige oordrag gekonsolideer word.

#### 14. Regte nie oorgedra te word nie.

Die deurgangsreg, 40 voet breed, langs die noordelike grens van die resterende gedeelte van die plaas gehou kragtens transportakte No. 5433/1930 tot by die grootpad oor die resterende gedeelte, waarop die grond geregtig is, mag nie aan eienaars van erwe in die dorp oorgedra word nie.

#### 15. Nakoming van voorwaardes.

Die applikante moet die stittingsvoorwaardes nakom en moet die nodige stappe doen om te sorg dat die titelvoorwaardes en ander voorwaardes genoem in artikel *ses-en-vyftig bis* van Ordonnansie No. 11 van 1931, nagekom word; met dien verstande dat die Administrateur die bevoegdheid besit om die applikante van almal of enige van die verpligtings te onthef en sodanige verpligtings by enige ander persoon of liggaam van persone te laat berus.

### B—TITELVOORWAARDES.

#### 1. Alle erwe.

Die erf is nie geregtig nie op die deurgangsreg, 40 voet breed, langs die noordelike grens van die resterende gedeelte van die plaas gehou kragtens Transportakte No. 5433/1930 tot by die grootpad oor die resterende gedeelte, maar is onderworpe aan bestaande voorwaardes en serwitute met inbegrip van die voorbehou van mineraleregte, maar uitgesonderd die serwituut van deurgangsreg, 40 voet breed, ten gunste van Gedeelte 1 van gedeelte van die plaas gehou kragtens Transportakte No. 5431/1930, wat slegs Erwe Nos. 1 en 2 raak.

#### 2. Die erwe met sekere uitsonderings.

Die erwe uitgesonderd—

- (i) die erwe in klousule A 12 hiervan vermeld;
- (ii) erwe wat vir Goewerments- of Provinciale doelendes verkry word; en
- (iii) erwe wat vir munisipale doeleinades verkry word mits die Administrateur, na raadpleging met die Dorperaad, die doeleinades waarvoor sodanige erwe nodig is, goedgekeur het—

is onderworpe aan onderstaande verdere voorwaardes:—

- (a) Die applikante en enige ander persoon of liggaam van persone wat skriftelik deur die Administrateur daartoe magtiging verleen is, het met die doel om te sorg dat hierdie voorwaardes en enige ander voorwaardes genoem in artikel *ses-en-vyftig bis* van Ordonnansie No. 11 van 1931 nagekom word, die reg en bevoegdheid om op alle redelike tye die erf te betree ten einde sodanige inspeksie te doen of ondersoek in te stel as wat vir bovermelde doel gedoen of ingestel moet word.
- (b) Die erf of enige gedeelte daarvan mag nie aan 'n Kleurling oorgedra, verhuur of op 'n ander manier toegewys of van die hand gesit word nie en geen Kleurlinge, uitgesonderd die eienaar of okkuperer se bedienedes, *bona fide* en noodsaaklik in diens op die erf, mag toegelaat word om daarop te woon of om dit op 'n ander manier te okkuper nie.
- (c) Die opstand van alle geboue moet voldoen aan die vereistes van goeie argitektuur sodat dit nie die bevalligheid van die omgewing benadeel nie.
- (d) Nog die eienaar nog enigiemand anders het die reg om, behalwe om die erf vir boudoeleinades in gereedheid te bring, enige materiaal daarop uit te grawe sonder die skriftelike toesteemming van die plaaslike bestuur.

- (e) No animal as defined in the Local Authorities' Pounds Regulations framed under the Local Government Ordinance, No. 17 of 1939, shall be kept on the erf.
- (f) No wood and/or iron buildings or buildings of unburnt claybrick shall be erected on the erf.
- (g) where, in the opinion of the local authority, it is impracticable for stormwater to be drained from higher-lying erven direct to a public street the owner of the erf shall be obliged to accept and/or permit the passage over the erf of such stormwater; provided that the owners of any higher-lying erven, the stormwater from which is discharged over any lower-lying erf, shall be liable to pay a proportionate share of the cost of any pipeline or drain which the owner of such lower-lying erf may find necessary to lay or construct for the purpose of conducting the water so discharged over the erf, and provided further that, in the event of a dispute between the parties as to the nature or the position of the pipeline or drain, or the allocation of the cost, the matter shall be referred to the Administrator or his nominee, whose decision shall be final.
- (h) The erf shall be used solely for the purpose of erecting thereon a dwelling-house or a block of flats, boarding house, hostel or other buildings for such uses as may be allowed by the Administrator from time to time after reference to the Board and the local authority, provided that the local authority may permit such other buildings as may be provided for in an approved Town-planning Scheme, subject to the conditions of the scheme under which the consent of the local authority is required and provided further that until the erf is connected to a public sewerage system the buildings shall not exceed two storeys in height.
- (i) Neither the owner nor any other person shall have the right to make or permit to be made upon the erf for any purpose whatsoever any bricks, tiles or earthenware pipes or other articles of a like nature.
- (k) The main building, which shall be a completed building and not one partly erected and intended for completion at a later date, shall be erected simultaneously with or before the erection of the outbuildings.
- (l) Buildings, including outbuildings, hereafter erected on the erf shall be located not less than 50 feet (English) from any boundary thereof.
- (m) In the event of a dwelling-house being erected on the erf not more than one dwelling-house together with such outbuildings as are ordinarily required to be used in connection therewith shall be erected on the erf except with the consent of the Administrator; provided that if the erf is subdivided or it or any portion of it is consolidated with any other erf or portion of an erf this condition may with the consent of the Administrator be applied to each resulting portion or consolidated area. The dwelling-house exclusive of outbuildings to be erected on the erf shall be of the value of not less than £3,000.
- (n) If the erf is fenced, or otherwise enclosed, the fencing or other enclosing device shall be erected and maintained to the satisfaction of the local authority.

### 3. Erven Subject to Special Conditions.

In addition to the conditions set out above, the undermentioned erven shall be subject to the following conditions:—

- (a) *Erven Nos. 6 and 7.*—Stormwater from the erf shall be discharged into Salley's Alley and not on to the park (Erf No. 10).
- (b) *Erf No. 2.*—The erf is subject to a servitude for street purposes, 80 feet by 80 feet, as indicated on the general plan, in favour of the local authority.

- (e) Behalwe met die toestemming van die plaaslike bestuur mag geen dier, soos omskryf in die Skutregulasies van Plaaslike Besture, opgestel ingevolge die Ordonnansie op Plaaslike Bestuur, No. 17 van 1939, op die erf aangehou word nie.
- (f) Geen geboue van hout en/of sink of van roustene mag op die erf opgerig word nie.
- (g) Waar dit na die mening van die plaaslike bestuur onuitvoerbaar is om neerslagwater van erwe met 'n hoër ligging regstreeks na 'n publieke straat af te voer, is die eienaar van die erf verplig om te aanvaar dat sodanige neerslagwater op sy erf vloeï en/of toe te laat dat dit daaroor loop; met dien verstande dat die eienaar van erwe met 'n hoër ligging, van waar die neerslagwater oor 'n erf met 'n laer ligging loop, aanspreeklik is om 'n eweredige aandeel van die koste te betaal van enige pyplyn of afleivoor wat die eienaar van sodanige erf met 'n laer ligging nodig vind om aan te lê of te bou, om die water wat aldus oor die erf loop, af te voer, en voorts met dien verstande dat, in geval van 'n geskil tussen die partye in verband met die aard of ligging van die pyplyn of afleivoor of die toewysing van die koste, die saak verwys word na die Administrateur of persoon deur hom aangewys, by wie die eindbeslissing berus.
- (h) Die erf moet slegs gebruik word om daarop 'n woonhuis op te rig om 'n woonstelgebou, losieshuis, koshuis of ander geboue vir sodanige gebruik as wat die Administrateur van tyd tot tyd, na raadpleging met die Dorperaad en die plaaslike bestuur, toelaat; met dien verstande dat die plaaslike bestuur sodanige ander geboue waarvoor in 'n goedgekeurde dorpsaanlegskema voorsiening gemaak word, kan toelaat, behoudens die voorwaardes van die skema waarvolgens die toestemming van die plaaslike bestuur vereis word, en voorts met dien verstande dat die geboue nie meer as twee verdiepings hoog mag wees nie totdat die erf met 'n publieke rioleringstelsel verbind is.
- (i) Nog die eienaar nog enigiemand anders besit die reg om vir enige doel hoegenaamd bakstene, teëls of erdepype of ander artikels van 'n soortgelyke aard op die erf te vervaardig.
- (k) Die hoofgebou, wat 'n voltooide gebou moet wees en nie een wat gedeeltelik opgerig en later voltooi sal word nie, moet gelyktydig met, of vóór, die oprigting van die buitegeboue opgerig word.
- (l) Geboue, met inbegrip van buitegeboue, wat hierna op die erf opgerig word, moet minstens 50 voet (Engelse) van enige grens daarvan geleë wees.
- (m) Ingeval 'n woonhuis op die erf opgerig word, mag nie meer as een woonhuis met sodanige buitegeboue as wat gewoonlik vir gebruik in verband daarmee nodig is op die erf opgerig word nie, behalwe met die toestemming van die Administrateur; met dien verstande dat as die erf onderverdeel word of as dit of enige gedeelte daarvan met enige ander erf of gedeelte van 'n erf gekonsolideer word, bierdie voorwaarde met die toestemming van die Administrateur op elke gevoldelike gedeelte of gekonsolideerde gebied toegepas kan word. Die waarde van die woonhuis, sonder inbegrip van die buitegeboue, wat op die erf opgerig gaan word, moet minstens £3,000 wees.
- (n) Indien die erf omhein of op 'n ander wyse toegemaak word, moet die heining of ander omheiningsmateriaal tot voldoening van die plaaslike bestuur opgerig en onderhou word.

### 3. Erwe aan spesiale voorwaardes onderworpe.

Benewens die betrokke voorwaardes hierbo uiteengesit, is onderstaande erwe aan die volgende voorwaardes onderworpe:—

- (a) *Erwe Nos. 6 en 7.*—Neerslagwater van die erf moet in Salley's Alley afgeweert word en nie in die park (Erf No. 10) nie.
- (b) *Erf No. 2.*—Die erf is onderworpe aan 'n serwituut vir straatdooleindes, 80 voet by 80 voet, soos aangewys op die algemene plan, ten gunste van die plaaslike bestuur.

#### 4. Servitudes for Sewerage and other Municipal Purposes.

In addition to the relevant conditions set out above, the erven upon which servitudes are indicated on the general plan shall be subject to the following conditions:

- (a) The erf is subject to a servitude for sewerage and other municipal purposes, as indicated on the general plan, in favour of the local authority.
- (b) No building or other structure shall be erected within the aforesaid servitude area and no large-rooted trees shall be planted within the area of such servitude or within 6 feet thereof.
- (c) The local authority shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance and removal of such sewerage mains and other works as it in its discretion may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose subject to any damage done during the process of constructing, maintaining and removing such sewerage mains and other works being made good by the local authority.

#### 5. Definitions.

In the foregoing conditions the following terms shall have the meaning assigned to them:

- (i) "Applicants" means (a) Morucone Investments (Proprietary), Limited; and (b) Rosina Elizabeth Ueckermann, married out of community of property to Tobias Johannes Ueckermann, and their successors in title to the township.
- (ii) "Coloured person" means any African or Asiatic native, Cape Malay, or any person who is manifestly a coloured person and includes any partnership or company or association of persons, in which any such person has the power to exercise any control whatsoever over the activities or assets of such partnership or company or association of persons.
- (iii) "Dwelling-house" means a house designed for use as a dwelling for a single family.

#### 6. Government and Municipal Erven.

Should any erf referred to in clause A 12 or erven acquired as contemplated in clauses B 2 (ii) and (iii) hereof come into the possession of any person other than the Government or the local authority such erf shall thereupon be subject to such of the aforementioned or such other conditions as may be decided by the Administrator after consultation with the Board.
