MUNISIPALITEIT BEDFORDVIEW.—VOOR-GESTELDE VERANDERING VAN GRENSE.

1. (1) The Transvaal Teachers' Pension Ordinance, 1959, the Transvaal Hospital and Education Officers' Pension Ordinance, 1959, and the Transvaal Hospital Nurses' Pension Ordinance, 1959, are hereby amended by the substitution for paragraphs (c) and (d) of sub-section (1) of section eight thereof of the following paragraphs:—

- (c) interest at the rate of four per cent per annum on the daily uninvested balance of the Fund;
- (d) a sum equal to the deficiency if the total investments of the Fund during any financial year produce an average rate of interest lower than four per cent per annum; and
- (e) any other moneys due to the Fund by the Administration."

DRAFT ORDINANCE

To provide for the control, regulation and prohibition of drive-in theatres, to provide for the division of land required for the purpose of a drive-in theatre and for matters incidental thereto.

BE IT ENACTED by the Provincial Council of Transvaal as follows:—

Definitions. 1. In this Ordinance, unless the context otherwise indicates—

“Administrator” means the officer appointed under the provisions of section *sixty-eight* of the South Africa Act, 1909, acting on the advice and with the consent of the Executive Committee of the Province;

“Director” means the Director of Local Government appointed in terms of the provisions of section *nine* of the Local Government Control Ordinance, 1958;

“local authority” means a town council, village council or health committee constituted under and by virtue of the provisions of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939), and shall include the Peri-Urban Areas Health Board established under and by virtue of the provisions of the Peri-Urban Areas Health Board Ordinance, 1943 (Ordinance No. 20 of 1943).

No drive-in theatre to be carried on except with the consent of the Administrator.

2. (1) Notwithstanding anything to the contrary contained in any other law but subject to the provisions of sub-section (2), no person shall, after the date of coming into operation of this Ordinance, carry on a drive-in theatre without first having obtained the consent of the Administrator as contemplated in this Ordinance.

(2) The provisions of this Ordinance shall not apply with reference to any drive-in theatre which was being carried on at the date of coming into operation thereof.

(3) Any consent given in terms of sub-section (1) shall not derogate from the provisions of any other law.

Application for drive-in theatre.

3. (1) Any person who intends carrying on a drive-in theatre shall, after compliance with such requirements as may be prescribed, if the site on which it is proposed to carry on the drive-in theatre—

(a) is situated within the area of jurisdiction of a local authority, give written notice of his intention to such local authority and the Director; or

(b) is not situated within the area of jurisdiction of a local authority but within five miles of the boundaries of any local authority, give written notice of his intention to every such local authority and to the Director; or

(c) is not situated within the area of jurisdiction of a local authority and is more than five miles from the boundaries of any local authority, give written notice of his intention to the Director.

(2) After compliance with the provisions of sub-section (1) and such requirements as may be prescribed, application to carry on a drive-in

Consideration of application.

5. (1) The Director shall, after the requirements of this Ordinance have been complied with, submit the application referred to in sub-section (2) of section *three* to the Administrator recommending that—

- (a) the application be granted subject to such of the following conditions as the Director may deem fit to include in any such recommendation regarding—
- (i) points of access and egress from the site of the proposed drive-in theatre;
 - (ii) construction works to be undertaken and completed on the site of the proposed drive-in theatre;
 - (iii) any monetary or other contribution to be made by the applicant towards the construction or maintenance or both the construction and maintenance of roads which will be used or are likely to be used in connection with the proposed drive-in theatre;
 - (iv) measures to be taken by the applicant to ensure safety of persons on the site of the proposed drive-in theatre;
 - (v) the safeguarding of traffic on any public road leading or adjacent to the proposed drive-in theatre;
 - (vi) advertising at any place on the site of the proposed drive-in theatre, other than on the projection screen thereof;
 - (vii) measures to be taken to ensure the cleanliness and general hygiene of the premises of the proposed drive-in theatre;

Offences and penalties.

Any person who contravenes or fails to comply with any provision of this Ordinance, or contravenes or fails to comply with any of the conditions referred to in sub-section (2) of section five shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds or imprisonment for a period not exceeding six months or to both such fine and such imprisonment in the case of a continuing offence to a fine not exceeding twenty-five pounds per day for each day during which the default continues.

Regulations.

7. (1) The Administrator may make regulations, not inconsistent with the provisions of this Ordinance—

(a) in respect of any matter contemplated, required or permitted to be prescribed under this Ordinance; and

(b) generally for the better carrying out of the objects and purposes of this Ordinance.

(2) Any regulation made under sub-section (1) may be made to apply generally throughout the Province or within any part thereof and different regulations may be made under that sub-section for different circumstances.

(3) Any regulation made under sub-section (1) may provide penalties for any breach thereof, but no penalty shall exceed a fine of one hundred pounds or imprisonment for a period of six months, or both such fine and imprisonment.
