terms of the provisions of section *eighty-nine* of the
Republic of South Africa Constitution Act, 1961, assented
to the said Ordinance;

And whereas power is vested in me by section *ninety*
of the Republic of South Africa Constitution Act, 1961,
to promulgate an Ordinance assented to by the State
President-in-Council;

Now, therefore, I do hereby promulgate the said
Ordinance, which is printed hereunder.

ORDINANCE NO. 10 OF 1961.

(Assented to on 6th July, 1961.)

(English copy signed by the State President.)

AN ORDINANCE

To apply a sum not exceeding R139,922,647 towards the service
of the Province of Transvaal during the year ending on the
31st day of March, 1962.

BE IT ENACTED by the Provincial Council of Trans-
vaal as follows:—

1. The Provincial Revenue Fund is hereby Provincial

charged
with
R136,415,127.
charged with such sums of money as may be
required for the service of the Province during
the year ending on the 31st day of March, 1962,
not exceeding in the aggregate the sum of one
hundred and thirty-six million four hundred and
fifteen thousand one hundred and twenty-seven
rand:

To defray normal or recurrent
expenditure R115,735,127

To defray capital or non-
recurrent expenditure R 20,680,000

2. The money appropriated by section *one* How money
to be
applied.
shall be applied to the services as detailed in the
First Schedule to this Ordinance and more parti-
cularly specified in the Estimates of Expenditure
(Nos. T.P. 3 and 4 of 1961), as approved by the
Provincial Council, and subject to section *three*
hereof and to no other purpose.

3. With the approval of the Administrator,
acting with the consent of the Executive Com-
mittee, a saving on any sub-head of a vote may
be made available to meet excess expenditure on
any other sub-head or expenditure on a new sub-
head of the same vote, provided that no excess
shall be incurred on the sums appearing in
column 2 of the Schedules to this Ordinance nor
shall savings thereon be available for any purpose
other than that for which the money is hereby
granted.
