**D**IE Provinsiale Raad van Transvaal VERORDEN AS VOLG:—

Wysiging van artikel 2 van Ordonnansie 10 van 1928, soos gewysig by artikel 1 van Ordonnansie 14 van 1933, artikels 3 en 4 van Ordonnansie 14 van 1938, artikel 2 van Ordonnansie 4 van 1945, artikel 2 van Ordonnansie 12 van 1946, artikel 1 van Ordonnansie 12 van 1947, artikel 1 van Ordonnansie 24 van 1953, artikel 1 van Ordonnansie 10 van 1954, artikel 2 van Ordonnansie 10 van 1955, artikel 1 van Ordonnansie 9 van 1958, artikel 1 van Ordonnansie 18 van 1959 en artikel 6 van Ordonnansie 29 van 1960.

Kort titel.

1. Ondanks andersluidende bepalings in die Persoonlike en Inkomstebelastings Ordonnansie, 1928, vervat, word subartikel (1) van artikel twee daarvan, ten opsigte van die jaar van aanslag wat op die dertigste dag van Junie 1961 eindig, vertolk asof die belasting daarin vermeld met twintig persent vermeerder was.

2. (1) Artikel *agt* van die Persoonlike en Inkomstebelastings Ordonnansie, 1928, word hierby gewysig deur in die Afrikaanse teks die woord „of”; waar dit vir die eerste maal voorkom, deur die woord „n” te vervang.

(2) Subartikel (1) word geag in werking te getree het op die datum waarop die Wysigingsordonnansie op Persoonlike en Inkomstebelastings, 1960 (Ordonnansie No. 29 van 1960), van krag geword het.

3. Die jaarlikse persentasie beoog in subartikel (2) van artikel twee van die Persoonlike en Inkomstebelastings Ordonnansie, 1928, word hierby vasgestel op dertig persent ten opsigte van die jaar van aanslag wat op die dertigste dag van Junie 1961 eindig.

ORDINANCE NO. 9 OF 1961.

## AN ORDINANCE

To amend the Personal and Income Taxes Ordinance, 1928, and to fix, in respect of the year of assessment ending on the thirtieth day of June, 1961, the annual percentage contemplated in sub-section (2) of section two of that Ordinance.

**B**E IT ENACTED by the Provincial Council of Transvaal as follows:—

1. Notwithstanding anything to the contrary contained in the Personal and Income Taxes Ordinance, 1928, sub-section (1) of section two thereof shall, in respect of the year of assessment ending on the thirtieth day of June, 1961, be construed as if the tax therein provided for had been increased by twenty per cent.

2. (1) Section *eight* of the Personal and Income Taxes Ordinance, 1928, is hereby amended by the substitution in the Afrikaans text for the word “of”, where it appears for the first time, of the word “n”.

(2) Sub-section (1) shall be deemed to have come into operation on the date from which the Personal and Income Taxes Amendment Ordinance, 1960 (Ordinance No. 29 of 1960), took effect.

3. The annual percentage contemplated in sub-section (2) of section two of the Personal and Income Taxes Ordinance, 1928, is hereby fixed at thirty per cent in respect of the year of assessment ending on the thirtieth day of June, 1961.

4. This Ordinance shall be called the Personal and Income Taxes Amendment Ordinance, 1961.
