ORDINANCE NO. 15 OF 1961.

AN ORDINANCE

To amend the Financial Adjustments Ordinance, 1961.

BE IT ENACTED by the Provincial Council of Transvaal as follows:—

1. Section *two* of the Financial Adjustments Ordinance, 1961 (hereinafter referred to as the principal Ordinance), is hereby amended by the substitution for the words “one million three hundred thousand” of the words “three million three hundred and thirty thousand”.
Amendment of section 2 of Ordinance 14 of 1961.

2. Section *three* of the principal Ordinance is hereby amended by the substitution for the word “four” of the word “two”.
Amendment of section 3 of Ordinance 14 of 1961.

3. This Ordinance shall be called the Financial Adjustments Amendment Ordinance, 1961, and shall be deemed to have come into operation on the date of the coming into operation of the principal Ordinance.

Tot wysiging van die Padverkeersordonnansie, 1957.

DIE Provinciale Raad van Transvaal VERORDEN AS VOLG:—

Wysiging van artikel 1 van Ordonnansie 18 van 1957, soos gewysig by artikel 1 van Ordonnansie 26 van 1958 en artikel 1 van Ordonnansie 35 van 1960.

1: Artikel een van die Padverkeersordonnansie, 1957 (hierna die Hoofordonnansie genoem), word hierby gewysig deur in die woordomskrywing van "drywer" in die Afrikaanse teks, die woorde „op 'n openbare pad" te skrap.

2. Artikel veertien van die Hoofordonnansie word hierby gewysig deur—

(a) die voorbehoudbepaling in paragraaf (a) van subartikel (1) vervat, deur die volgende voorbehoudbepaling te vervang:

„Met dien verstande dat in die geval van enige sodanige motorvoertuig wat vir gebruik deur die Staatspresident afgesonder is, 'n embleem waarin die republikeinse wapen en die letters SP omvat word, geag word 'n registrasie-merk en -nommer te wees"; en

(b) in paragraaf (b) van die genoemde subartikel, die woorde „Unie-departement van Buitelandse Sake" deur die woorde „Departement van Buitelandse Sake" en die woorde „Unie" deur die woorde „Republiek" te vervang.

3. Artikel agt-en-dertig van die Hoofordonnansie word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

„(1) Geen motorhandelaar wat die houer is van 'n motorhandelaarslisensie, mag 'n motorvoertuig kragtens sodanige lisensie op 'n openbare pad gebruik nie tensy sodanige voertuig 'n voertuig is wat sy eiendom is in die loop van sy besigheid vir die doel om dit te verkoop of te verruil.".

4. Artikel vier-en-veertig van die Hoofordonnansie word hierby gewysig deur in subartikel (1) die woorde „ten opsigte van enige kleinhandelsbesigheid waarvan hy die eienaar is," deur die woorde „ten opsigte van die kleinhandelsbesigheid waarvoor sodanige lisensie gehou word," te vervang.

Wysiging van artikel 44 van Ordonnansie 18 van 1957.

ORDINANCE NO. 16 OF 1961.

(*Assented to on 26th January, 1962.*)
(*Afrikaans copy signed by the State President.*)

AN ORDINANCE

To amend the Road Traffic Ordinance, 1957.

BE IT ENACTED by the Provincial Council of Transvaal as follows:—

1. Section one of the Road Traffic Ordinance, 1957 (hereinafter referred to as the principal Ordinance), is hereby amended by the deletion in the definition of "drywer" in the Afrikaans text, of the words "op 'n openbare pad".

2. Section fourteen of the principal Ordinance is hereby amended by—

(a) the substitution for the proviso contained in paragraph (a) of sub-section (1), of the following proviso:

“Provided that in the case of any such motor vehicle set aside for use by the State President, an emblem embodying the republican coat of arms and the letters SP shall be deemed to be a registration mark and number”; and

(b) the substitution in paragraph (b) of the said sub-section for the words “the Union Department of External Affairs” of the words “Department of Foreign Affairs” and for the word “Union” of the word “Republic”.

3. Section thirty-eight of the principal Ordinance is hereby amended by the substitution for sub-section (1) of the following sub-section:

“(1) No motor dealer, who is the holder of a motor dealer's licence, shall operate a motor vehicle on a public road under such licence unless such vehicle is a vehicle owned by him in the course of his business for the purpose of sale or exchange.”.

4. Section forty-four of the principal Ordinance is hereby amended by the substitution in sub-section (1) for the words “in respect of any retail business owned by him” of the words “in respect of the retail business for which such licence is held.”.

Wysiging van artikel 59 van Ordonnansie 18 van 1957.

5. Artikel *nege-en-vyftig* van die Hoofordonnansie word hierby gewysig deur in paragraaf (g) van subartikel (5), na die woorde „lorrie/toe-wa,” die woorde „of, omnibus” of „bus” in te voeg.

Wysiging van artikel 63 van Ordonnansie 18 van 1957.

6. Artikel *drie-en-sestig* van die Hoofordonnansie word hierby gewysig—

- (a) deur in subartikel (4) die woorde „drie” deur die woorde „ses” te vervang; en
- (b) deur die volgende subartikel daaraan toe te voeg:

„(5) 'n Toetsbeampte vir drywers-licensies wat opsetlik of nalatig 'n voorlopige beweegdheidsertifikaat uitreik of enige persoon wat opsetlik of nalatig 'n leerlinglisensie uitreik in stryd met die bepalings van hierdie artikel, is skuldig aan 'n misdryf en by skuldigbevinding strafbaar met 'n boete van hoogstens tweehonderd rand of met gevangenistraf vir 'n tydperk van hoogstens ses maande of met beide sodanige boete en gevangenistraf.”

Wysiging van artikel 64 van Ordonnansie 18 van 1957.

7. Artikel *vier-en-sestig* van die Hoofordonnansie word hierby gewysig deur in subartikel (7), na die woorde „misdryf”, die volgende woorde in te voeg:

„en by skuldigbevinding strafbaar met 'n boete van hoogstens tweehonderd rand of met gevangenistraf vir 'n tydperk van hoogstens ses maande of met beide sodanige boete en gevangenistraf”.

Wysiging van artikel 65 van Ordonnansie 18 van 1957.

8. Artikel *vyf-en-sestig* van die Hoofordonnansie word hierby gewysig deur die volgende subartikel daaraan toe te voeg:

„(6) Enige persoon wat opsetlik of nalatig 'n drywerslicensie uitreik in stryd met die bepalings van hierdie artikel, is skuldig aan 'n misdryf en by skuldigbevinding strafbaar met 'n boete van hoogstens tweehonderd rand of met gevangenistraf vir 'n tydperk van hoogstens ses maande of met beide sodanige boete en gevangenistraf.”

Wysiging van artikel 160 van Ordonnansie 18 van 1957.

9. (1) Artikel *honderd-en-sestig* van die Hoofordonnansie word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

„(1) Vir die toepassing van hierdie artikel—

- (a) beteken die uitdrukking 'boekjaar' 'n tydperk van twaalf maande wat eindig op die een-en-dertigste dag van Maart van enige jaar; en
- (b) sluit enige verwysing na die gebied van 'n plaaslike bestuur ook sodanige buite-gebied in soos beoog word in paragraaf (b) van artikel *sewe* van die Ordonnansie op Plaaslike Bestuur, 1939 (Ordonnansie No. 17 van 1939).”

(2) Die bepalings van subartikel (1) word geag op die eerste dag van Januarie 1959 in werking te getree het.

Wysiging van artikel 169 van Ordonnansie 18 van 1957.

10. Artikel *honderd nege-en-sestig* van die Hoofordonnansie word hierby gewysig deur die woorde „te soek.” deur die volgende woorde te vervang:

„te soek: Met dien verstande dat enige Staatsdepartement (insluitende die Administrasie van die Suid-Afrikaanse Spoerweë en Hawens), enige provinsiale administrasie of enige plaaslike bestuur vrygestel is van die betaling van voormelde geld.”

Kort titel.

11. Hierdie Ordonnansie heet die Verdere Padverkeerswysingsordonnansie, 1961.

5. Section *fifty-nine* of the principal Ordinance is hereby amended by the insertion in paragraph (g) of sub-section (5), after the expression "truck / van" of the words "or 'omnibus' or 'bus'".

6. Section *sixty-three* of the principal Ordinance is hereby amended—

- (a) by the substitution in sub-section (4) for the word "three" of the word "six"; and
- (b) by the addition thereto of the following sub-section:

“(5) An examiner of drivers' licences who wilfully or negligently issues a provisional certificate of competence, or any person who wilfully or negligently issues a learner's licence contrary to the provisions of this section, shall be guilty of an offence and liable on conviction to a fine not exceeding two hundred rand, or to imprisonment for a period not exceeding six months, or to both such fine and imprisonment.”

7. Section *sixty-four* of the principal Ordinance is hereby amended by the addition at the end of sub-section (7), of the following words:

“and liable on conviction to a fine not exceeding two hundred rand, or to imprisonment for a period not exceeding six months or to both such fine and imprisonment”.

8. Section *sixty-five* of the principal Ordinance is hereby amended by the addition of the following sub-section:

“(6) Any person who wilfully or negligently issues a driver's licence contrary to the provisions of this section, shall be guilty of an offence and liable on conviction to a fine not exceeding two hundred rand, or to imprisonment for a period not exceeding six months, or to both such fine and imprisonment.”

9. (1) Section *one hundred and sixty* of the principal Ordinance is hereby amended by the substitution for sub-section (1) of the following sub-section:

“(1) For the purpose of this section—

- (a) the expression 'financial year' means a period of twelve months ending on the thirty-first day of March of any year; and
- (b) any reference to the area of a local authority shall include such outside area as is contemplated in paragraph (b) of section *seven* of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939).”

(2) The provisions of sub-section (1) shall be deemed to have come into operation on the first day of January, 1959.

10. Section *one hundred and sixty-nine* of the principal Ordinance is hereby amended by the substitution for the words "such information" of the following words:

“Such information: Provided that any State Department (including the South African Railways and Harbours Administration), any provincial administration or any local authority shall be exempt from the payment of any such fees.”

11. This Ordinance shall be called the Road Traffic Further Amendment Ordinance, 1961.

Now, therefore, under and by virtue of the powers vested in me by sub-section (1) of section *forty-nine* of the Deeds Registries Act, 1937, read with section *twenty bis* of the Townships and Town-planning Ordinance, 1931, I, hereby declare that the boundaries of the said township are extended to include the said portion, subject to the conditions set out in the Annexure hereto.

ANNEXURE.

The land shall upon incorporation be subject to the existing conditions and servitudes but excluding the following conditions contained in Crown Grant No. 284/1908, which do not affect the land to be incorporated:—

- (1) The right to construct a water-furrow for irrigation and other purposes as will more fully appear from Deed of Agreement No. 633/1893;
- (2) the right to an outspan and grazing for cattle;
- (3) the right of the Government to all the water from the two sprouts flowing into the property;
- (4) the right of the Government to lay a pipe line as shown on Diagram S.G. No. A.1936/14 and the right at all times of free and unencumbered access to the said pipe line;
- (5) the servitude in favour of the Government of the right to lay out and maintain thereon a rifle range as will appear from Notarial Deed No. 673/27S;
- (6) the right in favour of the Government to keep and maintain a pipeline as will appear from Notarial Deed No. 18/1928S and as shown on Diagram No. A.4364/1927;
- (7) the right of the Government to manoeuvring and training over the remaining extent of the farm measuring 6,735 morgen 159·84 square roods;
- (8) the lease by Piet Retief Golf Club of 25·0415 morgen as described in Notarial Deed of Lease No. 100/59 L;
- (9) the right of the Town Council of Piet Retief to a pipeline six feet along the boundary AB of the farm as shown on Diagram S.G. No. A.3298/47.

The land shall further be subject to the following conditions imposed by the Administrator:—

- (a) The erf and buildings erected and to be erected thereon shall be used solely for such industrial and/or commercial purposes (e.g. factories, warehouses, workshops and the like) as may be approved, in writing, by the local authority and other purposes incidental thereto; no retail trade of any description shall be conducted thereon or therefrom save as is in sub-clause (b) hereof provided and save that it is specially hereby provided that for the purposes of this clause the prohibition against retail trading set out above, shall not prohibit the owner from selling on the erf goods

- (i) die oprigting en gebruik vir woondoeleinades van geboue vir bestuurders en opsigters van werke, pakhuise of fabrieke wat op genoemde erf opgerig word, en met die skriftelike toestemming van die Administrateur gegee na raadpleging met die Departement van Bantoe-administrasie en ontwikkeling en van die plaaslike owerheid en onderworpe aan sodanige voorwaardes as wat die Administrateur, na raadpleging met die plaaslike owerheid ople, voorsiening gemaak word vir die huisvesting van Kleurlinge wat *bona fide* en noodsaklik voltyds werkzaam is in die nywerheid wat op die erf gedryf word;
- (ii) die oprigting van geboue wat as kantore of pakkainers deur die eienaar of okkupererder gebruik sal word.
- (b) Die eienaar of enige okkupererder mag nie 'n restaurant of teekamer-besigheid of 'n Bantoe-eethuis op die erf oprig nie, behalwe vir die gebruik van sy eie werknemers.
- (c) Geboue, met inbegrip van buitegeboue, wat hierna op die erf opgerig word, moet minstens 20 voet van die straatgrens daarvan geleë wees.
- (d) Die op- en aflaai van voertuie moet slegs binne die grense van die erf plaasvind: Met dien verstande dat geen materiaal of goedere van watter aard ook al, op die gedeelte van die erf tussen enige behoorlike voorgeskrewe boulyn en die straatgrens van die erf gestort, geplaas of bewaar mag word nie; hierdie gedeelte mag vir geen ander doel as vir die aanle en onderhoud van grasperke en tuine gebruik word nie.

wholly or partially manufactured or processed or assembled thereon and other goods not manufactured on the land: Provided that such goods form part of or are incidental to the sale of and/or are for use in or with goods manufactured wholly or in part or processed or assembled on the erf. The words "and other purposes incidental thereto" shall mean and include—

- (i) the erection and use for residential purposes of buildings for managers and watchmen of works, warehouses or factories erected on the said erf and, with the consent, in writing, of the Administrator given after consultation with the Department of Bantu Administration and Development and of the local authority and subject to such conditions as the Administrator in consultation with the local authority may impose, provision may be made for the housing of Coloured persons bona fide and necessarily employed on fulltime work in the industry conducted on the erf;
- (ii) the erection of buildings to be used as offices or storerooms by the owner or occupier.
- (b) The owner and any occupier shall not establish on the erf, except for the use of its own employees, a restaurant or tearoom business or a Bantu eating-house.
- (c) Buildings, including outbuildings, hereafter erected on the erf shall be located not less than 20 feet from the boundary thereof abutting on a street.
- (d) The loading and off-loading of vehicles shall be done only within the boundaries of the erf: Provided that no materials or goods of whatever nature shall be dumped, placed or stored on the portion of the erf between any duly prescribed building line and the street boundary of the erf, which portion shall not be used for any purpose other than laying out and maintaining lawns and gardens.

REGULATIONS RELATING TO COLLEGE FUNDS

The Administrator is hereby pleased, in terms of section *one hundred and twenty-one* of the Education Ordinance, 1953 (Ordinance №. 29 of 1953), to make the following regulations relating to college funds and equipment donated to a college with effect from the first day of January, 1962.

WOORDOMSKRYWING.

 - „kollegefondskomitee” ’n komitee soos by regulasie 4 beoog;

 - „registrator” ’n persoon wat aan die hoof van die administratiewe personeel van die kantoor van ’n onderwyskollege staan en as sodanig aangestel is;
 - „rektor” iemand wat in ’n pos van hoof by ’n onderwyskollege aangestel is;
 - „streekkomitee” ’n streekkomitee ingevolge die bepaling van paragraaf (b) van subartikel (1) van artikel tweé-en-vyftig van die Onderwysordonnansie ingestel;
 - „studenteraad” ’n raad gekies deur die ingeskreve studente van ’n onderwyskollege as synde die hoogste verteenwoordigende gesag namens die studente en wat as sodanig deur die rektor erken word;
 - „vise-rektor” iemand wat in n pos van vise-hoof by ’n onderwyskollege aangestel is;
 - en enige ander woord of uitdrukking het die betekenis wat in die ordonnansie daarvan geheg word.

STIGTING VAN ’N KOLLEGEFONDS.

2. (1) Die rektor van ’n onderwyskollege kan ’n kollegefonds stig vir die doel om fasiliteite en geriewe by die kollege te verskaf en om die belangte van so ’n kollege en van die studente daarvan te bevorder.

(2) Enige fonds, uitgesonderd ’n bestaande Trustfonds, wat deur die rektor of ’n lid van sy doserende personeel voor die datum van die inwerkingtreding van hierdie regulasies by ’n kollege gestig en onderhou is met oogmerke soortgelyk aan dié in subregulasie (1) beoog, is vir die toepassing van hierdie regulasies en onderworpe aan die voorwaardes daarvan, ’n kollegefonds.

ONTVANGSTE TEN BEHOEWE VAN ’N KOLLEGEFONDS.

3. (1) Die kollegefonds bestaan uit—
 - (a) vrywillige geldelike bydraes gedoen deur elke student toegelaat tot ’n opleidingskursus by ’n kollege;
 - (b) opbrengste van kermisse, konserne en ander funksies;
 - (c) bemarkings en donasies aan die kollegefonds; rente en ander inkomste wat aan die kollegefonds toeval.
- (2) Die maksimum bedrag van die bydraes in subregulasie (1) (a) genoem, word deur die kollegefondskomitee vasgestel en dit mag nie, tensy die magtiging van die Direkteur daartoe verkry is, die bedrag van R20 per student per jaar oorskry nie.

BESTUUR VAN KOLLEGEFONDS.

4. (1) Die kollegefonds word bestuur deur ’n kollegefondskomitee wat bestaan uit—
 - (a) die rektor as voorsitter;
 - (b) ’n vise-rektor of, waar daar meer as een vise-rektor is, twee vise-rektors, benoem deur die rektor;
 - (c) twee lede van die onderwyspersoneel, deur sodanige personeel eenmaal jaarliks gekies, en waar so iemand, weens ’n oorplasing na ’n ander inrigting of om watter rede ookal, nie meer lid van die kollegefondskomitee is nie, kies die onderwyspersoneel uit sy gelede iemand om die vakature aan te vul, en die persoon aldus gekies beklee die amp vir die onverstreke gedeelte van die amptstermyn van sy voorganger;
 - (d) ’n lid van die streekkomitee deur so ’n komitee gekies op sodanige tye as wat die streekkomitee in elke geval bepaal, en waar so iemand om watter rede ookal, nie meer lid van die kollegefondskomitee is nie, kies die streekkomitee uit sy gelede iemand om die vakture aan te vul, en die persoon aldus gekies beklee die amp vir die onverstreke gedeelte van die amptstermyn van sy voorganger; en
 - (e) die registrator van die kollege wat as sekretaris van die komitee optree.

DEFINITIONS.

1. In these regulations, unless inconsistent with the context—
 - “college fund” means any fund of a college of education as contemplated in regulation 2;
 - “college fund committee” means any committee as contemplated in regulation 4;
 - “Ordinance” means the Education Ordinance, 1953 (Ordinance No. 29 of 1953), as amended;
 - “rector” means any person appointed to the post of principal at a college of education;
 - “regional committee” means a regional committee constituted in terms of the provisions of paragraph (b) of sub-section (1) of section fifty-two of the Education Ordinance;
 - “registrar” means any person at the head of the administrative staff of the office of any college of education and who has been appointed as such;
 - “students’ council” means any council elected by the registered students of a college of education as being the highest representative authority on behalf of the students and recognised as such by the principal;
 - “vice-rector” means any person appointed to the post of vice-principal at a college of education;
 - and any other word or expression has the meaning ascribed thereto in the ordinance.

ESTABLISHMENT OF A COLLEGE FUND.

2. (1) The rector of a college of education may establish a college fund for the purpose of providing facilities and conveniences at the college and of promoting the interests of the college and its students.

(2) Any fund, other than an existing Trust Fund, established and maintained at any college by the rector or any member of his lecturing staff prior to the date of coming into operation of these regulations with aims similar to those contemplated in sub-regulation (1), shall, for the purposes and subject to the conditions of these regulations be a college fund.

RECEIPTS IN AID OF A COLLEGE FUND.

3. (1) The college fund consists of—
 - (a) voluntary contributions made by each student admitted to a training course at a college;
 - (b) proceeds from fêtes, concerts and other functions;
 - (c) bequests and donations to the college fund, interest other income accruing to the college fund.

(2) The maximum amount of contributions referred to in subregulation (1) (a) shall be fixed by the college and shall not without the authority of the Director, exceed the sum of R20 per student per annum.

ADMINISTRATION OF COLLEGE FUND.

4. (1) The college fund shall be administered by a college fund committee comprising—
 - (a) the rector as chairman;
 - (b) a vice-rector or, where there is more than one vice-rector, two vice-rectors appointed by the rector;
 - (c) two members of the lecturing staff elected by the staff once a year, and when such person, owing to a transfer to any other institution or for any reason whatsoever, is no longer a member of the college fund committee, the teaching staff shall elect a person from amongst its own members to fill the vacancy and the person so elected shall fill such office for the unexpired period of his predecessor’s term of office;
 - (d) a member of the regional committee elected by the regional committee at such time as it may determine in each case, and when such person is for any reason whatsoever no longer a member of the college fund committee, the regional committee shall elect a person from its own members to fill the vacancy, and the person so elected shall fill such office for the unexpired period of his predecessor’s term of office; and
 - (e) the registrar of the college acting as secretary to the committee.

(2) 'n Lid van die kollegefondskomitee beklee die amp vir solank dit die Direkteur behaag en die Direkteur kan te eniger tyd 'n kollegefondskomitee ontbind indien hy homself tevrede gestel het dat die komitee sy magte ingevolge hierdie regulasies op 'n onbehoorlike wyse uitgeoefen het en kan 'n persoon benoem om die kollegefonds te beheer tot tyd en wyl 'n nuwe komitee saamgestel is.

(4) Alle regsgedinge deur of teen 'n kollegefonds word op naam van sodanige fonds ingestel en enige regskoste daardeur aangedaan word teen die fonds in rekening gebring; met dien verstande dat geen regsgeding deur die fonds ingestel of verdedig mag word sonder die goedkeuring van die Direkteur nie.

KWORUM.

5. 'n Kworum van die kollegefondskomitee bestaan uit vier van die lede van sodanige kollegefondskomitee en geen besigheid mag op 'n vergadering van 'n kollegefondskomitee verrig word, tensy 'n kworum teenwoordig is nie.

BOEKHOUDING.

6. (1) Die rektor is verantwoordelik vir die uitreiking van kwitansies, die hou van rekeningboeke, die veilige bewaring van sodanige boeke en alle stukke, dokumente en kwitansies wat daarop betrekking het en oor die algemeen vir die beheer oor alle rekeningsake in verband met die kollegefonds.

(2) Kwitansies moet vir alle gelde wat ontvang is, uitgereik word en kwitansies moet verkry word vir alle gelde wat bestee word.

(3) Rekeningboeke moet gehou word met besonderhede van alle ontvangste en uitgawes.

(4) Die rekeningboeke betreffende die kollegefonds moet jaarliks deur 'n geoktrooide rekenmeester geouditeer word met dien verstande dat die rekeningboeke te eniger tyd, helsy op versoek van die kollegekomitee, of die Direkteur, of nie, geouditeer kan word deur die Proviniale Ouditeur of iemand namens hom daartoe gemagtig.

(5) 'n Jaarlikse finansiële staat en balansstaat, gesertifiseer deur die ouditeur, moet aan die Direkteur en aan die streekkomitee voorgelê word en moet daarna ter insae lê vir alle belanghebbendes.

DEPONEER EN OPVRA VAN GELD.

UITGAWE UIT KOLLEGEFONDS.

8. (1) Die kollegefondskomitee kan uit die kollegefonds 'n bydrae maak aan die studenteraad of aan 'n mediese hulpskema ten behoeve van studente ingestel.

(2) Behoudens die oorbetaling van gelde wat vir 'n bepaalde doel in ontvang geneem is, mag geen uitgawe bo R100 ten opsigte van enige diens of die koop van enige item of artikel sonder die voorafverkreeë goedkeuring van die kollegefondskomitee aangegaan word nie.

(3) Geen item mag volgens die hurkoopstelsel aangekoop word nie.

(2) A member of the college fund committee shall remain in office during the pleasure of the Director and the Director may at any time disestablish any college fund committee on satisfying himself that the committee has abused its powers in terms of these regulations and he may appoint any person to administer the college fund until such time as a new committee is formed.

(3) Subject to the provisions of the ordinance or of the regulations, the college fund committee may fix its own procedure, provided that any meeting of the college fund committee shall be held at such time and place as the chairman may determine.

(4) All legal proceedings by or against any college fund shall be instituted in the name of such fund and any legal expenditure incurred, thereby shall be charged to the fund; provided that the fund shall not institute or defend any legal proceedings without the Director's approval.

QUORUM.

5. A quorum of the college fund committee shall consist of four of the members of such college fund committee and unless a quorum is present no business shall be transacted at any meeting of a college fund committee.

BOOKKEEPING.

6. (1) The rector shall be responsible for the issue of receipts, the keeping of account books, the custody of such books and all papers, documents and receipts relating thereto and in general for the control of all the accounts relating to the college fund.

(2) Receipts must be issued for all moneys received and obtained for all moneys spent.

(3) Account books must be kept providing particulars of all receipts and expenditure.

(4) The account books relating to the college fund must be audited annually by a chartered accountant; provided that the account books may at any time, whether at the request of the college fund committee or of the Director or not, be audited by the Provincial Auditor or any person authorised thereto on his behalf.

(5) An annual financial statement and balance sheet, certified by the auditor, shall be submitted to the Director and the regional committee and shall thereafter be open to inspection by all interested.

DEPOSIT AND WITHDRAWAL OF MONEY.

7. (1) All moneys received in respect of a college fund must, as soon as possible after receipt thereof, be deposited in the name of the college in one account at a commercial bank, post office savings bank or building society or other banking institution registered in terms of the Banking Act (Act No. 38 of 1942).

(2) Withdrawal from the account contemplated in sub-regulation (1) shall take place only on the strength of the rector's and the registrar's signatures or of that of any other member of the college fund committee, should one of the aforesaid not be available.

(3) Moneys deposited may be reinvested at interest at any commercial bank, post office savings bank or building society or at any other banking institution registered in terms of the Banking Act (Act No. 38 of 1942), approved by the college fund committee.

EXPENDITURE FROM COLLEGE FUND.

8. (1) The college fund committee may contribute from the college fund to the student's council or to a medical aid scheme established in aid of students.

(2) Except for the payment of moneys received for any specific purpose, no expenditure in excess of R100 shall be incurred in respect of any service or the purchase of any item or article without the approval of the college fund committee first having been obtained.

(3) No item shall be bought on the hire-purchase system.

PROCEDURE IN VERBAND MET VERLIESE.

9. 10. (1) Die rektor moet behoorlik rekord hou van alle uitrusting wat aangekoop is uitsluitlik met geld uit kollegefondse, asook van alle uitrusting aan die kollege geskenk, en hy moet toesien dat sodanige uitrusting behoorlik onderhou word.

(2) Die uitrusting in subregulasie (1) genoem moet verantwoord word en inventarisne moet jaarliks opgestel word net soos in die geval van provinsiale uitrusting.

BESLUIT VAN DIREKTEUR.

11. PROCEDURE IN CONNECTION WITH LOSSES.

9. (1) Any loss of college fund moneys owing either to an unlawful act or omission or any cause whatsoever resulting from any act of commission or omission on the part of officers of the Department or of any other persons, must immediately be reported by the rector to the Director together with full particulars.

(2) After receipt of the report and particulars referred to in sub-regulation (1) the Director shall decide on the steps, if any, to be taken in connection with the recovery or otherwise of such loss or on any other steps that may be deemed necessary, and where such loss in the opinion of the rector is the result of an unlawful act constituting a criminal offence, the rector shall also immediately report the case to the nearest police station; provided that in the case of losses not exceeding the sum of R10 and which are the result of circumstances not constituting a criminal offence and provided such amount is replaced immediately by the person or persons responsible for the loss, such loss need not be reported to the Director.

STATEMENT OF EQUIPMENT PURCHASED FROM COLLEGE FUND OR DONATED TO THE COLLEGE.

10. (1) The rector must keep a proper record of all equipment purchased exclusively with money from the college fund as well as all equipment donated to the college, and he must see that such equipment is properly maintained.

(2) The equipment referred to in sub-regulation (1) must be accounted for and inventories must, as in the case of provincial equipment, be compiled.

DIRECTOR'S DECISION.

11. Should any person, body of persons or college fund committee fail to take steps or to make a decision in terms of these regulations, the Director may request such person, body of persons or committee to take the necessary steps or to make the relevant decision within a specified time. Should any such person, body of persons or committee fail to act within the specified time or, owing to its disestablishment, be unable to act, the Director may take the necessary steps, make the necessary decision or take any other action he may deem to be the action of such person, body of persons or committee.
