A

DRAFT ORDINANCE

To provide for the establishment of a consultative committee, management committee or a local authority for a group area or portion thereof and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Council of Transvaal as follows:—

Definitions. 1. In this Ordinance, unless the context otherwise indicates—

- (i) "Administrator" means the officer appointed under section sixty-six of the Republic of South Africa Constitution Act, 1961 (Act No. 32 of 1961), acting on the advice and with the consent of the Executive Committee of the Province; (i)
- (ii) "group" means a group as defined in section one of the Group Areas Act, 1957 (Act No. 77 of 1957); (ii)
- (iii) "group area" means an area as defined in section one of the Group Areas Act, 1957; (iii)
- (iv) "local authority" means a town council, village council or health committee established in terms of the Local Government Ordinance, 1939, and includes the Peri-Urban Areas Health Board established in terms of the Peri-Urban Areas Health Board Ordinance, 1943; (v)
- (v) "Minister" means the Minister of Community Development; (iv).
- (vi) "regulation" means a regulation made under this Ordinance. (vi)

2. (1) The Administrator may, with the approval of the Minister, by notice in the *Provincial Gazette* establish for any group area (other than a group area for the white group) or any portion of such group area, which is situated within the area of jurisdiction of a local authority, or for any two or more such group areas or portions of group areas for the same group (whether contiguous or not) either a consultative committee or a management committee, and may at any time, in like manner, disestablish any consultative committee or management committee so established.

Establishment of consultative or management committee for a group area or portion thereof.

(1) Die Administrateur, kan met die goedkeuring van die Minister, by kennisgewing in die *Provinsiale Koerant* vir enige groepsgebied (met uitsondering van 'n groepsgebied vir die blanke groep) of enige gedeelte van sodanige groepsgebied, wat geleë is binne die reggebied van 'n plaaslike bestuur, of vir enige twee of meer sodanige groepsgebiede of gedeeltes van groepsgebiede vir dieselfde groep (hetsy aangrensend al dan nie), of 'n raadplegende komitee of 'n bestuurskomitee instel en kan te eniger tyd, op dieselfde wyse, enige raadplegende komitee of bestuurskomitee aldus ingestel, afskaf.
