





Section 11 to provide a formula for calculating the commutation of pension without the necessity of a medical examination. It has the effect of reducing the maximum commutation from one-third to approximately one-quarter but the remaining pension will be higher.

Sections 12 (2), 13 and 14 to introduce a formula for simplifying the calculation of benefits without materially altering the benefits payable to the members.

Section 18 to remove the anomalies that exist between the Council's Gratuity Scheme and the Pension Fund rules.

Section 19 to extend the scope of persons who can be nominated as dependants.

Section 33 to comply with the request of the Registrar of Pension Funds to provide Fidelity cover."
