## PROCLAMATION

BY THE HONOURABLE THE ADMINISTRATOR OF THE  
PROVINCE OF TRANSVAAL.

Whereas in terms of sub-section (3) of section *fourteen* of the Peri-Urban Areas Health Board Ordinance, 1943, the Administrator may by proclamation diminish from time to time the area of jurisdiction of the Peri-Urban Areas Health Board;

And whereas it is deemed expedient to exclude the area described in the Schedule hereto from the area of jurisdiction of the said Board in order to incorporate the area so excluded in the Municipality of Pretoria;

Now, therefore under and by virtue of the powers vested in me by sub-section (3) of section *fourteen* of the Peri-Urban Areas Health Board Ordinance, 1943, I do by this my Proclamation proclaim that the area of jurisdiction of the Peri-Urban Areas Health Board shall be diminished with effect from 1st July, 1964, by the exclusion therefrom of the area described in the Schedule hereto.


