(5) Where the length of the underground cable from the stand boundary to the consumers service fuses or circuit-breakers exceeds 100 (one hundred) feet, a meter chamber of an approved type shall be built on the stand boundary by the consumer and the connection from such meter chamber to the building containing the consumer's main switchboard shall be effected and maintained by the consumer.

(6) The Council's meters shall be installed at a position selected by the Engineer or by an authorized official.

(7) All connections to buildings separated from the main building shall be made by either underground cable or wires drawn through galvanised solid-drawn tubing of not less than ¾-inch external diameter.

PROPOSED AMENDMENT TO THE NORTH JOHANNESBURG REGION TOWN-PLANNING SCHEME (AMENDING SCHEME No. 93).

- (2) no new roads are created.

- (iii) The following conditions be inserted in Clause 19 (b) (iii) of the Scheme Clauses after the words "110 Cape feet":

"Provided that the minimum street frontage of erven created by the subdivision of the following erf in Buccleuch Township, shall be 100 Cape feet: Erf No. 111."
