

No. 9 (Administrateurs-), 1994

VERLENGING VAN DIE AMPSTERMYN VAN HUIDIGE BURGEMEESTERS EN ONDER-BURGEMEESTERS EN UITSTEL VAN TUSSENVERKIESSINGS, KAGTENS ARTIKEL 10 (1) VAN DIE OORGANGSWET OP PLAASLIKE REGERING, 1993 (WET No. 209 VAN 1993)

Ek, Willie Raymond Hoods, Waarnemende Administrateur van Transvaal, kragtens artikel 10 (1) van die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993)—

- (a) herroep hierby Proklamasie No. 4 (Administrateurs), 1994, gepubliseer in *Buitengewone Offisiële Koerant* No. 4971 van 4 Februarie 1994; en
- (b) vaardig hierby maatreëls uit waarvolgens, ondanks die bepalings van enige ander wet—
  - (i) die ampstermyne van die huidige Burgemeesters en Onder-burgemeesters van plaaslike owerheidsliggome verleng word; en
  - (ii) geen toevallige vakatures in plaaslike owerheidsliggome wat tans bestaan of mag ontstaan gevul word nie (tensy die magbalans tussen politieke partye in 'n plaaslike owerheidsliggaaam deur so 'n toevallige vakature beïnvloed word, in welke geval so 'n plaaslike owerheidsliggaaam 'n versoek om die vulling van die toevallige vakature aan die Administrateur moet rig, welke versoek gesteun moet word deur 'n formele meerderheidsbesluit van die plaaslike owerheidsliggaaam vergesel van die naam van die kandidaat genomineer deur die betrokke politieke party of, in die geval van 'n onafhanklike setel, deur die plaaslike owerheidsliggaaam);

### PROCLAMATION

No. 9 (Administrator's), 1994

EXTENSION OF THE TERMS OF OFFICE OF EXISTING MAYORS AND DEPUTY MAYORS AND POSTPONEMENT OF BY-ELECTIONS IN TERMS OF SECTION 10 (1) OF THE LOCAL GOVERNMENT TRANSITIONAL ACT, 1993 (ACT NO. 209 OF 1993)

I, Willie Raymond Hoods, Acting Administrator of the Transvaal, under section 10 (1) of the Local Government Act, 1993 (Act No. 209 of 1993)—

- (a) hereby repeal Proclamation No. 4 (Administrator's), 1994, published in *Official Gazette Extraordinary* No. 4971 of 4 February 1994; and
- (b) hereby make enactments according to which, notwithstanding the provisions of any other law—
  - (i) the terms of office of the present Mayors and Deputy Mayors of local government bodies shall be extended; and
  - (ii) no casual vacancies which presently exist or may occur in local government bodies shall be filled (unless such a vacancy affects the balance of power among political parties in the local government, in which case such a local government body shall submit a request to the Administrator for the filling of the casual vacancy, which request shall be supported by a formal majority resolution of the local government body accompanied by the name of a candidate nominated by the political party concerned or, in the case of an independent seat, by the local government body);

up and until the establishment of a transitional council to which the relevant local government body is included as contemplated in section 7 of the said Act.
