

### BYLAE

#### Instelling van plaaslike oorgangsraad

1. 'n Plaaslike oorgangsraad, hieronder die Stadsraad van Brakpan genoem, word hierby, soos beoog in artikel 7 (1) (b) (i) van die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993), vanaf die datum van inwerkingtreding van hierdie Proklamasie (hieronder die effektiewe datum genoem),

### PROCLAMATION

**No. 10 (Premier's), 1994**

LOCAL GOVERNMENT TRANSITION ACT, 1993  
 (ACT No. 209 OF 1993)

TRANSITIONAL COUNCIL: TOWN COUNCIL OF BRAKPAN AND TOWN COMMITTEE OF TSAKANE

Under section 10 of the Local Government Transition Act, 1993 (Act No. 209 of 1993), I hereby with the concurrence of the Provincial Committee, make the enactments in the Schedule.

### SCHEDULE

#### Establishment of transitional local council

1. A transitional local council, hereunder called the Town Council of Brakpan, is hereby established as contemplated in section 7 (1) (b) (i) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), with effect from the date upon which this Proclamation shall come into operation (hereunder called the

#### **Ontbinding van plaaslike owerheidsliggame**

2. Die Stadsraad van Brakpan en die Dorpskomitee van Tsakane word hierby op die effektiewe datum ontbind.

#### **Gebied van Stadsraad van Brakpan**

3. Die gebied van die Stadsraad van Brakpan bestaan uit die bestaande regsgebiede van die ontbinde Stadsraad van Brakpan, soos omskryf by Goewermentskennisgewing No. 45 van 30 Julie 1919, soos gewysig, wat die gebied van Geluksdal soos omskryf in Bylae 1 by Administrateurskennisgewing No. 912 van 1976 insluit, en die gebied van die ontbinde Dorpskomitee van Tsakane, soos omskryf in Staatskoerant No. R. 1480 van 11 Julie 1986.

#### **Raadslede**

4. (1) Die Stadsraad van Brakpan bestaan uit 28 Raadslede.

(2) Die ampstermyne van die Raadslede van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld, word op die effektiewe datum beëindig.

(3) Die persone in Aanhangsel A vermeld, wat behoorlik kragtens paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, benoem is, word hierby as Raadslede van die Stadsraad van Brakpan aangestel.

(4) enige toevalleige vakature wat na die effektiewe datum op die Stadsraad van Brakpan ontstaan, moet binne 30 dae aan die verantwoordelike Lid van die Uitvoerende Raad gerapporteer word welke vakture, ondanks die bepalings van artikels 20 en 36 van die Ordonnansie op Municipale Verkiesings, 1970 (Ordonnansie No. 16 van 1970), deur die gemelde Lid gevul moet word uit die lys van bykomende kandidate in orde van voorkeur soos beoog in paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, in Aanhangsel B vervat.

#### **Burgemeester en Onderburgemeester**

5. Die Stadsraad van Brakpan moet, binne sewe dae na die effektiewe datum op 'n spesiale vergadering van die Stadsraad van Brakpan, 'n Burgemeester uit die statutêre komponent en 'n Onderburgemeester uit die nie-statutêre komponent uit die Raadslede in artikel 4 (3) vermeld kragtens die bepalings van artikels 16 en 17 respektiewelik van die Ordonnansie op Plaaslike Bestuur, 1939, verkies.

#### **Toelaes van Raadslede, Burgemeester en Onderburgemeester**

6. (1) Al die Raadslede ontvang na die effektiewe datum dieselfde toelaes as wat aan Raadslede van die ontbinde Stadsraad van Brakpan betaal is.

(2) Die Burgemeester en die Onderburgemeester ontvang na die effektiewe datum dieselfde toelaes as wat aan die Burgemeester en Onderburgemeester van die ontbinde Stadsraad van Brakpan betaal is.

effective date), comprising the Town Council of Brakpan and the Town Committee of Tsakane, which Town Council of Brakpan shall be deemed to be a local government body in terms of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939).

#### **Dissolution of local government bodies**

2. The Town Council of Brakpan and the Town Committee of Tsakane are hereby dissolved on the effective date.

#### **Area of Town Council of Brakpan**

3. The area of the Town Council of Brakpan comprises the existing areas of jurisdiction of the dissolved Town Council of Brakpan as defined in Government Notice No. 45 of 30 July 1919, as amended, including the area of Geluksdal as defined in Schedule 1 to Administrator's Notice No. 912 of 1976, and the area of the dissolved Town Committee of Tsakane, as defined in Government Notice No. R. 1480 of 11 July 1986.

#### **Councillors**

4. (1) The Town Council of Brakpan comprises 28 Councillors.

(2) The terms of the office of the Councillors of the dissolved local government bodies mentioned in section 2, shall be terminated on the effective date.

(3) The persons mentioned in Annexure A, duly nominated in terms of paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, are hereby appointed as Councillors of the Town Council of Brakpan.

(4) Any casual vacancy arising on the Town Council of Brakpan after the effective date, shall be reported to the responsible Member of the Executive Council within 30 days, which vacancy shall, notwithstanding the provisions of sections 20 and 36 of the Municipal Election Ordinance, 1970 (Ordinance No. 16 of 1970), be filled by the said Member from the list of additional candidates in order of preference as contemplated in paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, as contained in Annexure B.

#### **Mayor and Deputy Mayor**

5. The Town Council of Brakpan shall, within seven days after the effective date, at a special meeting of the Town Council of Brakpan, under sections 16 and 17 respectively, of the Local Government Ordinance, 1939, elect a Mayor from the statutory component and a Deputy Mayor from the non-statutory component from the Councillors mentioned in section 4 (3).

#### **Allowances of Councillors, Mayor and Deputy Mayor**

6. (1) All Councillors shall, after the effective date, receive the same allowances as the allowances paid to Councillors of the dissolved Town Council of Brakpan.

(2) The Mayor and the Deputy Mayor shall, after the effective date, receive the same allowances as the allowances paid to the Mayor and the Deputy Mayor of the dissolved Town Council of Brakpan.

**Uitvoerende Komitee**

**7.** (1) Die Stadsraad van Brakpan kies, ondanks die bepalings van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960 (Ordonnansie No. 40 van 1960), kragtens artikel 16 (6) van die Oorgangswet op Plaaslike Regering, 1993, uit sy lede 'n Uitvoerende Komitee bestaande uit ses lede, waarvan drie lede uit die statutêre komponent en drie lede uit die nie-statutêre komponent afkomstig moet wees.

(2) Die Stadsraad van Brakpan verkieës een lid van die Uitvoerende Komitee afkomstig van die nie-statutêre komponent as voorzitter en een lid van die Uitvoerende Komitee as Vise-Voorzitter van die Uitvoerende Komitee.

(3) Die bepalings van artikels 1 en 55 tot 61 van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, is, by die toepassing van hierdie Proklamasie, *mutatis mutandis* op die Uitvoerende Komitee in subartikel (1) bedoel van toepassing.

**Stadsklerk**

**8.** (1) Die Stadsklerk van die ontbinde Stadsraad van Brakpan word by die toepassing van hierdie Proklamasie, behoudens die bepalings van die Wet op die Besoldiging van Stadsklerke, 1984 (Wet No. 115 van 1984), geag die Stadsklerk van Brakpan te wees, soos bedoel in artikel 62 van die Ordonnansie op Plaaslike Bestuur, 1939.

(2) Die Stadsklerk van Brakpan oefen by die toepassing van hierdie Proklamasie al die funksies, bevoegdhede en pligte uit wat aan die Stadsklerk van die ontbinde Stadsraad van Brakpan kragtens die Ordonnansie op Plaaslike Bestuur, 1939, die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, die Ordonnansie op Municipale Verkiesings, 1970, of enige ander wet, of verordening van die Stadsraad van Brakpan opgedra is.

**Oordra van bates, laste, regte en verpligtinge**

**9.** Alle bates, laste, regte en verpligtinge van die ontbinde Stadsraad van Brakpan en die Dorpskomitee van Tsakane word na die effektiewe datum aan die Stadsraad van Brakpan opgedra: Met dien verstande dat die Stadsraad van Brakpan na die effektiewe datum nie verantwoordelik sal wees vir enige skuld of enige aanspreeklikheid van die ontbinde Dorpskomitee van Tsakane wat voor die effektiewe datum ontstaan het, uitgenome 'n skuld of aanspreeklikheid wat afkomstig is van enige infrastruktuur wat inkomste genereer of wat aangewend kan word vir die doel waarvoor dit goedgekeur is.

**Besluite, verordeninge en regulasies**

**10.** (1) Alle besluite wat deur die ontbinde Stadsraad van Brakpan en die Dorpskomitee van Tsakane geneem is, word behoudens die bepalings van subartikel (2), na die effektiewe datum, geag besluite van die nuwe Stadsraad van Brakpan te wees.

**Executive Committee**

**7.** (1) The Town Council of Brakpan shall, notwithstanding the provisions of the Local Government (Administration and Elections) Ordinance, 1960 (Ordinance No. 40 of 1960), under section 16 (6) of the Local Government Transition Act, 1993, elect from its members an Executive Committee comprising six members, of which three members shall be from the statutory component and three members from the non-statutory component.

(2) The Town Council of Brakpan shall elect one member of the Executive Committee from the non-statutory component as chairperson and one member of the Executive Committee as vice chairperson of the Executive Committee.

(3) The provisions of sections 1 and 55 to 61 of the Local Government (Administration and Elections) Ordinance, 1960, shall, when exercising the provisions of this Proclamation, be applicable *mutatis mutandis* to the Executive Committee contemplated in subsection (1).

**Town Clerk**

**8.** (1) The Town Clerk of the dissolved Town Council of Brakpan shall, for the purposes of this Proclamation and subject to the provisions of the Remuneration of Town Clerks Act, 1984 (Act No. 115 of 1984), be deemed to be the Town Clerk of Brakpan, as contemplated in section 62 of the Local Government Ordinance, 1939.

(2) The Town Clerk of Brakpan shall, for the purposes of this Proclamation, perform all the functions, powers and duties assigned to the Town clerk of the dissolved Town Council of Brakpan in terms of the Local Government Ordinance, 1939, the Local Government (Administration and Elections) Ordinance, 1960, the Municipal Elections Ordinance, 1970, or another law, or by-law of the Town Council of Brakpan.

**Transfer of assets, liabilities, rights and obligations**

**9.** All assets, liabilities, rights and obligations of the dissolved Town Council of Brakpan and the Town Committee of Tsakane shall after the effective date be transferred to the Town Council of Brakpan: Provided that the Town Council of Brakpan shall not be liable for any debt or any liability of the dissolved Town Committee of Tsakane which has been incurred before the effective date, excluding debts or liabilities deriving from any infrastructure generating income or which may be utilized for approved purposes.

**Resolutions, by-laws and regulations**

**10.** (1) All resolutions of the dissolved Town Council of Brakpan and the Town Committee of Tsakane shall, subject to the provisions of subsection (2), after the effective date, be deemed to be resolutions of the new Town Council of Brakpan.

(2) Alle verordeninge en regulasies van die ontbinde Stadsraad van Brakpan en die Dorpskomitee van Tsakane word vanaf die effektiewe datum hierby herroep, uitgenome die verordeninge en regulasies van die ontbinde Stadsraad van Brakpan in Aanhengsel C vermeld, wat na die effektiewe datum geag word die verordeninge en regulasies van die Stadsraad van Brakpan te wees.

#### Begroting

**11.** Die begroting van die Stadsraad van Brakpan sal bestaan uit die gesamentlike begroting van die ontbinde Stadsraad van Brakpan en die Dorpskomitee van Tsakane: Met dien verstande dat die boekinskrywing vir die 1994/95 finansiële jaar apart deur die Stadsraad van Brakpan gedoen sal word.

#### Verteenwoordiging op Streeksdiensteraad

**12.** (1) Die verteenwoordiging wat die ontbinde Stadsraad van Brakpan en die Dorpskomitee van Tsakane kragtens die Wet op Streeksdiensterade, 1985 (Wet No. 109 van 1985), op die Oos-Rand Streeksdiensteraad Wesvaal gehad het, word hierby beëindig.

(2) Die verteenwoordiging van die Stadsraad van Brakpan word kragtens die Wet op Streeksdiensterade, 1985, na die effektiewe datum op die Oos-Rand Streeksdiensteraad bepaal.

#### Enkele Plaaslike Administrasie vir Stadsraad van Brakpan

**13.** (1) 'n Enkele Plaaslike Administrasie word hierby vir die Stadsraad van Brakpan ingestel.

(2) 'n Permanente organisasiestruktuur vir die Enkele Administrasie moet deur die Stadsraad van Brakpan so spoedig moontlik na die effektiewe datum saamgestel word.

#### Werknemers en beampies van Stadsraad van Brakpan

**14.** (1) Nadat 'n permanente organisasiestruktuur soos in artikel 13 (2) bedoel saamgestel is, moet alle werknemers en beampies in diens van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld na die Enkele Plaaslike Administrasie in artikel 13 (1) bedoel, oorgeplaas word ooreenkomsdig die bepalings van artikel 10 (3) (f) (i) en (j) van die Oorgangswet op Plaaslike Regering, 1993.

(2) Totdat die werknemers en beampies in subartikel (1) bedoel na die Enkele Plaaslike Administrasie oorgeplaas is, word die betrokke werknemers en beampies vir doeleindes van hierdie Proklamasie geag in diens van die Enkele Plaaslike Administrasie te wees.

#### Inwerkingtreding

**15.** Hierdie Proklamasie tree op **14 September 1994** in werking.

(2) All by-laws and regulations of the dissolved Town Council of Brakpan and the Town Committee of Tsakane shall be repealed from the effective date, excluding the by-laws and regulations of the dissolved Town Council of Brakpan mentioned in Annexure C, which shall after the effective date be deemed to be by-laws and regulations of the Town Council of Brakpan.

#### Budget

**11.** The budget of the Town Council of Brakpan shall consist of a joint budget of the dissolved Town Council of Brakpan and Town Committee of Tsakane: Provided that the book entries for the 1994/95 financial year shall be handled separately by the Town Council of Brakpan.

#### Representation on Regional Services Council

**12.** (1) Representation of the dissolved Town Council of Brakpan and the Town Committee of Tsakane in terms of the Regional Services Council Act, 1985 (Act No. 109 of 1985), on the East Rand Regional Services Council, is hereby terminated.

(2) Representation of the Town Council of Brakpan on the East Rand Regional Services Council shall be determined after the effective date in terms of the Regional Services Councils Act, 1985.

#### Single Local Administration for Town Council of Brakpan

**13.** (1) A single Local Administration is hereby established for the Town Council of Brakpan.

(2) A permanent organisational structure for the Single Administration shall be constituted by the Town Council of Brakpan as soon as possible.

#### Employees and officers of Town Council of Brakpan

**14.** (1) After a permanent organisational structure as contemplated in section 13 (2) has been constituted, all employees and officers in the service of the dissolved local government bodies mentioned in section 2, shall be transferred to the Single Local Administration contemplated in section 13 (1) in accordance with the provisions of section 10 (3) (f) (i) and (j) of the Local Government Transition Act, 1993.

(2) Until the employees and officers contemplated in subsection (1) have been transferred to the Single Local Administration, the employees and officers concerned shall, for the purposes of this Proclamation, be deemed to be in the service of the Single Local Administration.

#### Commencement

**15.** This Proclamation shall come into operation on **14 September 1994**.






