| <p>The Minister of Transport and Public Works of the Province of Western Cape has, in terms of subsection (14)(a) of section 7A of the Road Transportation Act, 1977 (as inserted by section 2 of the Western Cape Road Transportation Act Amendment Law, 1996), made the regulations in the Schedule to this notice and prescribed therein the requirements for minibus taxi associations to register.</p> | | | |
| <p>SCHEDULE</p> <p>REGULATIONS PRESCRIBING REQUIREMENTS FOR MINIBUS TAXI ASSOCIATIONS TO REGISTER</p> <p>1. Subject to regulation 3, the minimum number of members which a minibus taxi association must have before it may be registered shall be —</p> <ul style="list-style-type: none"> (a) in the case of such an association formed and in existence before the date on which these regulations come into operation, 10 members, each of whom owns at least one vehicle; and (b) in the case of such an association formed after the date on which these regulations come into operation, 10 members, each of whom owns at least one vehicle in respect of which a permit contemplated by section 13 of the Road Transportation Act, 1977, has been issued. <p>2. From the date of the commencement of these regulations the maximum fees which a minibus taxi association may charge shall be —</p> <ul style="list-style-type: none"> (a) in the case of a joining fee, R2 000,00 (two thousand rand), irrespective of the number of vehicles owned by the person or member concerned; and (b) in the case of an annual membership fee, the provisions contained in the constitution of an association shall prevail. <p>3. In the case of any minibus taxi association which is not able to meet the applicable membership requirements contemplated by regulation 1, the Minister of Transport and Public Works of the province of Western Cape may, upon good cause having been shown, reduce such minimum membership requirements.</p> <p>4. Any registered minibus taxi association which ceases to have the required applicable membership shall automatically cease to be registered.</p> <p>5. These regulations shall come into operation on 7 April 1997.</p> | | | |

Die Minister van Vervoer en Openbare Werke van die provinsie Wes-Kaap het ingevolge subartikel (14)(a) van artikel 7A van die Wet op Padvervoer, 1977 (soos ingevoeg by artikel 2 van die Wes-Kaapse Wysigingswet op die Wet op Padvervoer, 1996), die regulasies in die Bylae van hierdie kennisgewing gemaak en die registrasievoorskrifte vir minibustaxiverenigings daarin voorgeskryf.

BYLAE

REGULASIES WAT REGISTRASIEVEREISTES VIR MINIBUSTAXIVERENIGINGS VOORSKRYF

1. Behoudens regulasie 3, is die minimum getal lede wat 'n minibustaxivereniging moet hê voordat dit geregistreer kan word —
 - (a) in die geval van so 'n vereniging wat voor die datum van inwerkingtreding van hierdie regulasies gevorm is en bestaan het, 10 lede wat elk minstens een voertuig besit; en
 - (b) in die geval van so 'n vereniging wat na die datum van inwerkingtreding van hierdie regulasies gevorm word, 10 lede wat elk minstens een voertuig besit waarvoor 'n permit, beoog by artikel 13 van die Wet op Padvervoer, 1977, uitgereik is.
2. Vanaf die datum van inwerkingtreding van hierdie regulasies is die maksimum gelde wat 'n minibustaxivereniging kan hef —
 - (a) in die geval van 'n aansluitingsgeld, R2 000,00 (tweeduisend rand), ongeag die getal voertuie wat die betrokke persoon of lid besit; en
 - (b) in die geval van 'n jaarlikse lidmaatskapgeld, sal die bepalings soos vervat in die konstitusie van 'n vereniging geld.
3. In die geval van enige minibustaxivereniging wat nie aan die toepaslike lidmaatskapvereistes beoog by regulasie 1 kan voldoen nie, kan die Minister van Vervoer en Openbare Werke van die provinsie Wes-Kaap by aanvoering van gegronde redes dié minimum lidmaatskapvereistes verlaag.
4. Enige geregistreerde minibustaxivereniging wat ophou om die vereiste toepaslike minimum lidmaatskap te hê, sou outomatis op om geregistreer te wees.
5. Hierdie regulasies tree op 7 April 1997 in werking.
