



I, Jacobus Wouter Henry Meiring, Member of the Cabinet of the Western Cape Provincial Government, entrusted with Environmental Affairs, hereby declare that it is my intention to prohibit vehicles, as determined in terms of paragraph 3 of the General Policy (Government Notice No. 858 of 29 April 1994) concerning the control of vehicles in the coastal zone, obtaining access to the bathing areas, beach areas and ecologically sensitive areas at the Klein River Mouth, Hermanus (as indicated on the attached map). 
