2. In regulasie 1 deur die volgende woordomskrywing na die omskrywing van "Natuurbewaringsbeampte" in te voeg:  
"Natuurbewaringsreservis" beteken 'n Natuurbewaringsreservis ingevolge regulasie 26.4 aangestel.
3. In regulasie 26 deur die volgende regulasies na regulasie 26.3 in te voeg:
  - 26.4 Die plaaslike owerheid kan enige persoon wat hy geskik ag as 'n Natuurbewaringsreservis aanstel vir die uitvoering van die bepalings van hierdie regulasies.
  - 26.5 Elke Natuurbewaringsreservis besit al die bevoegdhede by regulasie 10 aan 'n Natuurbewaringsbeampte verleen en kan sodanige bevoegdhede uitoefen binne die regsgebied van die plaaslike owerheid deur wie hy/sy aangestel is.

**WEST COAST DISTRICT COUNCIL:**

**AMENDMENT OF THE REGULATIONS FOR THE CONTROL OF THE SEASHORE AND THE SEA SITUATED WITHIN OR ADJOINING THE AREA OF JURISDICTION OF THE WEST COUNCIL REGIONAL SERVICES COUNCIL**

The regulations for the control of the seashore and the sea situated within or adjoining the area of jurisdiction of the West Coast Regional Services Council promulgated in Provincial Gazette 5008 dated 5 January 1996 in terms of section 10(1) of the Sea-Shore Act, 1935 (Act 21 of 1935) are hereby amended as follows:

1. By substituting the expressions "West Coast Regional Services Council" and "South African Police" respectively, wherever they appear in the regulations, with the expressions "West Coast District Council" and "South African Police Service".
2. In regulation 1 by the insertion after the definition of "Nature Conservation Officer" of the following definition:  
"Nature Conservation Reservist" means a Nature Conservation Reservist appointed in terms of regulation 26.4.
3. In regulation 26 by the addition after regulation 26.3 of the following regulations:
  - 26.4 The local authority may appoint any person it considers suitable as a Nature Conservation Reservist for the carrying out of the provisions of these regulations.
  - 26.5 Each Nature Conservation Reservist shall have all the powers conferred by regulation 10 on a Nature Conservation Officer and may exercise such powers within the area of jurisdiction of the local authority which appointed him/her.
