CHAPTER 1

Definitions

In these rules, unless inconsistent with the context, the singular shall include the plural and vice versa, the male shall include the female and the following terms shall have the meanings set against them.

| 1.1 | "ALL CLEAR" | means | the authority for the payment of dividends given by the race meeting stewards. |
| 1.2 | "BET" | means | the selection of the minimum number of horses required to qualify for a dividend under the rules pertaining to a particular pool in such a manner that the pool is incremented in respect of any one runner or combination of runners. |
| 1.3 | "CLUB" | means | a racing club conducting a specific race meeting. |
| 1.4 | "COASTAL POOL" | means | a combination of selected exotic pools by Western Province Racing Club and Kwazulu-Natal Totalisator. |
| 1.5 | "COUPLED" | | has the meaning set out in rule 2.3. |
| 1.6 | "DIVIDEND" | means | the amount declared to be paid to holders of winning tickets in respect of each unit of betting calculated in accordance with these Rules as they apply to each form of betting. |

| 1.7 | "EMERGENCY ACCEPTOR" | <i>means</i> | a horse carded in addition to the maximum field, as provided for in the particular race conditions for the purpose of substitution in the event of a scratching within the maximum field. In all cases where emergency acceptors are carded they must be treated as runners until such time as they are officially scratched. |
| 1.8 | "EMPLOYEE" | <i>means</i> | a person acting as such, whether in a permanent or temporary capacity, on behalf of a club. |
| 1.9 | "GROSS POOL" | <i>means</i> | the total amount received in respect of a specific betting pool, less any amounts refunded. |
| 1.10 | "HOST CENTRE" | <i>means</i> | the centre being either Western Province Racing Club or KwaZulu-Natal Totalisator, that is deemed to be the controlling centre for a specific race meeting. Western Province Racing Club hosts all race meetings taking place in the Western Cape, Eastern Cape and Northern Cape. KwaZulu-Natal Totalisator hosts all race meetings taking place in KwaZulu-Natal, Gauteng and Free State. |
| 1.11 | "INVESTOR" | <i>means</i> | any person who places a bet pursuant to these Rules. |
| 1.12 | "ISSUE" | <i>means</i> | in relation to a ticket, that such ticket is issued in terms of these Rules. |
| 1.13 | "LEG" | <i>means</i> | each nominated race in those forms of betting where selections are required in more than one race. The first of the nominated races to be run is the first leg. The second of the nominated races to be run is the second leg and so on, depending on the number of races incorporated into a particular type of betting. |
| 1.14 | "MINOR" | <i>means</i> | a person under the age of eighteen years. |
| 1.15 | "NET POOL" | <i>means</i> | the gross pool, less tax and commission as laid down from time to time. |
| 1.16 | "OFFICIAL" | <i>means</i> | a person acting as such, whether in a permanent or temporary capacity, on behalf of a club. |
| 1.17 | "PLACED HORSES" | <i>means</i> | in relation to each type of betting, the horses occupying the places which qualify for a dividend or dividends in accordance with these Rules. |
| 1.18 | "RACECARD" | <i>means</i> | the official programme issued by a Racing Club for a specific race meeting. |
| 1.19 | "REFUNDS" | | has the meaning set out in rule 2.4. |
| 1.20 | "RULES" | <i>means</i> | the Rules herein contained and as amended from time to time. |
| 1.21 | "RUNNER" or "STARTER" | <i>means</i> | a horse declared to have started in a race in accordance with the Rules of the Jockey Club of South Africa, which has not been withdrawn before the start of such race. |
| 1.22 | "STEWARD" | <i>means</i> | a person acting as such, whether in a permanent or temporary capacity, on behalf of a club. |
| 1.23 | "TICKET" | <i>means</i> | the official betting ticket issued by a club, subject to the provisions of these Rules. |
| 1.24 | "TOTALISATOR FAVOURITE" | <i>means</i> | the individual horse on which the highest number of win unit bets have been taken, regardless of couplings. Should two or more horses have exactly the same number of unit bets placed on them, joint favourites must be declared. In the case of "coastal pools", the totalisator favourite is determined by the host centre. |
| 1.25 | "VALID TICKET" | <i>means</i> | an official ticket issued by a club's computer system, which bears the horse's number or numbers, the race number, the type of betting and the official code of the race or race meeting and other pertinent information. |
| 1.26 | "VALID TICKET HOLDER" | <i>means</i> | the person who presents a valid ticket for payment, made only to the bearer. |
| 1.27 | "WITHDRAWAL" | <i>means</i> | a horse which is declared a non-starter in a race in accordance with these Rules. |

CHAPTER 2

General

- 2.1 All investments on the totalisator shall be subject to the provisions of the Western Cape Gambling and Racing Law, 1996 (Law 4 of 1996), as amended, and the Regulations framed thereunder and these Rules.

2.2 Applicability of Rules

These Rules shall apply to the Western Province Racing Club, and to every person placing a bet on any totalisator conducted by that club; provided that insofar as any rule may relate to a specific totalisator pool, such rule shall be applicable only if such club offers such pool. The general rules shall apply to every pool in addition to the specific rules that apply to any particular type of pool.

Nothing in these Rules contained shall be construed as placing an obligation on any club to offer any specific totalisator pool.

2.3 Coupled horses

- 2.3.1 Whenever in any race a trainer has two or more horses carded, including emergency acceptors, belonging to one or more owners, such horses shall be coupled in the Jackpot and Pick Six Pools. This rule shall apply to all venues.
- 2.3.2 Couplings shall not apply in the following pools: Win, Place, Dupla, Exacta, Swinger, Trifecta, Quartet, Double, Quinpot and Place Accumulator.
- 2.3.3 No change in the trainer of a horse after the printing of the racecard shall be recognized insofar as the coupling of horses is concerned.
- 2.3.4 Where an owner has more than one horse in any race trained by different trainers, such horses shall not be coupled.
- 2.3.5 In the Jackpot and Pick Six all scratched selections, regardless of couplings, shall be substituted by the official totalisator favourite and its couplings.

2.4 Refunds

- 2.4.1 Whenever a horse is withdrawn from a race before or after coming under starter's orders, the amount placed on such a horse in any:
- * Win, Place, Dupla, Exacta, Swinger, Trifecta, Quartet Pool
- shall, subject to the provisions of these Rules, be refundable to the investor.
- 2.4.2 No refund shall be made of any amount staked on a horse which has been declared a runner, but any horse disqualified as a result of an error on the part of a race club official may, entirely at the Committee's discretion, be treated as a late scratching and a refund may be made, except in the case of a Double, Jackpot, Quinpot, Pick Six or Place Accumulator, when the totalisator favourite shall be substituted.
- 2.4.3 No refunds shall be made in respect of any:
- * Double
 - * Jackpot
 - * Quinpot
 - * Pick Six
 - * Place Accumulator
- tickets, except where a race meeting is canceled or abandoned before the running of the first leg of the pool.

2.5 Dividends and tickets

- 2.5.1 All dividends shall be calculated on the net pool, rounded-up to the nearest whole 10c (ten cents).
- 2.5.2 Immediately after the amounts of dividends have been ascertained they shall be displayed in the places provided for that purpose, but no payment of dividends shall take place until the All Clear is given by the race meeting stewards.
- 2.5.3 Should no objection be duly lodged, the All Clear shall be given and payment shall commence forthwith.
- 2.5.4 Should an objection be duly lodged, the All Clear shall not be given until the ruling of the race meeting stewards on the objection has been made known. This ruling shall be final and binding on all ticket holders irrespective of any subsequent successful appeal against such ruling.
- 2.5.5 Dividends and refunds shall only be paid on presentation of valid tickets and shall only be payable to the bearers.
- 2.5.6 Claims for a dividend or refund shall be considered in respect of a lost or mutilated ticket, provided that the club's requirements regarding claim procedures and information to be provided are adhered to.
- 2.5.7 Subject to the provisions of these Rules, a club shall not be bound to entertain claims for payment of a dividend or for a refund unless made within 32 days after the date of issue.
- 2.5.8 No complaint, either in regard to the correctness of a ticket, the correctness of change, or the payment of a dividend, shall be entertained unless it is made before the complainant leaves the window.
- 2.5.9 The sale of tickets in respect of any given pool shall continue until the official-start of the first race in respect of that pool or the only race comprising that pool.
- 2.5.10 Every purchaser of a ticket shall ask for the runner number as shown on the race card for a particular race and meeting and not the name of a horse and shall indicate the meeting and type of pool in which he wishes to invest.
- 2.5.11 Totalisator tickets shall be printed on the official stationery and shall be inscribed with the number or numbers of the horse or horses concerned, as listed on the racecard, as well as the amount staked and the private code or identification mark of the club. Only such tickets may be accepted for the payment of dividends or refunds.

2.6 Limitation of liability

- 2.6.1 A club or any steward, official agent or employee shall not be liable for damages resulting from any negligence or grossly negligent act relating in any way to totalisator betting for which they are either directly, vicariously or in any way responsible, and in particular none of the aforementioned shall either directly, vicariously or in any way, be liable for damages for the loss, destruction or disappearance of any original betting ticket.
- 2.6.2 Should the Committee declare all bets off, the relevant Pool Refund Rules shall apply.
- 2.6.3 The only proof of investment in a pool is the original ticket or computer record of that ticket, and no action, either in contract or delict of any nature whatsoever, may be instituted against the club for the payment of a dividend unless the original ticket exists or is on computer record and was in the possession of the clubs when the claim was made, and it can be proven that such original ticket or transaction was at all material times in the possession of the club.

2.7 Employees

- 2.7.1 No employee, whether permanent or temporary, of a club is entitled to participate, either directly or indirectly, in any way whatsoever in a totalisator dividend.
- 2.7.2 Information and details with regard to all totalisator pools shall be strictly confidential and no employee of the club may divulge such information.

2.8 Interpretation of these Rules

- 2.8.1 In any dispute regarding the meaning and interpretation of these Rules, the meaning and interpretation attached to them by the race

meeting stewards shall be final and binding. Every person who stakes money on the totalisator shall be deemed to have acquainted himself with these rules and to have agreed to be bound thereby.

2.8.2 Where any matter not provided for in these Rules arises, the decision of the race meeting stewards shall be final and binding.

2.8.3 The race meeting stewards shall, in their absolute discretion, decide any dispute arising in any way whatsoever from the running of the totalisator, and in particular their decision as to the validity of any claim to participate in any dividend shall be final and binding on the club or anyone who has invested, or claims to have invested, in any totalisator pool.

2.9 No bet shall be made by or dividend paid to any person under the age of 18 years.

2.10 The Win and Place Totalisators (except as provided in rules 3.2 and 4.2) shall operate at every race and the racecard shall specify at which races any other totalisators will operate, but the Committee shall have power to vary such arrangements and to make such variations of arrangements public by means of notices and announcements at the race course.

2.11 Postal or telegraphic bets shall not be accepted.

2.12 Telephonic bets may be accepted in terms of the Telephone Betting Rules and Regulations.

2.13 Bets shall be accepted in accordance with the minimum bet value as laid down, which may be amended from time to time.

2.14 *Tax and commission*

Provincial or Government tax and commission, as laid down from time to time, shall be deducted from every gross pool before the calculation of any dividend.

CHAPTER 3

Win Totalisator

3.1 The purpose of the Win Pool is to select the winner of a specified race.

3.2 The Win Pool shall operate at any race with two or more starters.

3.3 The unit of betting shall be R1,00 (one rand).

3.4 The dividend shall be determined by dividing the net pool by the number of unit bets on the winning horse.

3.5 Notwithstanding the provisions of rule 3.4, whenever two or more horses deadheat for first place, the dividend payable shall be calculated in the following manner:

The net pool shall be divided into as many equal portions as there are dead-heaters, and each such portion shall then be divided by the number of unit bets on each of the dead-heaters. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.

3.6 If there are no tickets in respect of the winning horses the net pool shall be carried forward and added to a net Win Pool of the clubs at the sole discretion of the stewards.

3.7 The coupling of horses shall not apply to the win pool.

3.8 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.

3.9 In the Win pool, the following minimum dividends are guaranteed:

Outright win	R1,10
Dead heat	R0,60
Triple dead heat	R0,40
Four way dead heat	R0,30

CHAPTER 4

Place Totalisator

4.1 The purpose of the Place Totalisator is to select a placed horse in a specified race in terms of the Rules.

4.2 The Place Totalisator shall not operate when three or fewer horses are carded in a race.

4.3 Dividends shall be paid in respect of horses placed:

- (a) first and second when there are four or five horses carded;
- (b) first, second and third when there are six to thirteen horses carded; and
- (c) first, second, third and fourth when there are fourteen or more horses carded.

4.4 The unit of betting shall be R1,00 (one rand).

4.5 The dividends shall be calculated by dividing the net Place Pool into as many portions as there are placed horses, as determined in terms of rule 4.3. If there are no tickets in respect of one or more of the placed horses, their portion of the net Place Pool shall be divided equally among the placed horses in respect of which there are tickets.

- 4.6 The portions shall be divided by the number of unit bets on each of the placed horses, and the results so obtained shall be the dividend payable.
- 4.7 Dividends shall not be declared at less than the unit value of bets except in the case of dead-heaters.
- 4.8 For the purpose of the calculation of dividends, horses dead-heating for the first place shall be deemed to have filled the first and second places, horses dead-heating for second place to have filled the second and third places, horses dead-heating for third place to have filled the third and fourth places and horses dead-heating for fourth place to have filled the fourth place jointly.
- 4.9 When there is a deadheat for any place, the place dividend on the dead-heaters shall be calculated by dividing into portions whatever part of the Place Pool relates to the dead-heaters by the number of horses which have dead-heated and then by the number of unit bets on each of the horses. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 4.10 If there are no tickets in respect of any of the placed horses, the net pool shall be carried forward and added to a net place pool of the club at the sole discretion of the stewards.
- 4.11 The coupling of horses shall not apply to the Place Pool.
- 4.12 Refunds will be made on ALL scratched selections.
- 4.13 In the Place Pool, the following minimum dividends are guaranteed:

Outright place	R1,00
Dead heat place	R0,50
Triple dead heat place	R0,30
Four way dead heat place	R0,30

CHAPTER 5

Dupla Totalisator

- 5.1 The purpose of the Dupla Pool is to select the horses placed first and second in a specified race, irrespective of the order in which they finish.
- 5.2 Dividends shall be paid in respect of horses placed first and second, irrespective of the order in which they finish.
- 5.3 The unit of betting shall be R1,00 (one rand).
- 5.4 The dividend shall be determined by dividing the net Dupla Pool by the number of unit bets on the winning combination.
- 5.5 If two horses dead-heat for first place, the net pool shall be divided equally among the number of unit bets on the dead-heaters.
- 5.6 If a dead heat results in more than one winning combination, the net pool shall be divided into as many equal portions as there are winning combinations, and each such portion shall then be divided by the number of unit bets on each of the combinations. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 5.7 If there are no tickets in respect of the winning combination, the net pool shall be carried forward and added to a net Dupla Pool of the Club at the sole discretion of the stewards.
- 5.8 The coupling of horses shall not apply to the Dupla Pool.
- 5.9 The Dupla Pool may operate at any race with three or more starters.
- 5.10 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.
- 5.11 In the Dupla Pool, a minimum dividend of R1,00 is guaranteed except in the case of dead heats where more than one dividend is payable, in which case no minimum dividend is guaranteed.

CHAPTER 6

Exacta Totalisator

- 6.1 The purpose of the Exacta Pool is to select the horses placed first and second in a specified race, in the exact order in which they finish.
- 6.2 Dividends shall be paid in respect of horses placed first and second, in the exact order in which they finish.
- 6.3 The unit of betting shall be R1,00 (one rand).
- 6.4 The dividend shall be determined by dividing the net Exacta Pool by the number of unit bets on the winning combination.
- 6.5 If two or more horses dead-heat for first or second place, resulting in more than one winning combination, the net pool shall be divided into as many equal portions as there are winning combinations, and each such portion shall then be divided by the number of unit bets on each of the combinations. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 6.6 If there are no tickets in respect of the winning combination, the net pool shall be carried forward and added to a net Exacta Pool of the club at the sole discretion of the stewards.

- 6.7 The coupling of horses shall not apply to the Exacta Pool.
- 6.8 The Exacta Pool shall operate at any race with three or more starters.
- 6.9 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.
- 6.10 In the Exacta Pool, a minimum dividend of R1.00 is guaranteed except in the case of dead heats where more than one dividend is payable, in which case no minimum dividend is guaranteed.

CHAPTER 7

Swinger Totalisator

- 7.1 The purpose of the Swinger Pool is to select any two horses finishing in the first three places irrespective of the order in which they finish.
- 7.2 Dividends shall be paid in respect of horses placed:
 - (a) first and second;
 - (b) first and third; and
 - (c) second and third,irrespective of order, each combination to receive an equal share of the net Swinger Pool.
- 7.2.1 Where four or five runners start in a Swinger Pool, dividends shall be paid in respect of horses placed first and second only, irrespective of the order in which they finish.
- 7.3 The unit of betting shall be R1.00 (one rand).
- 7.4 The dividends shall be determined by dividing the respective portions of the net pool by the number of unit bets on each of the winning combinations.
- 7.5 For the purpose of the calculation of dividends in the case of a dead-heat:
 - (a) between two horses for the first place, they shall be deemed to have filled first and second place;
 - (b) between three horses for the first place, they shall be deemed to have filled first, second and third places; and
 - (c) between two horses for second place, they shall be deemed to have filled second and third places.
- 7.6 Where three horses dead-heat for second place, the winning combinations shall be the first horse together with any one of the dead-heaters and a combination of any two of the dead-heaters.
- 7.7 Where there is a dead-heat for third place, the winning combinations shall be:
 - the first horse with the second horse;
 - the first horse with any one of the dead-heaters;
 - the second horse with any one of the dead-heaters; and
 - a combination of any two of the dead-heaters.
- 7.8 If two or more horses dead-heat for first, second or third place, resulting in more than one winning combination, the dividends shall be calculated by dividing the net pool into as many portions as there are winning combinations and the portions by the number of unit bets on each such combination. If there are no tickets in respect of any of the portions, that portion shall be distributed equally among the remaining portions.
- 7.9 If there are no tickets in respect of one or more winning combination, the net pool shall be divided among the remaining winning combinations.
- 7.10 If there are no tickets in respect of any of the winning combinations, the whole net pool shall be carried forward and added to a net Swinger Pool of the club at the sole discretion of the stewards.
- 7.11 The coupling of horses shall not apply to the Swinger Pool.
- 7.12 The Swinger Pool may operate at any race with four or more starters. (see rule 7.2.1).
- 7.13 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.
- 7.14 In the Swinger Pool a minimum dividend of R1.00 is guaranteed, except in the case of dead heats which require more than three dividends to be paid in terms of rule 7.2 and more than one dividend in terms of rule 7.2.1, in which case no minimum dividend is guaranteed.

CHAPTER 8

Double Totalisator

- 8.1 The purpose of the Double Pool is to select the horses finishing first in each of the two legs making up the Double.
- 8.2 The Double shall operate at any two races designated on the racecard as an official Double, and for the purpose of these Rules the first of any such races shall be referred to as the first leg and the second of such races as the second leg.
- 8.3 Dividends shall be paid in respect of horses finishing:
 - (a) first in the first leg with first in the second—80% of the net pool;
 - (b) first in the first leg with second in the second leg—10% of the net pool; and
 - (c) second in the first leg with first in the second leg—10% of the net pool.

- 8.4 The unit of betting shall be R1.00 (one rand).
- 8.5 The dividends shall be determined by dividing the portions of the net pool by the number of unit bets on each of the winning combinations.
- 8.6 When two or more horses dead-heat for first place in either leg, the net Double Pool shall be divided as follows:
90% to holders of tickets linking each of the horses dead-heating with the first horse in the other leg.
10% to holders of tickets linking each of the horses dead-heating with the horse placed second in the other leg.
- 8.7 If there is a deadheat for first place in both legs of the Double, the dividend shall be calculated by dividing the whole of the net pool into as many portions as there are winning combinations, and each such portion shall be divided by the number of unit bets on each of the winning combinations. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 8.8 In the event of a deadheat for second place in either or both legs, the dividend shall be calculated by dividing the 10% portion of the net pool affected into as many equal portions as there are winning combinations. Each such portion shall then be divided by the number of unit bets on each of the winning combinations. If there are no tickets in respect of any one portion, that portion shall be distributed equally among the remaining portions.
- 8.9 Should no tickets have been issued in respect of a particular winning combination, the relevant portion of the net Double Pool shall be added to combinations in respect of which there are tickets.
- 8.10 If there are no tickets in respect of any of the winning combinations, the whole net pool shall be carried forward and added to a net Double Pool of the club at the sole discretion of the stewards.
- 8.11 There shall be no refunds in exchange for valid tickets in respect of Double tickets where any selection in any leg is scratched.
- 8.12 The official totalisator favourite shall be substituted for all scratched selections. If any horse is scratched from any leg of the Double, the holder of any ticket in respect of which such horse has been selected shall be deemed to have selected the official totalisator favourite, as defined in Chapter 1 of these Rules in such leg.
- 8.13 Where for any reason either leg is abandoned, the total net pool shall be distributed as follows:
(a) 90% to the holders of tickets bearing the number of the winner of the leg run; and
(b) 10% to the holders of tickets bearing the number of the horse placed second in the leg run;
(c) In the event of a deadheat for first place, there shall be no consolation dividend and the total net pool shall be divided into as many portions as there are dead-heaters, and each portion shall be distributed among the holders of tickets bearing the number of one of the dead-heaters. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 8.14 The coupling of horses shall not apply to the Double Pool.
- 8.15 In the Double Pool a minimum dividend of R1,10 is guaranteed in respect of horses finishing first in the first leg with first in the second leg (rule 8.3 (a)), except in the case of dead heats which generate more than one dividend, in which case no minimum dividend is guaranteed.

CHAPTER 9

Trifecta Totalisator

- 9.1 The purpose of the Trifecta Pool is to select any three horses to finish first, second and third in that order in a Trifecta Pool race, as designated on the racecard.
- 9.2 The unit of betting shall be R1.00 (one rand).
- 9.3 If a Trifecta Pool is cancelled or abandoned for any reason whatsoever, or if fewer than three runners finish such race, or if a selected horse is withdrawn, a refund of the stake shall be made.
- 9.4 Subject to the provisions of these Rules, the dividend shall be calculated by dividing the net Trifecta Pool by the number of unit bets on the winning combination, i.e. selection placing first, second and third in the correct order.
- 9.5 Should there be no tickets in respect of the winning combination, the net pool for the race shall be carried forward and added to a net Trifecta Pool of the club at the sole discretion of the stewards.
- 9.6 If two or more horses dead-heat for first, second or third place, the dividend shall be calculated by dividing the net pool into as many portions as there are winning combinations, and the portions by the number of unit bets on each such combination. If there are no tickets in respect of any of the portions, that portion shall be distributed equally among the remaining portions.
- 9.7 In the event of a dead-heat for first place, the winning combinations shall be any two of the dead-heaters and the horse placed third.
- 9.8 In the event of a deadheat for second place, the winning combinations shall be the horse placed first with any two of the dead-heaters.
- 9.9 In the event of a deadheat for third place, the winning combinations shall be the horses placed first and second with any of the dead-heaters.
- 9.10 The coupling of horses shall not apply to the Trifecta Pool.
- 9.11 The Trifecta Pool may operate at any race with three or more starters.
- 9.12 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.

CHAPTER 10

Quartet Totalisator

- 10.1 The purpose of the Quartet Pool is to select any four horses to finish first, second, third and fourth in that order in a Quartet Pool race, as designated.
- 10.2 The unit of betting shall be 10c (ten cents).
- 10.3 If a Quartet Pool race is cancelled or abandoned for any reason whatsoever, or if fewer than four runners finish such race, or if a selected horse is withdrawn, a refund of the stake shall be made.
- 10.4 Subject to the provisions of these Rules, the dividend shall be calculated by dividing the net Quartet Pool by the number of unit bets on the winning combination, i.e. the selection placing first, second, third and fourth in the correct order.
- 10.5 If two or more horses dead-heat for first, second, third or fourth place, resulting in more than one winning combination, the net pool shall be divided into as many equal portions as there are winning combinations, and each such portion shall then be divided by the number of unit bets on each of the combinations. If there are no tickets in respect of any one of the portions, that portion shall be distributed equally among the remaining portions.
- 10.6 Should there be no winning tickets, the net pool for the race shall be carried forward and added to a net Quartet Pool of the club at the sole discretion of the stewards.
- 10.7 In the event of a deadheat for first place, the winning combinations shall be the dead-heaters and the horses placed third and fourth.
- 10.8 In the event of a deadheat for second place, the winning combinations shall be the horses placed first with any two of the dead-heaters and the horse placed fourth.
- 10.9 In the event of a deadheat for third place, the winning combinations shall be the horses placed first and second with any of the dead-heaters.
- 10.10 In the event of a deadheat for fourth place, the winning combinations shall be the horses placed first, second and third with any of the dead-heaters.
- 10.11 The coupling of horses shall not apply to the Quartet Pool.
- 10.12 The Quartet Pool may operate at any race with four or more starters.
- 10.13 Refunds shall be made in exchange for valid tickets in respect of all scratched selections.

CHAPTER 11

Jackpot Totalisator

- 11.1 The purpose of the Jackpot Pool is to select the winners of each of the four Jackpot races, as designated on the racecard.
- 11.2 The unit of betting shall be 50c (fifty cents).
- 11.3 There shall be no refunds in exchange for Jackpot tickets where any selection in any leg is scratched.
- 11.4 The official totalisator favourite and its couplings shall be substituted for all scratched selections, regardless of couplings. If any horse is scratched from any leg of the Jackpot, the holder of any ticket in respect of which such horse has been selected shall be deemed to have selected the official totalisator favourite (as defined in Chapter 1 of these Rules) in such leg.
- 11.5 Where in one or more legs of the Jackpot the "emergency acceptor" rule applies (see rule 1.6) and the investor has selected "The Field", he shall be deemed to have selected such emergency acceptor or acceptors in substitution for the appropriate scratched horse or horses, notwithstanding any earlier provisions to the contrary.
- 11.6 Subject to the provisions of these Rules, the dividend shall be calculated by dividing the net Jackpot Pool by the number of unit bets on the winning combination, i.e. the winners of all four legs.
- 11.7 If any race or races which constitute one or more legs of the Jackpot are cancelled or abandoned for any reason the net pool for the day shall be divided equally among all valid ticket holders who have correctly selected all the winners of the legs of the Jackpot which have been run at the meeting.
- 11.8 Should there be no winning tickets, the net pool for the day shall be carried forward and added to a net Jackpot Pool of the club at the sole discretion of the stewards.
- 11.9 If a race meeting is cancelled or abandoned before the first race of the Jackpot has been run, a refund shall be made in exchange for a valid ticket.
- 11.10.1 If a dead heat between two or more horses in any leg for the first place in the Jackpot Pool results in more than one winning combination, the net pool shall be divided into as many equal portions as there are winning combinations, and each such portion shall then be divided by the number of unit bets on each of the combinations.
- 11.10.2 If a dead heat between two or more coupled horses and any other horses in any leg for first place in the Jackpot Pool, results in more than one winning combination, the net pool shall be divided into as many portions as there are winning combinations resulting from the number of dead-heating horses. The portions of the net pool pertaining to the coupled horses shall then be combined and a dividend for the total number of tickets in respect of the coupled horses shall be declared. A maximum of 32 dividends shall be declared.

- 11.10.3 Should there be no unit bets on one or more of the winning combinations as provided for under rule 11.10.1, that portion of the net pool shall be apportioned equally among the combinations on which there are winning unit bets.
- 11.11 The coupling of horses for a win shall apply to the Jackpot Pool at any venue.

CHAPTER 12

Place Accumulator Totalisator

- 12.1 The purpose of the Place Accumulator Pool is to select a placed horse in each of the seven Place Accumulator races as designated on the racecard.
- 12.2 In this Chapter "placed horse" means a horse which is placed:
first and second when there are four or five horses carded;
first, second and third when there are six to thirteen horses carded; and
first, second, third and fourth when there are fourteen or more horses carded.
- 12.3 The unit of betting shall be 50c (fifty cents).
- 12.4 There shall be no refunds in exchange for Place Accumulator tickets where any selection in any leg is scratched.
- 12.5 If any horse is scratched from any leg of the Place Accumulator, the holder of any ticket in respect of which such horse has been selected shall be deemed to have selected the official totalisator favourite, as defined in Chapter 1 of these Rules.
- 12.6 The coupling of horses shall not apply to the Place Accumulator pool.
- 12.7 Where in one or more legs of the Place Accumulator the "emergency acceptor" rule applies (see rule 1.6) and the investor has selected "The Field", he shall be deemed to have selected such emergency acceptor or acceptors in substitution for the appropriate scratched horse or horses, notwithstanding any earlier provisions to the contrary.
- 12.8 Subject to the provision of these Rules, the dividend shall be calculated by dividing the net Place Accumulator Pool by the number of unit bets on the winning combination, i.e. placed selections in all seven legs.
- 12.9 Should there be no winning tickets, the net pool for the day shall be carried forward and added to a net Place Accumulator Pool of the club at the sole discretion of the stewards.
- 12.10 If any race or races which constitute one or more legs of the Place Accumulator are cancelled or abandoned for any reason, the net pool for the day shall be divided equally among all valid ticket holders who have correctly selected placed horses in those legs of the Place Accumulator which were duly run.
- 12.11 If a race meeting is cancelled or abandoned before the first race of the Place Accumulator has been run, a refund shall then be made in exchange for a valid ticket.
- 12.12 In the Place Accumulator, deadheats for first place shall be deemed to have filled first and second place, deadheats for second place shall be deemed to have filled second and third place and deadheats for third place shall be deemed to have filled third and fourth place, and dead-heaters for fourth place shall be deemed to have filled fourth place jointly and one dividend shall be declared.
- 12.13 In the Place Accumulator, a minimum dividend of R0.50 is guaranteed.

CHAPTER 13

Quinpot Totalisator

- 13.1 The purpose of the Quinpot Pool is to select a horse finishing first or second in each of the five Quinpot races as designated on the racecard.
- 13.2 The unit of betting shall be 50c (fifty cents).
- 13.3 There shall be no refunds in exchange for Quinpot tickets where any selection in any leg is scratched.
- 13.4 If any horse is scratched from any leg of the Quinpot, the holder of any ticket in respect of which such horse has been selected shall be deemed to have selected the official totalisator favourite, as defined in Chapter 1 of these Rules in such leg.
- 13.5 The coupling of horses shall not apply in the Quinpot Pool.
- 13.6 Where in one or more legs of the Quinpot the "emergency acceptor" rule applies and the investor has selected "The Field" (see rule 1.6), he shall be deemed to have selected such emergency acceptor or acceptors in substitution for the appropriate scratched horse or horses, notwithstanding any earlier provisions to the contrary.
- 13.7 Subject to the provisions of these Rules, the dividend shall be calculated by dividing the net Quinpot Pool by the number of unit bets on the winning combination, i.e. horses placed first or second in all five legs.
- 13.8 Should there be no winning tickets the net pool for the day shall be carried forward and added to a net Quinpot Pool of the club at the sole discretion of the stewards.
- 13.9 If any race or races which constitute one or more legs of the Quinpot are cancelled or abandoned for any reason, the net pool for the day shall be divided equally among all valid ticket holders who have correctly selected horses placed first or second in those legs of the Quinpot which were duly run.
- 13.10 If a race meeting is cancelled or abandoned before the first race of the Quinpot has been run, a refund shall be made in exchange for a valid ticket.

- 13.11 In the event of a deadheat for first place, all such horses shall be deemed to have filled first and second places in the Quinpot and one dividend shall be declared.
- 13.12 In the event of a deadheat between horses for second place, it shall be deemed, for the purpose of the Quinpot, that all such horses have filled second place and one dividend shall be declared.

CHAPTER 14

Pick Six Totalisator

- 14.1 The purpose of the Pick Six Pool is to select the winners of each of the six Pick Six races, as designated on the racecard.
- 14.2 The unit of betting shall be 10c (ten cents).
- 14.3 There shall be no refunds in exchange for Pick Six tickets where any selection in any leg is scratched.
- 14.4 The official favourite and its couplings shall be substituted for all scratched selections, regardless of couplings. If any horse is scratched from any leg of the Pick Six, the holder of any ticket in respect of which such horse has been selected shall be deemed to have selected the official totalisator favourite, (as defined in Chapter I of these Rules) in such leg.
- 14.5 Where in one or more legs of the Pick Six the "emergency acceptor" rule applies and the investor has selected "The Field" (See rule 1.6), he shall be deemed to have selected such emergency acceptor or acceptors in substitution for the appropriate scratched horse or horses, notwithstanding any earlier provisions to the contrary.
- 14.6 Subject to the provisions of these Rules, the dividend shall be calculated by dividing the net Pick Six Pool by the number of unit bets on the winning combination, i.e. the winners of all six legs.
- 14.7 If any race or races which constitute one or more legs of the Pick Six race are cancelled or abandoned for any reason, the net pool for the day shall be divided equally among all valid ticket holders who have correctly selected all the winners of the legs of the Pick Six which were duly run.
- 14.8 Should there be no winning tickets, the net pool for the day shall be carried forward and added to a net Pick Six Pool of the club at the sole discretion of the stewards.
- 14.9 If a race meeting is cancelled or abandoned before the first race of the Pick Six has been run, a refund shall be made in exchange for a valid ticket.
- 14.10.1 If a dead heat between two or more horses for first place in any leg of the Pick Six Pool results in more than one winning combination, the net pool shall be divided into as many equal portions as there are winning combinations, and each such portion shall be divided by the number of unit bets on each of the combinations.
- 14.10.2 If a dead heat between two or more coupled horses and any other horses in any leg for first place in the Pick Six Pool, results in more than one winning combination, the net pool shall be divided into as many portions as there are winning combinations resulting from the number of dead-heating horses. The portions of the net pool pertaining to the coupled horses shall be combined and a dividend for the total number of tickets in respect of the coupled horses shall be declared. A maximum of 32 dividends shall be declared.
- 14.10.3 Should there be no unit bets on one or more of the winning combinations as provided for under rule 14.10.1, that portion of the net pool shall be apportioned equally among the combinations on which there are winning unit bets.
- 14.11 The coupling of horses for a win shall apply to the Pick Six Pool at any venue.

CHAPTER 15

All Up Totalisator

- 15.1 The purpose of the All Up bet is to select the runners which qualify for a dividend in respect of the pool in each of the legs of the All Up bet selected.
- 15.2 All Up bets apply to the WIN and PLACE Pools, and the general rules applicable to those pools shall apply to All Up betting.
- 15.3 The pool type shall be common to all legs of the All Up bet.
- 15.4 The All Up bet shall consist of not fewer than two and not more than six legs, all of which shall be from the same race meeting.
- 15.5 The unit of betting shall be as laid down for the WIN and PLACE pools.
- 15.6 All legs shall be selected in ascending order, but need not be consecutive.
- 15.7 Only one runner shall be selected in each of the specified legs.
- 15.8 If a selected race is abandoned or a selected runner is scratched, the All Up bet continues as if that leg had not been selected and any reinvestments from the previous leg, or legs, shall be carried forward to the next selected leg or legs if any. For a single-leg bet or the terminating leg of an All Up bet, the amount due for investment in that leg shall be paid as a dividend.
- 15.9 If, for any reason, a selected race is run out of the advertised sequence, the selection in such a race shall be treated as envisaged in Rule 15.8, with the added rule that all All Up combinations starting on the "out of sequence" race shall terminate on that leg and any appropriate dividend shall be paid.
- 15.10 If an objection in a particular race or any other matter delays the announcement of the official result until ten (10) minutes before the official post time of the following race, any reinvestment available as a result of the race in respect of which the objection was raised shall NOT be reinvested in the following race. The reinvestment carried forward shall be reinvested in any subsequent selected leg or legs. Should there be no subsequent leg or legs the reinvestment amount carried forward shall be paid as a dividend. All decisions relating to rule 15.10 are entirely at the discretion of the stewards.

- 15.11 If a dividend from a leg is carried forward to a subsequent leg as a reinvestment, that dividend shall be rounded down to the nearest cent and carried forward as a rounded-down investment. The total amount of all such rounded-down reinvestments in respect of each runner of each race shall be rounded up to the nearest unit of investment for that pool type and shall be added to the total pool collation for that race. The resultant dividend due will be in proportion to the rounded down reinvestment made in respect of that race. For the terminating leg of the All Up bet the dividend due for each bet shall be rounded down to the nearest 10c (ten cents), and shall be added together (if appropriate) to form the final dividend due.
- 15.12 The maximum reinvestment in respect of any single selection shall be R2000 (two thousand rands) and any amount in excess of this limit shall be held back and treated as dividends due, regardless of the results of any subsequent leg or legs.
- 15.13 In addition to the single Non-Formula All Up bet over two to six legs, the following Formula All Up bets shall apply:
- Formula A: Every possible bet arising from the original selection decreasing to a single bet on each leg.
- Formula B: Every possible bet decreasing to two legs.
- Formula C: Every possible bet decreasing to three legs.
- Formula D: Every possible bet decreasing to four legs.
- Formula E: Every possible bet decreasing to five legs.
- Formula F: All six legs of a six-leg All Up bet.
- Investors are required to nominate the formula required when placing an All Up bet. If no formula is nominated, the system will assume a single straight line All Up bet and issue the appropriate ticket.
- 15.14 Once the first leg of an All Up bet has been run, the bet shall not be cancelled by the investor.
- 15.15 All the selected legs of an All Up bet shall have been run before any dividends accruing in respect of the bet will be paid.

CHAPTER 16

Fractional Betting

16.1 PURPOSE:

Fractional Betting allows the purchase of a portion of a bet, or of a bet a number of times, i.e. a fraction less than or greater than 1.

- 16.2 APPLICATION:—Fractional Betting is available for the following types of betting and options marked It is offered from all betting terminals and includes telephone betting. The totalisator rules applicable to these types of betting apply to Fractional Betting.

- 16.3 METHOD OF PURCHASE:—A customer nominates the following either verbally or via a marked betting coupon:—

- * Race Meeting
- * Race
- * Money available (multiple boxes on the bet slip can be completed to equal the money value).
- * Type of betting and option (e.g. Trifecta Box)
- * Horses

The computer system will:—

- 16.3.1 determine the value of the bet by multiplying the horse selection (i.e. number of bets) by the unit of betting for that particular type of betting.
- 16.3.2 compare the amount of money available for investment with the value of the bet at the unit of betting as in 16.3.1, above. The resultant percentage is then applied to the unit of betting and rounded down to the nearest cent, thus arriving at the fractional value of each unit of betting purchased, i.e. the base unit of betting.
- 16.3.3 multiply this base unit of betting with the number of bets taken to determine actual cost of the bet. This will be rounded up to the nearest R0.10.
- 16.3.4 add difference between the actual cost of the bet and the amount paid (rounded up to the next ten cents) to the gross pool for that particular type of betting.
- 16.3.5 Print a betting ticket and, in addition to the bet details normally printed, show the percentage of the total bet purchased if less than 100%. If the bet purchased is more than a unit, the ticket will show the number of times the bet is purchased and any fraction in excess of the whole number will be shown as a percentage of the unit of betting.
- 16.4 CARRY FORWARDS: If the net pool or a portion thereof is not won, the amount not won shall be carried forward and added to the next applicable net pool at the sole discretion of the stewards.

WESTERN CAPE GAMBLING AND RACING BOARD

RULES OF THE GAME: BOOKMAKERS

22 August 1997

RULES RELATING TO THE CONTROL OF BOOKMAKERS AND THE MANAGEMENT AND CONTROL OF BETTING ROOMS
MADE BY THE BOOKMAKERS' CONTROL COMMITTEE

The following rules are binding on all bookmakers in the Western Cape, and are in addition to the rights, duties and obligations imposed on bookmakers in terms of the Western Cape Gambling and Racing Law, 1996 (Law 4 of 1996).

GENERAL OR OVERRIDING RULES

CONFIDENTIALITY OF BETTING TRANSACTIONS

1. All betting transactions between a bookmaker and a bettor shall be strictly private and shall not be divulged by the first-named to any third party other than an appointed officer, an inspector appointed under the Ordinance, a member of the Bookmakers' Control Committee, a police official as defined in section 1 of the Criminal Procedure Act, 1977 (Act 51 of 1977), or a person specially authorised thereto by the Premier.

Void bets

2. In the case of a void bet the stake money shall be refunded to the bettor.

Possibility to win

3. In all cases there shall be a possibility of winning at the time the bet is made, failing which the bet shall be void.

Bets are "all in"

4. Unless otherwise stipulated on the betting slips, bets are "all in", whether a race is run or not, with the exception of—
 - (a) starting price bets, and
 - (b) bets made on the day of the race in respect of a horse that does not come under starter's orders or is withdrawn before the start.

"Giving a run"

5. The concession known as "giving a run" on a race shall be restricted to the two days immediately prior to the day on which the race is scheduled to be run.

Death of party to bet

6. Should either party to a bet die before the race is run, all bets are off, save that bets shall not be void as a result of the death of a bookmaker who is survived by a registered partner or partners.

Application of rules

7. These rules shall also apply to all betting transactions on races run outside the Western Cape.

RULES RELATING TO SPECIAL SITUATIONS

Deductions

8. The following deduction rules shall apply in respect of all betting transacted on the day of the race and where the bettor has been 'given a run':
 - (a) Where a horse is withdrawn before or after coming under starter's orders, all bets on that horse shall be void, and all bets struck as fixed odds on the remaining horses on the day of the race or 'with a run' shall be subject to deduction calculated in accordance with the following table:

- (b) Any bets struck after the official announcement of the withdrawal of one of or more horses shall not be subject to any adjustment unless there are further withdrawals.

Abandoned ante-post betting races

9. (a) Where a race is abandoned, all single-event bets on the race concerned shall be void.
- (b) Where the first leg of a double or a treble event is abandoned, the stake shall be placed on the remaining leg or legs.
- (c) When the second leg of a double is abandoned, backers of the winning horse in the first leg shall be paid at the price of the first leg as indicated on the ticket issued.
- (d) In a treble event where the first leg is won and the remaining races are abandoned, payments shall be made on the first leg at the price indicated on the ticket issued.
- (e) If two legs of a treble event are won and the third race is abandoned, the bet shall be paid out as a double at the odds on the two legs as indicated on the ticket issued.

Wagers struck on race day

10. (a) Where a single bet is made on the day of the race and the horse concerned is scratched, the bettor shall be refunded his or her stake.
- (b) Where both legs of a double-event are due to take place on the day of the wager, and either horse does not run for any reason, the stake money shall go on the other horse at the price indicated on the ticket. In the event of a treble, the bet shall become a double if only two horses run, or a single bet where only one horse runs. In all cases of this nature, the bookmaker's liability shall be determined by the prices indicated on the ticket issued.
- (c) In starting price doubles, trebles or accumulators, the bettor shall be paid at the official starting prices.
- (d) Where fixed odds have been given prior to a scratching or withdrawal, the bettor shall be paid at the price indicated on the ticket, subject to the adjustment or adjustments reflected in the Deduction Table in rule 8(a).

Postponed races

11. When a race advertised to be run on a certain date is postponed to a future date, all bets on such race shall stand.

Dead heats

12. In the event of a dead heat, and also in double events where either race is decided in the bettor's favour and the other race results in a dead heat, the bettor shall win the odds to half the stake and lose the other half, the only exception being in the case of a dead heat in a Match Race, in which event the bets shall be void. In double events, if both horses backed run dead heats, the backer shall win the odds to one quarter of the stake and lose the other three-quarters.

Starting prices and tote odds

13. (a) In starting price betting, the starting price shall be the official odds established by the racing club concerned. In the event of a late withdrawal where no new betting is displayed before the start of a race, the starting price shall be the last price displayed, subject to the adjustment reflected in the Deduction Table in rule 8(a).
- (b) "Totalisator place" means that the placing shall be 1, 2; 1, 2, 3; or 1, 2, 3, 4 according to the conditions and the number of starters in each particular race, as laid down by the racing club concerned.
- (c) In starting price bets and bets at tote odds, the limits which apply in a betting room shall be displayed at all times by the bookmaker.

Place betting at fixed odds

14. In races of five or six runners, place betting at fixed odds shall be first and second only at one-third of the win odds. In races of seven or more runners, place betting at fixed odds shall be first, second and third at one-quarter of the win odds. If two horses dead-heat for third place in a field of seven or more runners, settling shall take place on the same basis as for winning bets and the same principle shall apply to a dead heat for second place in a race of five or six runners. Any place betting at tote odds shall, unless otherwise stipulated, be settled in accordance with what the tote pays out on the course where the event is decided.

Betting on objections

15. No betting shall be allowed on the outcome of any objection.

Races run over again

16. If any race is ordered to be run over again, starting price bets shall be at the price current at the time the race was first run. Bets on any horse which started on the first occasion but did not go to the post on the second occasion shall be lost.

Ante-post betting

17. (a) A bookmaker betting on ante-post betting races shall display his or her prices on the betting board and indicate a price against the name of each horse in the race.
- (b) In all races on which betting in betting rooms takes place, a price shall be shown against every horse not officially scratched. Doubtful starters shall be indicated.

Settling

18. (a) Bookmakers shall make payment in respect of cash betting tickets on presentation thereof after the All Clear has been given.
- (b) Settling of all other bets not previously paid shall take place in the betting room concerned from 09:00 onwards on the first business day following the race meeting concerned.

Defaulters and posting of defaulters

19. (a) A bookmaker wishing to post a person as a defaulter through the Western Cape Bookmakers' Control Committee shall notify the secretary of the Committee in writing of the following:
- (i) full name of the defaulter
 - (ii) current residential or postal address of that person
 - (iii) full details of bet or bets claimed (i.e. date, horse, venue, bet laid and ticket numbers)
 - (iv) any other relevant information.
- (b) If the debt due by a posted defaulter is settled, the bookmaker shall immediately notify the secretary of the Western Cape Bookmakers' Control Committee in writing.
- (c) A bookmaker shall not deal with any person—
- (i) who has been declared by the Jockey Club of South Africa to be a defaulter;
 - (ii) who has been warned off the course by any of the racing clubs in the Western Cape;
 - (iii) who has been warned off the course by the Jockey Club of South Africa;
 - (iv) who has been declared by the Western Cape Bookmakers' Control Committee to be a defaulter; or
 - (v) any persons whose licences have been revoked.

Games of chance

20. No faro, dice, roulette or any other game of chance shall be played in any betting room.

Conduct on course

21. Rules affecting the conduct of bookmakers on course which are made by the racing clubs from time to time shall be observed at all relevant times.

Matters not provided for and interpretation

22. Any matter not specially provided for in these Rules and any question of interpretation of these Rules shall be decided by the Western Cape Bookmakers' Control committee, whose decision shall be final and binding upon all concerned.

SPORTS BETTING RULES

In sports betting current rules relating to betting on horses shall apply to all circumstances not covered by the following set of rules:

Football

23. (a) All football bets shall be settled on ninety minutes play. Extra time shall not count, unless the words 'to win outright' are clearly stated. Where a bet is struck 'to win outright', there shall be no betting on a draw, as extra time or penalties may be required to decide the outcome.
- (b) Prices shall be displayed on both teams as well as a draw. The price on the home team shall be displayed first and then the price of the away team.
- (c) If a team plays a different opponent to the one advertised or displayed in any tattersall's, or if the venue of a match is the reverse of that displayed, all bets on that match shall be void. Multiple bets which include that match shall stand, with that match being treated as void.

- (d) Bets shall be accepted up to kick-off time. Any selection where the kick-off time was earlier than the time when the bet was accepted shall be void.
- (e) Where various betting opportunities are offered for the same match, such as correct score, first player to score or half-time or full-time result forecast, these cannot be combined in accumulative bets, where the outcome is related. Where an accumulative bet of this type has been accepted in error, it shall be settled by equally dividing the stake unit where the related outcomes clash.
- (f) Should a match be abandoned or postponed prior to the completion of ninety minutes play, the selection shall be void.
- (g) Settlement of 'first or last player to score' bets shall be based on the goal scorer listed in the results section of the local press. Own goals shall not count. First player to score bets shall be void if the selected player does not take part or takes the field as a substitute after the first goal has been scored. If a match is abandoned, 'first player to score' bets shall stand, provided a goal has been scored.
- (h) Any matches that are postponed by more than one day after the advertised date shall be void. Multiple bets shall stand, with the void match being treated as a 'non-runner' for settlement purposes.

Athletics or swimming

24. For settlement purposes the podium position or medal ceremony shall count as the official result.

Boxing

25. (a) If a contest is postponed or abandoned, all bets shall be void. Should there be a substitute for one of the boxers, bets shall be void. A price shall be offered for a draw and if that occurs, all winning bets on either boxer shall be losing bets.
- (b) If either boxer fails to answer the bell, his opponent shall be deemed to have won the contest in the previous round. A points decision shall only be effective on completion of the scheduled number of rounds. If for any reason the number of rounds scheduled is changed, all 'round by round' bets shall be void.

Cricket

26. (a) All limited overs match bets shall be settled in accordance with official competition rules. This includes matches where a reduction of overs takes place.
- (b) If in other matches a match is abandoned because of outside interference, all bets shall be void.
- (c) In top batsmen and bowler betting, bets shall be void if players are not in the starting eleven.
- (d) In series betting all outright series bets shall stand, provided one match has been played. Correct score bets shall be void if the stipulated number of matches are not played.

Golf

27. (a) Bets on any player failing to tee off in the first round shall be void. Any subsequent withdrawals shall be deemed to be losers.
- (b) Tournament group bets on non-players shall be void if that group fails to complete the tournament. The deductions rule and the dead-heat rules applicable to horse racing shall apply.
- (c) Tournament match betting is betting on specified pairings to achieve the lowest individual aggregate for the whole tournament. Prices shall be quoted for a tie in match betting. If either player fails to take part in the tournament, bets on that match shall be void.

Motor racing

28. (a) In championship betting, bets on all drivers shall stand, whether or not they participate.
- (b) In Grand Prix betting, bets shall be settled on the result of the podium presentations.

Rugby

29. (a) The score at the end of the second half and not extra time shall be taken as the final result. Prices shall be displayed in respect of both teams as well as a draw. The only bets on the result at the end of the second half not to be settled shall be where the words 'to win outright' are clearly stated.
- (b) In 'first-try scorer' betting, penalty tries shall not count.

American football

30. The score at the end of play, including overtime, if played, shall be taken as the final result. The only exceptions shall be 'first half/second half' bets, which shall be settled at the conclusion of regulation time.

Tennis

31. (a) In match betting, once the umpire calls play, the player who progresses to the next round shall be deemed to be the winner. If a match fails to start, all bets shall be void.
- (b) If in set betting, the required number of sets to win have not been played, all set bets shall be void.
