ACT

To authorise certain unauthorised expenditure in respect of the 1999/2000 financial year and to charge the Provincial Revenue Fund accordingly.

BE IT ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

Authorisation of unauthorised expenditure for 1999/2000 financial year

1. (1) The Provincial Revenue Fund is hereby charged with the amount of R33 816 524,95 to authorise certain unauthorised expenditure as set out in Schedule 1 hereunder for the 1999/2000 financial year, over and above the amounts appropriated for this service for the financial year which ended on 31 March 2000. 5

(2) The expenditure referred to in subsection (1) is more fully described in the Report of the Auditor-General listed in Schedule 1 hereunder.

(3) The expenditure will be regarded as a direct charge against the Provincial Revenue Fund. 10

2. (1) The Provincial Revenue Fund is hereby charged with the amount of R143 350,00 to authorise certain unauthorised expenditure as set out in Schedule 1 hereunder for the 1999/2000 financial year, over and above the amounts appropriated for this service for the financial year which ended on 31 March 2000. 15

(2) The expenditure referred to in subsection (1) is more fully described in the Report of the Auditor-General listed in Schedule 1 hereunder.

(3) The expenditure will be regarded as a direct charge against the Provincial Revenue Fund.
