Schedule

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC responsible for local government has determined that the municipal council consists of 10 councillors.

After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 5 wards in terms of Schedule 1 to the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 13743 voters on 20 February 2004, by the number of wards in the municipality.

The Cape Agulhas Municipality comprises of 5 wards. The ward numbers, the voting districts in each ward, and the number of voters are as follows:

Ward 1 consisting of 2865 registered voters comprising the following voting districts:

- Voting district 98000018 (NAPIER COMMUNITY HALL) comprising 1712 registered voters
- Voting district 98070059 (HAASVLAKTE BOEREVERENIGING SAAL) comprising 381 registered voters
- Voting district 98070060 (THE WERF) comprising 662 registered voters
- Voting district 98070105 (SPANJAARDSKLOOF) comprising 110 registered voters

Ingevolge artikel 18(3) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet 117 van 1998) het die LUR vir plaaslike regering bepaal dat die munisipale raad bestaan uit 10 raadslede.

Na oorlegpleging met die Onafhanklike Verkiesingskommissie het die Munisipale Afbakeningsraad die munisipaliteit in 5 wyke afgebaken ingevolge Bylae 1 van die Wet.

Die getal geregistreerde kiesers in elke wyk, wyk nie meer as vyftien persent van die norm af nie. Die norm is bepaal deur die getal geregistreerde kiesers op die munisipale segment van die nasionale gemeenskaplike kieserslys, naamlik 13743 kiesers op 20 Februarie 2004, deur die getal wyke in die munisipaliteit te deel.

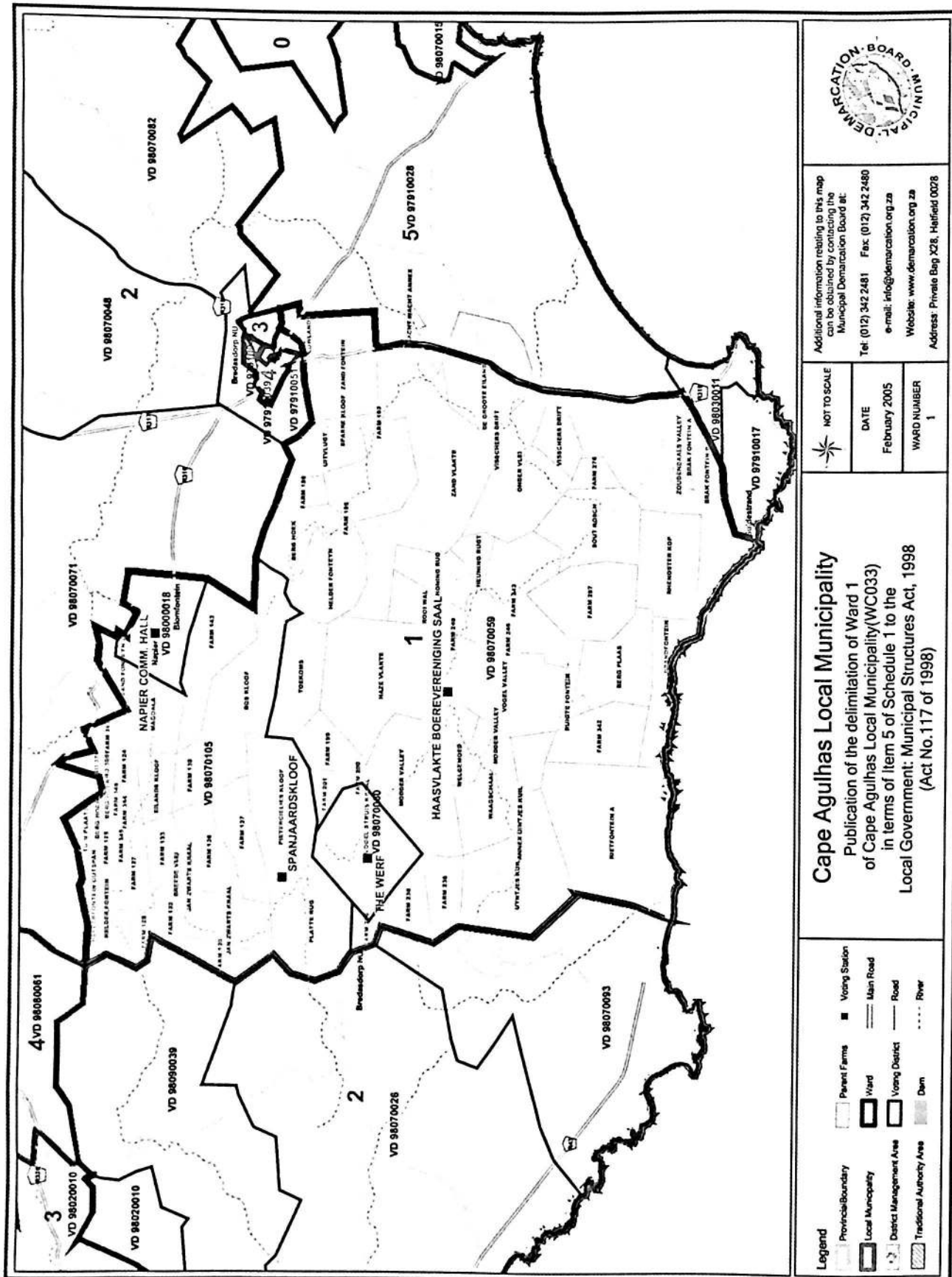

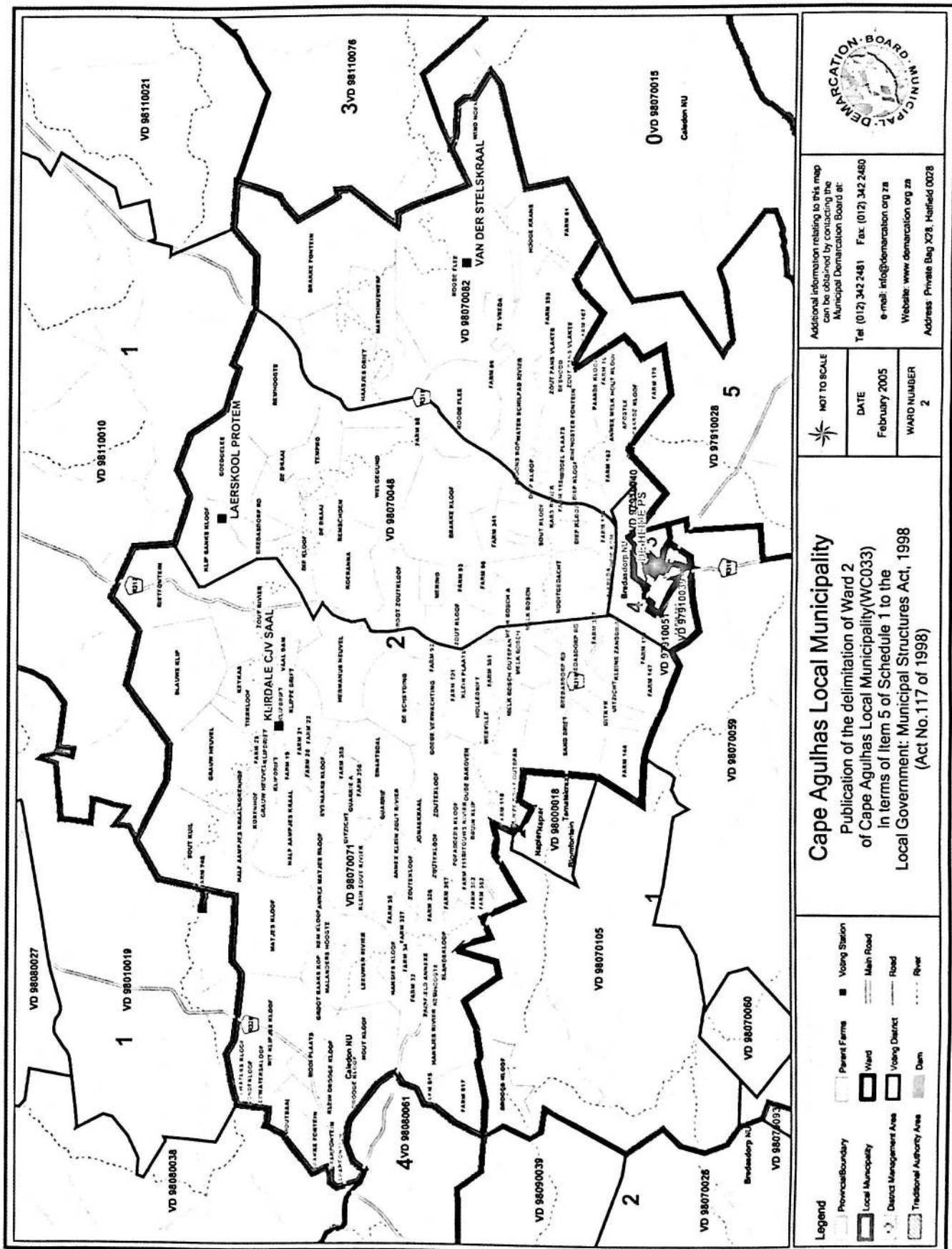

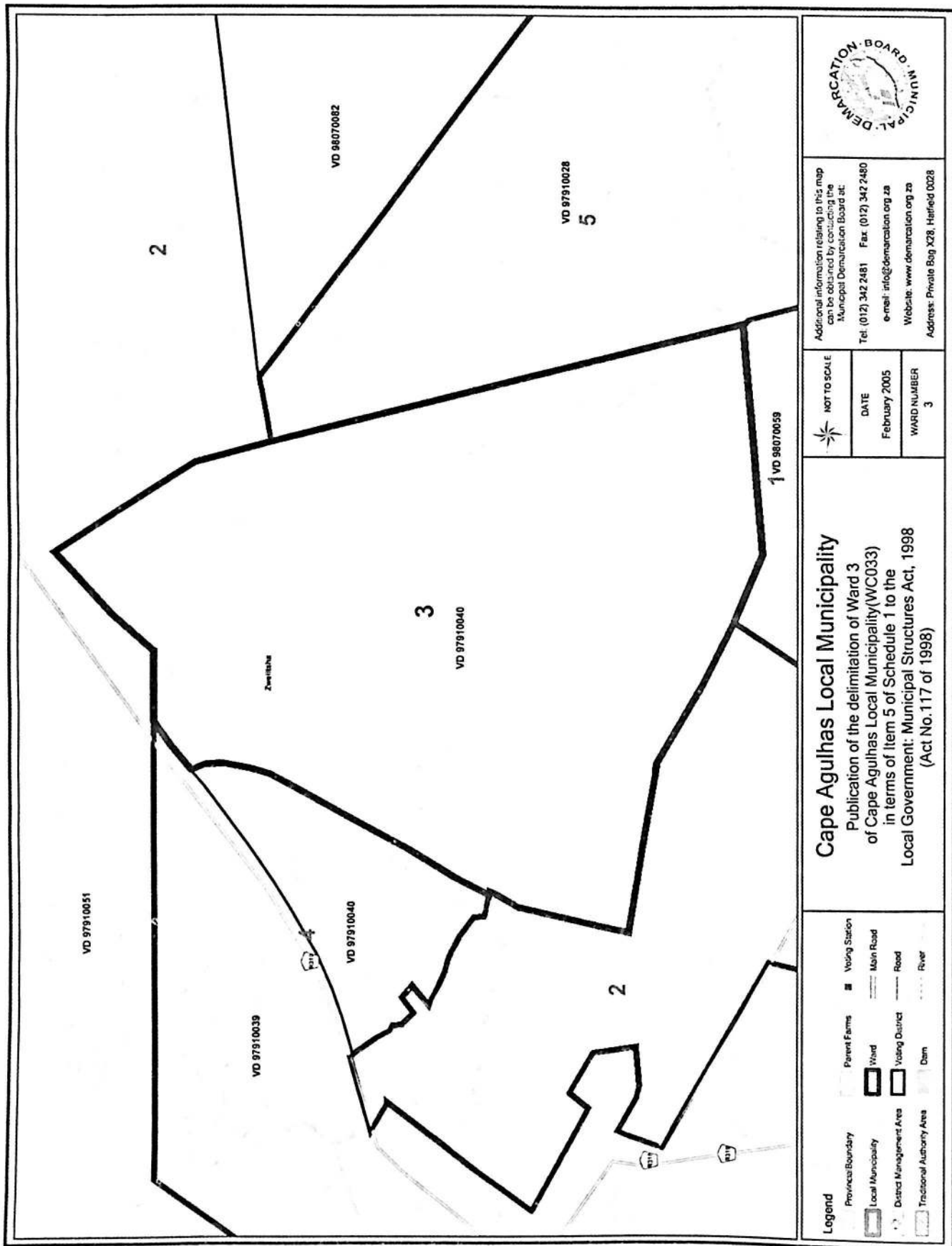
