ACT

To authorise certain unauthorised expenditure in respect of the 2005/2006 financial year and to charge the Provincial Revenue Fund accordingly.

(Afrikaans text signed by the Premier) (Assented to 30 August 2007)

B E IT ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

Authorisation of unauthorised expenditure for the 2005/2006 financial year

- 1. (1) The Provincial Revenue Fund is charged with the amount of R9 964 742,04 to authorise certain unauthorised expenditure as set out in Schedule 1 hereunder for the 2005/2006 financial year, over and above the amounts appropriated for this service for the financial year which ended on 31 March 2006.
 - (2) The expenditure referred to in subsection (1) is described by reference to the Report of the Auditor-General and the explanatory memorandum as 10 indicated in the footnote to the fifth column of the schedule to this Act.
 - (3) The expenditure is a direct charge against the Provincial Revenue Fund.

Short title

2. This Act is called the Western Cape First Finance Act, 2007.
