WESTERN CAPE LIQUOR ACT, 2008 (ACT 2 OF 2008) WESTERN CAPE LIQUOR REGULATIONS, 2011: AMENDMENT 2012

The Provincial Minister of Finance, Economic Development and Tourism in terms of section 88 of the Western Cape Liquor Act, 2008 (Act 4 of 2008), has made the regulations set out in the Schedule.

SCHEDULE

Definition

1. In these regulations “the Regulations” means the Western Cape Liquor Regulations published under Provincial Notice 366 on 21 December 2011.

Amendment of Regulation 16

2. Regulation 16 of the Regulations is amended by the substitution for the word “and” in subregulation (1) after the number “7” of the word “or”.

Amendment of Regulation 32

3. Regulation 32 of the Regulations is amended by the substitution for subregulation (2) of the following subregulation:

- “(2) An application in terms of section 65(1) must—
 (a) be made in the form of Form 27 in Annexure 3;
 (b) be in typed script on A4 size standard paper;
 (c) contain the information as required in that Form; and
 (d) be accompanied by proof of payment to the Authority of the prescribed fee set out in item 10(a) of Annexure 1.”.

Amendment of Regulation 33

4. Regulation 33 of the Regulations is amended by the deletion of the word “liquor” in subregulation (5)(b)(ii).

Amendment of Annexure 3

5. Annexure 3 to the Regulations is amended by the substitution for the Index to Forms of the following index:

BYLAE**Woordomskrywing**

Wysiging van Regulasie 32

3. Regulasie 32 van die Regulasies word gewysig deur in die Engelse teks subregulasie (2) deur die volgende subregulasie te vervang:

- “(2) An application in terms of section 65(1) must—
- (a) be made in the form of Form 27 in Annexure 3;
 - (b) be in typed script on A4 size standard paper;
 - (c) contain the information as required in that Form; and
 - (d) be accompanied by proof of payment to the Authority of the prescribed fee set out in item 10(a) of Annexure 1.”.
