DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND DEVELOPMENT PLANNING**EXEMPTION IN TERMS OF SECTION 60(1) OF THE WESTERN CAPE LAND USE PLANNING ACT, 2014 (ACT 3 OF 2014) – ERVEN 38368, 35148 AND ERVEN 35163 TO 35170, MILNERTON: CITY OF CAPE TOWN**

In terms of section 60(1) of the Western Cape Land Use Planning Act, 2014 (Act 3 of 2014) (the Act), notice is given of the authorisation by the Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape in terms of section 60(1) of the Act, on 25 June 2020, for exemption from the following provision:

- (1) *Section 43(5)(d) “the procedure for persons who are interested and affected by the notice to submit written comments within a period of at least 30 days”*

in respect of the intended applications for the rezoning and consolidation of Erf 35148 and Erven 35163 to 35170, Milnerton and the rezoning and subdivision of Erf 38368, Milnerton for the redevelopment of the subject properties for a subsidized human settlement project, subject to the following condition imposed in terms of Section 60(6) of the Act:

- (a) that persons who are interested and affected by the notice be allowed to submit written comments within a period of at least **ten (10) days**.
