DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND DEVELOPMENT PLANNING**WESTERN CAPE LAND USE PLANNING ACT, 2014 (ACT 3 OF 2014)****EXEMPTION FROM PROVISIONS OF ACT: CITY OF CAPE TOWN**

I, Anton Wilhelm Bredell, Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape, under section 60(1)(b) of the Western Cape Land Use Planning Act, 2014 (Act 3 of 2014)(the Act), exempt the City of Cape Town from the provisions of sections 43, 44, 45 and 47 of the Act, in respect of the intended land use applications for subdivision, rezoning, departures and amendment of the General Plan on erven 4454–4704, 4709–4913, 4920–5160, 5958–6154 and 6572–6634, The Hague, Delft.

Under section 60(6) of the Act I impose the condition that except for references to the Act instead of the Land Use Planning Ordinance, 1985 (Ordinance 15 of 1985)—

- (a) *the original 2011 applications inclusive of the approved amended layout plans, dated 18 May 2015, not be amended; and*
- (b) *the original 2011 decisions by the City of Cape Town may not be amended,*

- (b) *die oorspronklike 2011 besluite deur Stad Kaapstad nie gewysig mag word nie,*
