DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND DEVELOPMENT PLANNING**NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT 107 OF 1998)****INVITATION FOR PUBLIC COMMENT: DRAFT ENVIRONMENTAL MANAGEMENT FRAMEWORK FOR DRAKENSTEIN MUNICIPALITY**

The Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape, in terms of regulation 3 of the Environmental Management Framework Regulations, 2010, published under Government Notice R547/2010 in *Government Gazette* 33306 dated 18 June 2010, read with section 24(2) and (3), of the National Environmental Management Act, 1998 (Act 107 of 1998) (the Act), invites members of the public to submit written representations on or objections to the Draft Environmental Management Framework for Drakenstein Municipality (the Draft EMF).

Section 24(3) of the Act provides that the National Minister, or a Provincial Minister with the concurrence of the National Minister, may compile information and maps that specify the attributes of the environment in particular geographical areas, including the sensitivity, extent and interrelationship and significance of such attributes that must be taken into account by every competent authority. Such information and maps are to be used as environmental management frameworks in the consideration of applications for environmental authorisations in or affecting a geographical area to which the framework applies.

Drakenstein Municipality comprises the largest economy in the Cape Winelands. The municipality is centred around Paarl, with a total population of approximately 284 475 people and 72 210 households. Given the anticipated growth in the area, an environmental management framework was drafted for the Drakenstein Municipality to promote sustainability, sustainable development, secure environmental protection and cooperative environmental governance in the geographical area.

The Draft EMF supports the environmental rights of people situated in the geographical area to an environment that is not harmful to their health and well-being, and to have the environment protected. The Draft EMF will prevent pollution and ecological degradation, promote conservation and secure the sustainable development and use of natural resources in the geographical area while promoting justifiable economic and social development.

DRAKENSTEIN MUNISIPALITEIT**

Die Provinciale Minister van Plaaslike Regering, Omgewingsake en Ontwikkelingsbeplanning in die Wes-Kaap, ingevolge regulasie 3 van die “Environmental Management Framework Regulations, 2010”, gepubliseer onder Goewermentskennisgewing R547/2010 in *Staatskoerant* 33306 gedateer 18 Junie 2010, saamgelees met artikel 24(2) en (3) van die Wet op Nasionale Omgewingsbestuur, 1998 (Wet 107 van 1998) (die Wet), nooi lede van die publiek om skriftelike vertoë of besware in te dien oor die Konsepomgewingsbestuursraamwerk vir Drakenstein Munisipaliteit (die Konsep-EMF).

Artikel 24(3) van die Wet bepaal dat die Nasionale Minister, of 'n Provinciale Minister met die instemming van die Nasionale Minister, inligting en kaarte kan opstel wat die eienskappe van die omgewing in bepaalde geografiese gebiede spesifiseer, insluitende die sensitiwiteit, omvang en onderlinge verhouding en belang van sodanige eienskappe wat deur elke bevoegde owerheid in aanmerking geneem moet word. Sodanige inligting en kaarte gaan gebruik word as omgewingsbestuursraamwerke by die oorweging van aansoeke om omgewingsmagtigings in of rakende 'n geografiese gebied waarop die raamwerk van toepassing is.

Drakenstein Munisipaliteit bevat die grootste ekonomiese aktiwiteite in die Kaapse Wynland. Die munisipaliteit is rondom die Paarl gesentreer, met 'n totale bevolking van ongeveer 284 475 mense en 72 210 huishoudings. Gegewe die verwagte groei in die gebied is 'n omgewingsbestuursraamwerk vir die Drakenstein Munisipaliteit opgestel om volhoubaarheid, volhoubare ontwikkeling, beveiligde omgewingsbeskerming en samewerkende omgewingsbestuur in die geografiese gebied te bevorder.

Die Konsep-EMF ondersteun die omgewingsregte van mense wat in die geografiese gebied geleë is, tot 'n omgewing wat nie skadelik is vir hul gesondheid en welstand nie, en tot 'n beskermde omgewing. Die Konsep-EMF sal besoedeling en ekologiese agteruitgang verhoed, bewaring bevorder en die volhoubare ontwikkeling en gebruik van natuurlike hulpbronne in die geografiese gebied beveilig en terselfdertyd regverdigbare ekonomiese en maatskaplike ontwikkeling bevorder.
