**DEPARTMENT OF TRANSPORT AND PUBLIC WORKS: WESTERN CAPE  
NATIONAL LAND TRANSPORT ACT, 2009 (ACT 5 OF 2009)  
EXTRAORDINARY MEASURES IN DECLARED AREAS: BELLVILLE AND PAARL  
PROPOSAL TO DECLARE AREAS AND PROPOSED EXTRAORDINARY MEASURES**

1. I, Daylin Gary Mitchell, Provincial Minister of Transport and Public Works in the Western Cape—
  - (a) propose to declare, under section 91(1) of the National Land Transport Act, 2009 (Act 5 of 2009) (the Act), Bellville and Paarl as areas in respect of which the notification prescribing the extraordinary measures contemplated in section 91(2) of the Act (the proposed Notice) may be made (the proposed declared areas), which proposed extraordinary measures are set out in paragraph 9;
  - (b) in terms of section 91(3) of the Act, state the information required by that section in this paragraph, paragraphs 8, 9 and 12 and the Schedule; and
  - (c) propose to provide in the proposed Notice for matters contemplated in section 91(5) and (6) of the Act, as set out in paragraph 11.
2. In July of last year, a number of violent incidents took place in the proposed declared areas as a result of tensions between conflicting taxi associations in the areas relating to the route contemplated in the Schedule. Accordingly, I declared those areas as areas in respect of which certain extraordinary measures may be made. My proposed actions were set out under Government Notice 416/2021 in *Government Gazette* 44836 dated 9 July 2021. The final Notice setting out the extraordinary measures was published under Provincial Notice 77/2021 in *Provincial Gazette* 8467 dated 23 July 2021 and amended by Provincial Notices 82/2021 in *Provincial Gazette* 8475 dated 6 August 2021 and 111/2021 in *Provincial Gazette* 8496 dated 23 September 2021.
3. Provincial Notice 77/2021, read with Provincial Notice 82/2021, stated that the extraordinary measures would be in place for a period of two months. This was later amended in Provincial Notice 111/2021 to refer to a four-month period.
4. In November 2021, I again declared extraordinary measures in the proposed declared areas. My proposed actions were published under Provincial Notice 143/2021 in *Provincial Gazette* 8522 dated 22 November 2021. The final Notice setting out the extraordinary measures was published under Provincial Notice 144/2021 in *Provincial Gazette* 8523 dated 25 November 2021. Provincial Notice 144/2021 stated that the extraordinary measures would be in place for a period of three months, and that the period may be extended by two months should the circumstances set out in section 91(1) of the Act continue to exist.
5. The period in respect of which the extraordinary measures apply will soon expire; the last day on which it applies is 25 February 2022. However, tensions between the conflicting taxi associations in the proposed declared areas have continued. A number of violent incidents, including murders, have occurred and are being investigated as part of the conflict between the taxi associations. The taxi associations have been involved in an arbitration process relating to the conflict between them, and the arbitration award was received on 22 November 2021. The award is being studied by the affected parties. The Provincial Taxi Registrar is also in the process of conducting an inquiry under section 7A(20) of the Road Transportation Act, 1977 (Act 74 of 1977), in order to ascertain and address the issues between the affected parties.
6. In the circumstances, violence, unrest or instability in the taxi industry continues in the proposed declared areas, or between operators in those areas, which has led to the safety of passengers using the relevant services, residents or any other persons entering those areas, deteriorating to an unacceptable level.
7. It is anticipated that, if the proposed actions contemplated in paragraphs 1 and 9 are not taken, violence, unrest or instability in the taxi industry in the proposed declared areas, or between operators in those areas, will continue, which would then compromise the safety of the persons referred to in paragraph 6.
8. The purpose of the proposed Notice is, therefore, to stabilise the situation in the proposed declared areas.
9. The proposed extraordinary measures are as follows:
  - (a) under section 91(2)(a) of the Act, the route and ranks, and a part of the Bellville Public Transport Interchange, set out in the Schedule, that are situated in the proposed declared areas are to be closed for the operation of any minibus taxi-type service for a period of three months (the closure period), commencing on 26 February 2022;
  - (b) under section 91(2)(b) of the Act, any operating licence or permit authorising any minibus taxi-type service on the closed route contemplated in paragraph (a) is to be suspended in respect of that route for the duration of the closure period; and
  - (c) under section 91(2)(c) of the Act, and subject to paragraph 11(b), no person may, for the duration of the closure period, undertake any minibus taxi-type service on the closed route contemplated in paragraph (a), or in terms of an operating licence or permit suspended as contemplated in paragraph (b).
10. I have consulted with the relevant planning authorities in the proposed declared areas, who agree with the proposed measures contemplated in paragraphs 1(a) and 9.
11. Further matters to be included in the proposed Notice are—
  - (a) under section 91(5) of the Act, a current minibus taxi operator who contravenes the proposed Notice, or fails to comply therewith, commits an offence and is liable on conviction to a fine of R5000, or to imprisonment for a period not exceeding six months; and
  - (b) under section 91(6) of the Act, a temporary permit may be issued to an operator of a motor vehicle, minibus or midibus to operate a minibus taxi-type service, or to an operator of a bus to operate a bus service, on a closed route or at a closed rank during the closure period in substitution for the prohibited services contemplated in paragraph 9(a).

12. Any interested or affected person—

**DEPARTEMENT VAN VERVOER EN OPENBARE WERKE: WES-KAAP**  
**“NATIONAL LAND TRANSPORT ACT, 2009” (WET 5 VAN 2009)**

**BUITENGEWONE MAATREËLS IN VERKLAARDE GEBIEDE: BELLVILLE EN PAARL**  
**VOORSTEL OM GEBIEDE TE VERKLAAR EN VOORGESTELDE BUITENGEWONE MAATREËLS**

1. Ek, Daylin Gary Mitchell, Provinciale Minister van Vervoer en Openbare Werke in die Wes-Kaap—
  - (a) stel voor om, kragtens artikel 91(1) van die “National Land Transport Act, 2009” (Wet 5 van 2009) (die Wet), Bellville en die Paarl te verklaar as gebiede ten opsigte waarvan die kennisgewing wat die buitengewone maatreëls beoog in artikel 91(2) van die Wet voorskryf (die voorgestelde Kennisgewing), gemaak kan word (die voorgestelde verklaarde gebiede), welke voorgestelde buitengewone maatreëls in paragraaf 9 uiteengesit word;
  - (b) ingevolge artikel 91(3) van die Wet, vermeld die inligting vereis by daardie artikel in hierdie paragraaf, paragrawe 8, 9 en 12 en die Bylae; en
  - (c) stel voor om in die voorgestelde Kennisgewing voorsiening te maak vir aangeleenthede beoog in artikel 91(5) en (6) van die Wet, soos uiteengesit in paragraaf 11.
2. In Julie laas jaar het 'n aantal gewelddadige insidente in die voorgestelde verklaarde gebiede plaasgevind as gevolg van spanning tussen strydende taxi-verenigings in die gebiede wat met die roete beoog in die Bylae verband hou. Gevolglik het ek daardie gebiede as gebiede verklaar ten opsigte waarvan sekere buitengewone maatreëls getref kan word. My voorgestelde optrede is onder Goewermentskennisgewing 416/2021 in *Staatskoerant* 44836 gedateer 9 Julie 2021 uiteengesit. Die finale Kennisgewing wat die buitengewone maatreëls uiteenis, is onder Provinciale Kennisgewing 77/2021 in *Provinciale Koerant* 8467 gedateer 23 Julie 2021 gepubliseer en by Provinciale Kennisgewings 82/2021 in *Provinciale Koerant* 8475 gedateer 6 Augustus 2021 en 111/2021 in *Provinciale Koerant* 8496 gedateer 23 September 2021 gewysig.
3. Provinciale Kennisgewing 77/2021, saamgelees met Provinciale Kennisgewing 82/2021, vermeld dat die buitengewone maatreëls vir 'n tydperk van twee maande in plek sou wees. Dit is later gewysig in Provinciale Kennisgewing 111/2021 om na 'n viermaandetyelperk te verwys.
4. In November 2021 het ek weer buitengewone maatreëls in die voorgestelde gebiede verklaar. My voorgestelde optrede is onder Provinciale Kennisgewing 143/2021 in *Provinciale Koerant* 8522 gedateer 22 November 2021 gepubliseer. Die finale Kennisgewing wat die buitengewone maatreëls uiteenis, is onder Provinciale Kennisgewing 144/2021 in *Provinciale Koerant* 8523 gedateer 25 November 2021 gepubliseer. Provinciale Kennisgewing 144/2021 het bepaal dat die buitengewone maatreëls in plek sal wees vir 'n tydperk van drie maande, en dat daardie tydperk met twee maande verleng kan word sou die omstandighede uiteengesit in artikel 91(1) van die Wet voortduur.
5. Die tydperk ten opsigte waarvan die buitengewone maatreëls van toepassing is, sal binnekort verstryk; die laaste dag waarop dit van toepassing is, is 25 Februarie 2022. Spanning tussen die strydende taxiverenigings in die voorgestelde verklaarde gebiede duur egter voort. 'n Aantal gewelddadige insidente, insluitende moorde, het plaasgevind en word ondersoek as 'n deel van die konflik tussen die taxiverenigings. Die taxiverenigings was deel van 'n arbitrasieproses rakende die konflik tussen hulle, en die arbitrasietoekenning is op 22 November 2021 ontvang. Die toekenning word deur die geraakte partye bestudeer. Die Provinciale Taxiregistrateur is ook tans besig met 'n ondersoek kragtens artikel 7A(20) van die Wet op Padvervoer, 1977 (Wet 74 van 1977), ten einde die geskilpunte tussen die geraakte partye vas te stel en die hoof te bied.
6. In die omstandighede duur geweld, onrus of onstabilitet voort in die taxibedryf in die voorgestelde verklaarde gebiede, of tussen operateurs in daardie gebiede, wat geleei het tot die agteruitgang tot 'n onaanvaarbare vlak van die veiligheid van passasiers wat die betrokke dienste gebruik, inwoners of enige ander persone wat daardie gebiede betree.
7. Dit word verwag dat, indien die voorgestelde optrede beoog in paragrawe 1 en 9 nie plaasvind nie, geweld, onrus of onstabilitet in die taxibedryf in die voorgestelde verklaarde gebiede, of tussen operateurs in daardie gebiede, sal voortduur, wat dan die veiligheid van die persone bedoel in paragraaf 6 sal benadeel.
8. Die doel van die voorgestelde Kennisgewing is daarom om die situasie in die voorgestelde verklaarde gebiede te stabiliseer.
9. Die voorgestelde buitengewone maatreëls is soos volg:
  - (a) kragtens artikel 91(2)(a) van die Wet, om die roete en staanplekke, en 'n gedeelte van die Bellville Openbare Vervoerwisselaar, uiteengesit in die Bylae, wat in die voorgestelde verklaarde gebiede geleë is, te sluit vir die bedryf van enige minibustaxi-tipe diens vir 'n tydperk van drie maande (die sluitingstydperk), met ingang van 26 Februarie 2022;
  - (b) kragtens artikel 91(2)(b) van die Wet, om enige operateurslisensie of permit wat enige minibustaxi-tipe diens op die geslote roete beoog in paragraaf (a) magtig, vir die duur van die sluitingstydperk ten opsigte van daardie roete op te skort; en
  - (c) kragtens artikel 91(2)(c) van die Wet, en behoudens paragraaf 11(b), mag geen persoon, vir die duur van die sluitingstydperk, enige minibustaxi-tipe diens op die geslote roete beoog in paragraaf (a), of ingevolge 'n operateurslisensie of permit wat soos beoog in paragraaf (b) opgeskort is, bedryf nie.
10. Ek het oorleg gepleeg met die betrokke beplanningsowerhede in die voorgestelde verklaarde gebiede, wat instem tot die voorgestelde maatreëls beoog in paragraaf 1(a) en 9.
11. Verdere aangeleenthede wat in die voorgestelde Kennisgewing ingesluit staan te word, is—
  - (a) kragtens artikel 91(5) van die Wet, pleeg 'n huidige minibustaxi-operateur wat die voorgestelde Kennisgewing oortree, of versuim om daaraan te voldoen, 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van R5000, of met gevangenisstraf vir 'n tydperk van hoogstens ses maande; en
  - (b) kragtens artikel 91(6) van die Wet, kan 'n tydelike permit aan 'n operateur van 'n motorvoertuig, minibus of midibus uitgereik word om 'n minibustaxi-tipe diens te bedryf, of aan 'n operateur van 'n bus om 'n busdiens te bedryf, gedurende die sluitingstydperk op 'n geslote roete of by 'n geslote staanplek ter vervanging van die verbode dienste beoog in paragraaf 9(a).

Ngenyanga yeKhala yonyaka ophelileyo, kuye kwaqhambuka uthotho lweetshukumo zobundlobongela kwezi ngingqi kucetywa ukumiselwa kwazo njengomvuka wokungaboni ngaso-nye Phakathi kwemibutho eyahlukeneyo yoonotaxi kwezi ngingqi ngenxa yemizila edizwe kwiShedyuli. Kwangokunjalo, ndazimisela ezo ngingqi njengeenginqi ekungafuneka kumiselwe amanyathelo angaqhelekanga ngazo. Iintshukumo endazicebayo zathiba thaca kwiSaziso sikaRhulumente 416/2021 kwiGazethi yeRhulumente 44836 yosuku olulolwethoba kweyeKhala ka-2021. ISaziso sokugqibela esasithi thaca la manyathelo angaqhelekanga sapapashwa phantsi kweSaziso sePhondo 77/2021 kwiGazethi yePhondo 8496 sosuku Iwama-23 kweyoMsintsi ka-2021
3. ISaziso sePhondo 77/2021, xa sifundwa kunye neSaziso sePhondo 82/2021, sadiza ukuba la manyathelo angaqhelekanga aya kumiselwa isithuba seenyanga ezimbini. Oku kwathi kwallintshintsha emva kwexesha kwiSaziso sePhondo 111/2021 ukuze sibhekise kwixesha eliziinyanga ezine.
4. Ngenyanga yeNkanga ka-2021, ndaphinda ndamisela amanye amanyathelo angaqhelekangakwakwezi ngingqi zazicetywa ukumiselwa. Iintshukumo endandiziceba zathi zapapashwa phantsi kweSaziso sePhondo 143/2021 kwiGazethi yePhondo 8522 yosuku Iwama-22 kweyeNkanga ka-2021. Isaziso sokugqibela esasimisela la manyathelo angaqhelekanga sapapashwa phantsi kweSaziso sePhondo 144/2021 kwiGazethi yePhondo 8523 yosuku Iwama-25 kweyeNkanga ka-2021. ISaziso sePhondo 144/2021 sadiza ukuba la manyathelo angaqhelekanga aya kusala emiselwa isithuba seenyanga ezintathu, yaye elo xesha lingandisa ngezinye iinyanga ezimbini ukuba iimeko ezimiselwe kwicandelo 91(1) lalo Mthetho zisaqhuba.
5. Eli xesha la manyathelo angaqhelekanga liza kuphela kungekudala; usuku Iwalo lokugqibela ngumhla wama-25 kweyoMdumba ka-2022. Kodwa ke, ziqhubile zona iintshukumo zokungaboni ngaso-nye phakathi kwemibutho eyahlukeneyo yoonotaxi.
