The consolidated statement reflects the financial performance of municipalities as at the end of the third quarter (ending 31 March 2022) of the 2021/22 municipal financial year.

The Provincial Treasury uses National Treasury's Database as the primary source for the information reported in this publication. Although every effort has been made to compile a reliable set of numbers, the quality and completeness of the information is affected by the credibility of reports submitted by municipalities.

SUMMARY ON THE STATE OF LOCAL GOVERNMENT REVENUE AND EXPENDITURE: THIRD QUARTER CONSOLIDATED STATEMENT FOR THE PERIOD 1 JANUARY 2022 – 31 MARCH 2022

BACKGROUND

Section 71 (7) of the Municipal Finance Management Act (MFMA) requires that the Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity.

This publication forms part of the In-Year Management, Monitoring and Reporting System for Local Government which enables the Provincial Treasury to exercise oversight over municipalities in the Western Cape. It provides a high-level review of the implementation of municipal budgets for the third quarter, ending 31 March 2022.

DATA USED

National Treasury's Local Government Database is the primary data source used for this publication. The quality of the report is subject to the credibility of the municipal Standard Chart of Accounts (mSCOA) data string information submitted by the tenth working day of each month and is compromised when municipalities fail to submit all the required data strings.

Some anomalies were noted in the submissions made by municipalities which have a significant impact on the credibility of the financial information reported for the period ending 31 March 2022. Discrepancies on key indicators were observed on the negative cash and cash equivalent budgets and year-to-date actuals reported by some municipalities as well as misalignments on capital funding and expenditure.

The areas of concern include:

- The incorrect use of the mSCOA chart and segments and weaknesses in balance sheet budgeting, movement accounting and basic municipal accounting practices in municipalities.
- Some municipalities are either not budgeting, transacting and reporting directly from their core financial system; have not purchased all the modules of their core financial system; or have not upgraded to the Enterprise Resource Planning (mSCOA enabling) version of their financial system.
- Municipalities are not locking their adopted budgets and their financial systems at month-end to ensure prudent financial management. The Local Government Database and Reporting System will therefore lock all submission periods within the reporting period at the end of each quarter to enforce municipalities to lock their budgets and close their financial system in the next reporting year.

Although improvements have been observed in some areas, the credibility of mSCOA data strings remains a concern. The municipal capital and cash flow budget performance presented in this publication may not align to the performance reported by municipalities to their respective Councils in their Financial Management Reports. Municipalities should refer to the guidance provided in the mSCOA circulars issued by the National Treasury to classify their transactions correctly.

Western Cape municipalities remain committed to improving the quality of financial information with support from National and Provincial Treasury.

The data presented in this gazette provides a summary of budget implementation performance against key indicators for all municipalities in the province extracted on 20 April 2022. Detailed information for each municipality is available to the public in the section 71 files published at mfma.treasury.gov.za.

AGGREGATED TRENDS

1. On aggregate, Western Cape municipalities spent 62.2 per cent or R52.57 billion of the total adjusted expenditure budget of R84.56 billion by the end of the third quarter on 31 March 2022 (operating expenditure accounted for R48.09 billion and capital expenditure for R4.49 billion).
2. In respect of revenue, aggregate billing and other revenue amounted to 70.4 per cent or R58.47 billion of the total adjusted revenue budget of R83.10 billion (operating revenue accounted for R54.27 billion and capital revenue for R4.20 billion).
3. Aggregate operating revenue for the period ended 31 March 2022 amounted to R54.27 billion or 73.8 per cent of the adjusted operating revenue budget of R73.56 billion. This represents a slight underperformance of 3.6 per cent compared to the year-to-date budget, mainly as a result of under recoveries reported on other own revenue (14.9 per cent).
4. Service charges and property rates are the largest revenue sources, contributing 46.9 per cent and 19.7 per cent, respectively towards the total adjusted operating revenue budget of R73.56 billion. The 2021/22 quarter three results show R26.08 billion in revenue generated from service charges (75.6 per cent of the R34.51 billion adjusted budget) and R10.71 billion revenue in property rates (73.9 per cent of the R14.48 billion adjusted budget). These amounts represent billed revenue and not actual revenue collected. Stringent debt collection strategies must be applied to realise the planned revenue.
5. Under performances are noted in other own revenue (14.9 per cent), investment revenue (6.33 per cent), transfers and subsidies (3.0 per cent), property rates (2.2 per cent) and services charges (1.42 per cent) at the end of March 2022. In the current economic and fiscal environment, municipalities are advised to closely monitor underperforming revenue items and adjust spending patterns to remain within their affordability envelope.
6. To date municipalities spent R48.09 billion or 64.1 per cent of their aggregated R75.02 billion operating adjusted expenditure budget. Employee related costs remain the highest cost driver to date, amounting to R16.66 billion, followed by materials and bulk purchases of R16.13 billion and other expenditure amounting to R10.55 billion. Many municipalities implemented the wage agreement for local government in the second quarter, which resulted in increased spending on cost of employment. Municipalities need to contain costs, more especially consumption related spending, exercise prudent financial management, and eradicate wasteful use of public resources.
7. Western Cape municipalities adjusted their capital budgets downwards to R9.54 billion from R11.62 billion. Capital spending of R4.49 billion or 47.0 per cent against the R9.54 billion adjusted capital budget was reported. The capital expenditure amount reflected in the data strings is lower than the actual capital spending reported by some municipalities in the Financial Management Reports that were presented to their respective Councils. The City of Cape Town reported spending of R2.8 billion or 45.8 per cent of their adjusted capital budget of R6.11 billion. However, from the M09 2021/22 C-schedules the Metro indicated actual YTD capital spending of R2.93 billion against an Adjustment Budget amount of R6.11 billion (48 per cent). The Metro indicated that the difference between the YTD MBRR actuals and the mSCOA data strings is due to settlement processes which still need to be coded correctly. A solution is currently being investigated. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported aggregated capital expenditure performance of R448.86 million or 43.7 per cent against their combined capital adjusted budget of R1.03 billion. The capital budget spending for district municipalities amounted to R14.25 million or 21.5 per cent of their total adjusted budget of R66.4 million whilst local municipalities' capital spending amounted to R1.22 billion or 52.2 per cent against their aggregated R2.34 billion adjusted

capital budget. Amongst the contributing factors to under-spending are delays in supply chain processes. Based on previous year's trends, capital expenditure is likely to increase in the next quarter.

8. In aggregate, Western Cape municipalities fund 64.4 per cent of their total planned capital investment from own funding. This is comprised of borrowing (19.6 per cent) and internally generated funds (44.8 per cent).
9. Capital spending against borrowings amounted to R801.51 million or 42.9 per cent against the adjusted borrowing budget of R1.87 billion. Capital spending funded from transfers recognised amounted to R1.60 billion or 47.2 per cent against the R3.40 billion adjusted budgeted amount. Spending on internally generated funds amounted to R1.80 billion or 42.0 per cent against the R4.28 billion adjusted budget for internally generated funds. Infrastructure investment is a lever for economic growth and a conscious effort to fully implement capital projects is encouraged.
10. Aggregate municipal consumer debtors as at 31 March 2022 amounted to R12.64 billion. The bulk of the outstanding debt is owed by households, which account for R9.16 billion or 72.5 per cent of the total outstanding debt.
11. Debtors older than 90 days amount to R8.39 billion or 66.4 per cent of the total outstanding debtors of R12.64 billion. This includes historic debt that has accumulated over an extended period, interest on arrears and other recoveries.
12. A quarter-on-quarter increase of 5.1 per cent is noted in outstanding debtors, from R12.02 billion at the end of quarter two to R12.64 billion at the end of quarter three of 2021/22.
13. In aggregate, Western Cape municipalities reported outstanding creditors of R617.20 million at 31 March 2022. The total outstanding creditors older than 30 days amount to R277.59 million or 45.0 per cent of the total. Municipalities cited various reasons for payments that are owed for more than 30 days. Bespoke support initiatives and engagements are held with municipalities that reported high outstanding creditor balances.
14. The total cash and cash equivalents reported by municipalities as at the end of quarter three amount to R31.59 billion. However, this amount is not aligned with figures in the MBRR schedules reported to municipal councils as explained above.
15. Provincial Treasury will continue to provide support to municipalities including guidance and support with mSCOA implementation, budget verifications, annual budget and in-year monitoring training, Covid-19 response, capacity building training initiatives, quarterly Chief Financial Officers' and Municipal Accountants Fora as well as facilitating the reduction of government debt owed to municipalities in conjunction with various government departments.
