WESTERN CAPE LAND USE PLANNING ACT, 2014 (ACT 3 OF 2014)  
NOTICE OF EXEMPTION TO MUNICIPALITIES UNDER SECTION 60(1) OF  
WESTERN CAPE LAND USE PLANNING ACT, 2014**

I, Anton Wilhelm Bredell, Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape, under section 60(1) of the Western Cape Land Use Planning Act, 2014 (Act 3 of 2014) (LUPA), grant an exemption to all municipalities in the Western Cape from the provisions of LUPA as set out in the Schedule. The exemption is aimed at reducing the financial or administrative burden of integrated application processes contemplated in section 67 of LUPA, the provision of housing with the assistance of a state subsidy and the incremental upgrading of existing settlements. The exemption is granted on condition that a public participation process concerning the same land use matter has been followed in terms of land use planning or other applicable legislation.

Ek, Anton Wilhelm Bredell, Provinciale Minister van Plaaslike Regering, Omgewingsake en Ontwikkelingsbeplanning in die Wes-Kaap, verleen kragtens artikel 60(1) van die Wes-Kaapse Wet op Grondgebruikbeplanning, 2014 (Wet 3 van 2014) (LUPA), aan alle munisipaliteite in die Wes-Kaap vrystelling van die bepalings van LUPA soos in die Bylae uiteengesit. Die vrystelling is gemik op die verligting van die finansiële of administratiewe las van geïntegreerde aansoekprosesse beoog in artikel 67 van LUPA, die verskaffing van behuisiging met behulp van 'n staatsubsidie of die stapsgewyse opgradering van bestaande nedersettings.
