I, Ms. Mireille Wenger, Provincial Minister of Finance and Economic Opportunities in the Western Cape, in terms of section 71(7) of the Local Government: Municipal Finance Management Act (No. 56 of 2003), publish the consolidated statement on municipal budgets in the Western Cape Province. The consolidated statement reflects the financial performance of municipalities as at the end of the first quarter (ending 30 September 2023) of the 2023/24 municipal financial year.

The Provincial Treasury uses National Treasury's Database as the primary source for the information reported in this publication. Although every effort has been made to compile a reliable set of numbers, the quality and completeness of the information is affected by the credibility of reports submitted by municipalities.

SUMMARY ON THE STATE OF LOCAL GOVERNMENT REVENUE AND EXPENDITURE: FIRST QUARTER CONSOLIDATED STATEMENT FOR THE PERIOD 1 JULY 2023 - 30 SEPTEMBER 2023

BACKGROUND

Section 71(7) of the Municipal Finance Management Act (MFMA) requires that the Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity.

This publication forms part of the In-Year Management, Monitoring and Reporting System for Local Government which enables the Provincial Treasury (PT) to exercise oversight over municipalities in the Western Cape. It provides a high-level review of the implementation of municipal budgets for the first quarter, ending 30 September 2023.

DATA USED

National Treasury's Local Government Database is the primary data source used for this publication. The quality of the report is subject to the credibility of the municipal Standard Chart of Accounts (mSCOA) data string information submitted by the tenth working day of each month and is compromised when municipalities fail to submit all the required data strings.

Some anomalies were noted in the submissions made by municipalities which have a significant impact on the credibility of the financial information reported for the period ending 30 September 2023. Discrepancies on key indicators were observed on the negative cash and cash equivalent budgets and year-to-date actuals reported by some municipalities as well as misalignments on capital funding and expenditure.

To assist municipalities to submit credible mSCOA data strings, PT has institutionalised an mSCOA segments use analysis tool which is shared with municipalities on a monthly basis. PT also has technical engagements with municipalities to discuss mSCOA findings. Municipalities are required to develop an action plan indicating specific timelines to resolve issues identified so that PT can keep track of the progress made by municipalities monthly.

Despite the challenges, Western Cape municipalities are committed to improving the quality of information with support from the National and Provincial Treasuries.

The data presented in this gazette provides a summary of the budget implementation performance against key indicators for all municipalities in the province. The data used was extracted on 16 October 2023 and detailed information for each municipality is available to the public in the section 71 files published at mfma.treasury.gov.za.

AGGREGATED TRENDS

1. In aggregate, Western Cape municipalities spent R18.38 billion or 17.7 per cent of the total approved expenditure budget of R103.82 billion by the end of the first quarter on 30 September 2023 (actual operating expenditure accounted for R16.66 billion and actual capital expenditure for R1.72 billion).
2. In respect of revenue, aggregate billing and other revenue amounted to R23.94 billion or 23.3 per cent of the total approved revenue budget of R91.26 billion (actual operating revenue accounted for R22.23 billion and actual capital revenue for R1.72 billion).
3. Service charges and property rates are the largest revenue sources, contributing 48.7 per cent and 18.7 per cent respectively towards the total approved operating revenue budget of R85.89 billion. This is consistent with past trends.
4. For the quarter under review property rates overperformed by R49.8 million or 1.1 per cent. The overperformance is mainly due to property rates levied on an annual basis in July 2023. However, an underperformance from service charges of 1.2 per cent is noted. This is mainly due to the underperformance of R183.35 million or 2.31 per cent on electricity revenue which is likely the result of ongoing load shedding. Service charges and property rates revenue represent billed revenue and not actual revenue collected. Municipalities must stringently implement debt collection strategies to realise this revenue.
5. To date municipalities spent R16.66 billion or 19.2 per cent of their aggregated R86.80 billion approved operating expenditure budget. Employee related costs is the highest cost driver, amounting to R5.69 billion or 21.1 per cent of the total operating expenditure to date, followed by inventory consumed and bulk purchases of R5.64 billion or 19.5 per cent and other expenditure amounting to R3.72 billion or 16.3 per cent of total operating expenditure.
6. Aggregated operating expenditure underperformed by R2.39 billion or 12.6 per cent against the year-to-date operating budget as at the end of September 2023. A year-on-year comparison indicates an increase in operating expenditure of R965.17 million or 6.2 per cent, growth that exceeds inflation.
7. As at the end of September 2023, an aggregated operating surplus of R5.57 billion against an approved operating deficit budget of R912.73 million was reported. The surplus may be due to some municipalities reducing in-year spending in line with their limited available revenue and cash. However, it was also noted that several municipalities are not fully reporting on their non-cash items (debt impairment and depreciation), this significantly understates the operating expenditure reported to date and results in an exaggerated operating surplus.
8. Municipalities in the Western Cape spent R1.72 billion or 10.9 per cent of their aggregated R15.82 billion approved capital budget to date. Spending is off to a slow start with an underperforming variance of 32.8 per cent in the current year when compared to the budgeted year-to-date performance. However, a year-on-year comparison shows capital spending by municipalities is 36.2 per cent larger than at the same point last year.
9. The City of Cape Town reported capital spending of R1.18 billion (10.7 per cent of the approved budget) which is an underperformance of 8.93 per cent against the year-to-date budget. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported aggregated capital expenditure performance of R159.23 million or 8.0 per cent against their combined capital budget of R1.99 billion. Local municipalities' capital spending amounted to R387.66 million or 15.6 per cent against their aggregated capital budget of R2.48 billion. Municipalities' capital spending is largely dependent on the timeous planning and completion of supply chain processes such as advertisement of bids and evaluating and awarding contracts to successful bidders.

10. In aggregate, Western Cape municipalities funded 70.1 per cent of their total planned capital investment from own funding, an increase from the 67.4 per cent budgeted in the prior year. This comprises of internally generated funds (20.7 per cent) and borrowings (49.3 per cent).
11. Capital spending funded from borrowings in the first quarter amounted to R739.99 million or 9.5 per cent of the budgeted borrowing of R7.80 billion. Capital spending funded from transfers amounted to R604.89 billion or 12.8 per cent of the budgeted amount of R4.73 billion. Internally generated funds utilised amounted to R373.47 million or 11.4 per cent of the approved budget of R15.81 billion.
12. The aggregate municipal consumer debtors balance as at 30 September 2023 amounted to R15.35 billion. The bulk of the outstanding debt is owed by households, which account for R10.83 billion or 70.6 per cent of the total outstanding debt.
13. Debtors older than 90 days amounted to R10.06 billion or 65.6 per cent of the total outstanding debtors of R15.35 billion. This includes historic debt that has accumulated over an extended period, interest on arrears and other recoveries. Debtors over 90 days increased by R214.97 million or 2.2 per cent during the first quarter.
14. Quarter-on-quarter outstanding debtors have increased by R1.1 billion or 7.7 per cent, from the R14.25 billion reported at the end of the June 2023.
15. In aggregate, Western Cape municipalities reported outstanding creditors of R786.01 million as at 30 September 2023. Outstanding creditors older than 30 days amounted to R417.48 million or 53.1 per cent of the total outstanding creditors. Total outstanding creditors have decreased by R178.67 million when compared to the outstanding creditors of R964.69 million reported as at the end of June 2023. Municipalities cited various reasons for payments that are owed for more than 30 days.
16. Four (4) municipalities in the Western Cape collectively owe Eskom an amount of R200.09 million in outstanding payments overdue for more than 30 days. Each of the four (4) municipalities have received approvals for the Municipal Debt Relief programme.
17. The total cash and cash equivalents reported by municipalities as at the end of the first quarter amounted to R15.95 billion. However, this amount is overstated and does not align with figures in the Municipal Budget and Reporting Regulations (MBRR) schedules reported to municipal councils.
18. Provincial Treasury will continue to provide support to municipalities including guidance and support with mSCOA implementation, budget verifications, annual budget and in-year monitoring workshops, capacity building training initiatives, quarterly Chief Financial Officers' and Municipal Accountants Fora as well as facilitating the reduction of government debt owed to municipalities in conjunction with various government departments.
