TED IN GOVERNMENT NOTICE No. R. 1866 OF

The Honourable the Minister of the Interior has been
pleased to make, in terms of the provisions of section
sixteen of the Mission Stations and Communal Reserves
Act, 1909 (Act No. 29 of 1909), of the Cape of Good
Hope, the undermentioned amendment to the regulations
published in Government Notice No. R. 1866 of the 18th
November, 1960:—

the words: “within 21 days of such meeting” of
the words “immediately after confirmation of the
minutes by the Board of Management at its next
meeting.”.
