(a) die rekords en register wat in regulasies 57 (1) en 66 genoem word, tesame met ’n tjek ten gunste van die Sekretaris vir die kreditsaldo aangedui in die skoolraad se bankstaat wat deur die bankbestuurder as korrek gesertifiseer is; en

(b) alle vaste eiendom, uitrusting, meublement en voorrade in die skoolraad se besit;

aan die Streekdirekteur van Bantoe-onderwys oorhandig of oordra.

(2) Nadat die korrektheid van die betrokke rekords en register bevestig is, moet die Streekdirekteur van Bantoe-onderwys toesien dat fondse wat in die krediet staan van ’n skoolkomitee wat onder dié raad by sy ontbinding geressorteer het aan daardie komitee oorgedra word.

(3) Ander bates, roerend of onroerend, waaroor die skoolraad voor ontbinding beskik het, moet, soos deur die Streekdirekteur van Bantoe-onderwys aangedui, aan die vervangende raad of liggaam waaronder die skole ingedeel word, oorgedra word. Waar die skole onder meer as een raad of liggaam ingedeel word, word die bates aan dié vervangende raad of liggaam oorgedra soos deur die Sekretaris bepaal.”

AMENDMENT TO THE REGULATIONS FOR SCHOOL COMMITTEES, COMMITTEE-BOARDS AND SCHOOL BOARDS FOR BANTU COMMUNITY SCHOOLS.

Under and by virtue of the powers vested in me by sub-section (1) of section fifteen of the Bantu Education Act, 1953 (Act No. 47 of 1953), I, WILLEM ADRIAAN MAREE, Minister of Bantu Education, hereby amend the regulations published under Government Notice No. R. 1177 of 1960, as follows:—

DEFINITIONS.

1. By the insertion after the definition of “inspector of Bantu schools” of the following new definition: “‘inspector of Bantu Education’ shall have the same meaning as inspector of Bantu schools.”

PART II.

2. By the insertion in regulation 22 (2) after the word “chairman” in the last line of the words “at such meeting”.

PART III.

3. By the substitution in regulation 34 (1) (g) for the symbol “(e)” in the fourth line of the symbol “(f)”.

4. By the insertion in regulation 34 (3) after the word “nominated” in the first line of the words “or elected”.

5. By the insertion in regulation 39 (2) after the word “chairman” in the last line of the words “at such meeting”.

PART IV.

By the addition after regulation “81” of the following new regulation “82” under the heading “Disposal of Funds where a School Board ceases to exist:—

“82. (1) Before a school board is disestablished the chairman shall on a date determined by the Regional Director of Bantu Education, hand over or transfer to the Regional Director of Bantu Education—

(a) the records and register mentioned in regulations 57 (1) and 66, together with a cheque in favour of the Secretary for the credit balance reflected in the school board’s bank statement which has been certified as correct by the bank manager; and

(b) all fixed property, equipment, furniture and stores held by the school board.

(2) After the correctness of the records and register concerned has been confirmed, the Regional Director of Bantu Education shall see to it that any funds which stand to the credit of a school committee that fell under such board at the time of its disestablishment, be transferred to that committee.

(3) Any other assets, movable or immovable, held by the school board prior to its disestablishment shall be transferred as indicated by the Regional Director of Bantu Education to the substituting board or body under which the schools are grouped. Where schools are grouped under more than one board or body, the assets are transferred to such substituting boards or bodies as determined by the Secretary.”

The Honourable, WILLEM ADRIAAN MAREE, Minister of Bantu Education, has under and by virtue of the powers vested in him by sub-section (1) of section three of the Special Education Act, 1948 (Act No. 9 of 1948), approved the St. Thomas School for Deaf Bantu Children, situated approximately ten miles from Stutterheim, on the farm Fairview, adjoining the main road to King William's Town, with effect from the 1st September, 1961, as a Union special school for the Bantu.

Further particulars of the school are as follows:—

- (2) The governing body has corporate status and is represented at law by Bishop E. A. Green, P.O. Box 425, Port Elizabeth.

A class, educational or other institution established or recognised as or declared a State-aided class, school or institution under any Act administered by the Department.
