CUSTOMS ACT 1955.—EXERCISE OF POWERS BY THE MINISTER. (No. MR/8.)

I, NICOLAAS DIEDERICH, Acting Minister of Finance, acting in terms of the powers vested in me by section *one hundred and sixty-six* of the Customs Act, No. 55 of 1955, hereby amend the Regulations published under Government Notice No. R. 1001 of 17th November, 1961, by substituting the following new sub-paragaphs 110 (1) (a) to (g) for the existing sub-paragaphs 110 (1) (a) to (d):—

- (a) Item 491 of the Second Schedule to the Act for the purpose of being used for the manufacture, on behalf of the said person, of clothing by a manufacturer who is registered in terms of the said item 491;
- (b) item 493 of the Second Schedule to the Act for the purpose of being used for the manufacture, on behalf of the said person, of shirts collars and pyjama suits by a manufacturer who is registered in terms of the said item 493;
- (c) item 495 of the Second Schedule to the Act for the purpose of being used for the manufacture, on behalf of the said person, of scarves, stoles and neckerchiefs by a manufacturer who is registered in terms of the said item 495;
- (d) item 507 of the Second Schedule to the Act for the purpose of being used for the manufacture on behalf of the said person, of nightdresses by a manufacturer who is registered in terms of the said item 507;
- (e) item 622 (5) of the Second Schedule to the Act for the purpose of being used in the manufacture, on behalf of the said person, of kerbside and portable meter pumps for petrol, fuel oil or lubricating oil by a manufacturer who is registered in terms of the said item 622 (5);
- (f) item 652 (2) of the Second Schedule to the Act for the purpose of being used in the building, on behalf of the said person, of railless cars and buses by a manufacturer registered in terms of the said item 652 (2); or
- (g) item 791 (1) of the Second Schedule to the Act for the purpose of being refined, on behalf of the said person, by a refiner registered in terms of the said item 791 (1)."

- (2) hereby amend Government Notice No. R. 1041 of the 29th June, 1962, by the deletion in the Annexure of the reference to tariff items “205 ex (1) (c) (iv)” and “205 ex (1) (d) (ii)” in the first column and all the particulars in the second and third columns which have reference to the tariff items mentioned.

## REGULATIONS.

## AGRICULTURAL AND VETERINARY SERVICES.

The State President has been pleased, under the provisions of section twelve of the Statistics Act, 1957 (Act No. 73 of 1957), to make the following regulations in regard to the taking of annual censuses of Agricultural and Veterinary Services.

## 1. For the purpose of these regulations—

- "agricultural services" means agricultural, animal, husbandry and horticultural services, including (without limiting the scope of those words) baling, harvesting, packing, pest control, picking, ploughing, pruning, shearing, shelling, spraying and threshing, rendered as a separate business;
- "due date" means 30th September of any particular year;
- "proprietor" means the person for the time being in charge of a business rendering agricultural services, and includes the manager of such a business;
- "veterinary services" means veterinary services rendered by persons registered as veterinarians in terms of Act No. 16 of 1933.

## 2. On or before due date—

- (a) every proprietor shall for the year ending 30th June immediately preceding due date or, if the financial year of the business concerned ends on a date other than 30th June, for the financial year immediately preceding due date;
- (b) every person registered as a veterinarian in terms of Act No. 16 of 1933, shall for the year ending 30th June immediately preceding due date, in respect of veterinary services rendered by him during that year;

## REGULASIES.

## LANDBOU- EN VEEARTSENIDENSTE.

Dit het die Staatspresident behaag om, kragtens die bepalings van artikel twaalf van die Wet op Statistieke, 1957 (Wet No. 73 van 1957), die volgende regulasies in verband met die opname van jaarlikse sensusse van Landbou- en Veeartsenydienste uit te vaardig.

## 1. Vir die toepassing van hierdie regulasies beteken—

- "landboudienste" landbou-, veteelt- en tuinboudienste en sluit in (sonder om die begripsomvang van dié woorde te beperk) baal, oes, pak, plaagbestryding, pluk, ploeg, snoei, skeer, dop, spuit en dors, wat as 'n afsonderlike besigheid gelewer word;
- "vervaldatum" 30 September van 'n bepaalde jaar;
- "eienaar" die persoon wat op daardie tydstip beheer het oor 'n onderneming wat landboudienste lewer, en sluit die bestuurder van so 'n besigheid in;
- "veeartsenydienste" veeartsenydienste gelewer deur persone wat as veearts ooreenkomsdig Wet No. 16 van 1933 geregistreer is.

## 2. Voor of op die valdatum moet—

- (a) elke eienaar vir die jaar geëindig 30 Junie wat die valdatum onmiddellik voorafgaan of, indien die boekjaar van die betrokke besigheid op 'n ander datum as 30 Junie eindig, vir die boekjaar wat die valdatum onmiddellik voorafgaan;
- (b) elke persoon wat as veearts ooreenkomsdig Wet No. 16 van 1933 geregistreer is, vir die jaar geëindig 30 Junie wat die valdatum onmiddellik voorafgaan, ten opsigte van veeartsenydienste gedurende daardie jaar deur hom gelewer.

render a return in which he shall furnish all the information detailed in the Annexure hereto, or so much of such information as may be required by the Director of Census and Statistics and is set out on a form issued by the said Director. (The form for the purpose of rendering the return may be obtained on verbal or written application from the Director of Census and Statistics, Pretoria.)

3. The proprietor or person so registered shall address and post such return to the Director of Census and Statistics, Pretoria, or cause it to be so addressed and posted.

4. Any proprietor and any person so registered who without good cause fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand, and in the case of continued default, to a fine not exceeding two rand for every day during which such default continues.

  - (b) Capital: Purchase of vehicles, machinery, implements and tools; land and buildings, and any other capital expenditure in connection with agricultural or veterinary services.
7. Revenue.
  - (a) Current: Rent received in respect of hire of vehicles, machinery, implements and tools; income derived from agricultural or veterinary services, and any other income which has been or is received in respect of agricultural or veterinary services rendered.
  - (b) Capital: Income received from sale of vehicles, machinery, implements and tools; land and buildings and other assets used in connection with agricultural or veterinary services.

'n opgawe indien waarin hy alle gegewens verstrek wat in die Aanhanglel hiervan vervat is, of soveel van die gegewens as wat deur die Direkteur van Sensus en Statistiek verlang word, en wat vermeld word op 'n vorm deur die Direkteur uitgereik. 4. Elke eienaar en elke persoon aldus geregistreer wat sonder gegrond rede versuim om aan hierdie regulasies te voldoen, begaan 'n oortreding en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand, en in die geval van voortgesette versuim met 'n boete van hoogstens twee rand vir elke dag wat die versuim voortduur.
