APPLICATION OF THE REGULATIONS SET OUT IN THE SCHEDULE TO THE WINE AND SPIRITS CONTROL AMENDMENT ACT, 1954.

Whereas the Minister of Agricultural Economics and Marketing has reason to believe that the quantity of wine, wine as defined in the Wine and Spirits Control Act, 1956 (Act No. 38 of 1956), and intended for distillation purposes, produced or to be produced during the year 1964, will be insufficient to meet the estimated needs of the trade and the estimated requirements of the Ko-operatiewe Wijnbouwers Vereniging van Zuid-Afrika, Beperkt, in respect of such wine;

Now, therefore, on the recommendation of the Minister and under the powers vested in me by section two of the Wine and Spirits Control Amendment Act, 1954 (Act No. 22 of 1954), as amended, I hereby declare the regulations set out in the Schedule to the said Act, with the inclusion of regulation 3 thereof, to be operative for the period the first day of February, 1964, to the thirty-first day of January, 1965.

- (b) on payment of the levy mentioned in paragraph (2), to obtain such drugs and medicines as may be prescribed by a railway medical officer in terms of paragraph (7) of Regulation No. 45 either at a consulting room or at a servant's residence;

provided that such benefits shall not be applicable in a midwifery case.

(2) A levy of 10 cents shall be payable on each prescription issued in favour of the wife and children of a Coloured servant in respect of drugs, medicines and medical appliances (excluding orthopaedic and surgical appliances), dispensed at the expense of the Sick Fund.

(3) If a railway medical officer is required to visit the wife or child of a Coloured servant at the servant's residence, the servant will be responsible for the payment of the railway medical officer's fee.

(4) A District Secretary shall issue in favour of a Coloured servant to whom the provisions of paragraph (1) are applicable, a card indicating that his wife and children are entitled to the benefits prescribed in that paragraph.”
