PRICE CONTROL.

MAXIMUM PRICES OF MILK.

I, Heinrich Rudolph Philip August Kotzenberg, Price Controller, acting by virtue of the powers vested in me by section four of the Price Control Act, 1964 (Act No. 25 of 1964), do hereby amend, with effect from the 1st July, 1965, Government Notice No. R. 867 of 11th June, 1965 (maximum prices of milk), by the substitution of the following sub-paragraph for sub-paragraph (4) of paragraph 1:—

“(4) The maximum price at which fresh milk may be sold to a distributor in Nigel by a producer or may be purchased by such distributor from a producer, is 32·9 cents per 10·3 lb.”.
