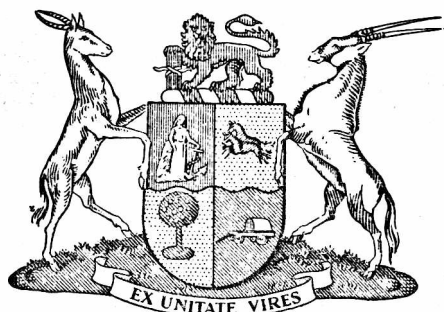

PRICE CONTROL.

MAXIMUM PRICES OF MINERAL WATERS AND FRUIT JUICES.

I, Heinrich Rudolph Philip August Kotzenberg, Price Controller, acting under the powers vested in me by sections four and five of the Price Control Act, 1964 (Act No. 25 of 1964), do hereby prescribe as follows:—

- (1) The maximum prices at which any manufacturer or bottler of mineral waters and fruit juices may sell such beverages (including fresh fruit juices, fruit based drinks and flavoured and unflavoured aerated and spa waters) ready for drinking without dilution to a dealer are the prices at which he ordinarily sold such beverages on 16th August, 1966, plus 8 cents per gallon.
- (2) Subject to the provisions of paragraph (1), the maximum prices at which any person may sell mineral waters and fruit juices (including fresh fruit juices, fruit based drinks and flavoured and unflavoured aerated and spa waters) ready for drinking without dilution in manufacturers' containers whether cooled or not cooled, opened or unopened, with or without a straw, are the prices determinable in accordance with the provisions of the First Schedule hereto.
- (3) The maximum deposits per bottle and per case which any seller may charge a person who buys mineral waters or fruit juices from him are the amounts specified in the Second Schedule hereto; and the amounts so specified are refunded by a seller of such beverages to any person who hands to him a returnable undamaged empty mineral water or fruit juice bottle or case of a brand in which he deals.
- (4) For the purposes of this notice "cost" is to be determined in accordance with the provisions of Government Notice No. R. 1532 of 2nd October, 1964.

PRYSBEHEER.

MAKSIMUM PRYSE VAN MINERAALWATER EN VRUGTESAP.

Ek, Heinrich Rudolph Philip August Kotzenberg, Prys-kontroleur, handelende kragtens die bevoegdheid my verleen by artikels vier en vyf van die Wet op Prysbeheer, 1964 (Wet No. 25 van 1964), bepaal hierby soos volg:—

- (1) Die maksimum pryse waarteen enige vervaardiger of bottelleerder van mineraalwater of vrugtesap, sodanige drank (insluitende vars vrugtesappe, drank met 'n vrugtebasis en gegeurde en ongegeurde spuit- en mineraalwater) gereed om sonder verdunning gedrink te word aan 'n handelaar mag verkoop, is die pryse waarteen hy sodanige drank gewoonlik op 16 Augustus 1966 verkoop het plus 8 sent per gelling.
- (2) Behoudens die bepalings van paragraaf (1) is die maksimum pryse waarteen enigiemand mineraalwater en vrugtesappe (insluitende vars vrugtesappe, drank met 'n vrugtebasis en gegeurde en ongegeurde spuit- en mineraalwater) gereed om sonder verdunning gedrink te word, in vervaardigershouers, hetsy verkoel of nie verkoel, oopgemaak of nie oopgemaak met of sonder 'n strooitjie mag verkoop, die pryse wat berekenbaar is ooreenkomstig die bepalings van die Eerste Bylae hiervan.
- (3) Die maksimum deposito's per bottel en per kas wat enige verkoper van 'n persoon wat mineraalwater of vrugtesap van hom koop, kan eis, is die bedrae wat in die Tweede Bylae hiervan aangegee word; en die bedrae aldus aangegee word deur 'n verkoper van sodanige drank uitbetaal aan enigiemand wat 'n terugstuurbare onbeskadigde leë mineraalwater- of vrugtesapbottel of kas van 'n merk waarin hy handel aan hom aanbied.
- (4) Vir die doeleindes van hierdie kennisgewing word „kospryse" bereken ooreenkomstig die bepalings van Goewermentskennisgewing No. R. 1532 van 2 Oktober 1964.

FIRST SCHEDULE.

Twelve cents per dozen for each ten cents or part of ten cents of cost per dozen, plus twelve cents per dozen; and the maximum price per unit is proportionate to the maximum price per dozen.

SECOND SCHEDULE.

1. Per bottle with a content of—
up to 16 fluid ounces..... 3 cents.
more than 16 fluid ounces..... 6 cents.
2. Per case containing not more than 24 bottles..... 20 cents.

Note.

The effect of this notice is—

- (a) that price control on mineral waters and fruit juices served in a glass or other drinking utensil is suspended;
- (b) that retailers' selling prices of mineral waters and fruit juices have to be calculated as follows:—
