IMPORT CONTROL.

I, NICOLAAS DIEDERICH, in my capacity as Minister of Economic Affairs and acting by virtue of the powers vested in me by section two of the Import and Export Control Act (Act No. 45 of 1963), do hereby prescribe the following in regard to the issue of import permits valid for 1967:—

Paragraph 1.—The goods mentioned in this paragraph in column (1) below and provided for in the respective customs tariff items, as shown in column (2), are hereby exempted from the provisions of Government Notice No. 1918, dated 6th December, 1957, and may be imported into the Republic of South Africa, from any country, without an import permit.

INVOERBEHEER.

Ek, NICOLAAS DIEDERICH, in my hoedanigheid van Minister van ekonomiese sake en handelende kragtens die bevoegdheid my verleen by artikel twee van die Wet op In- en Uitvoerbeheer (Wet No. 45 van 1963), skryf hierby die volgende voor met betrekking tot die uitreiking van invoerpermitte geldig vir 1967:—

Paragraaf 1.—Die goedere wat in hierdie paragraaf in kolom (3) hieronder genoem word en waarvoor in die betrokke doeanetariefitem voorsiening gemaak is, soos aangedui in kolom (2), word hierby vrygestel van die bepalinge van Goewermenskennisgewing No. 1918, gedateer 6 Desember 1957, en kan sonder 'n invoerpermit uit enige land in die Republiek van Suid-Afrika ingevoer word.

NOTE 1.—The articles appearing in paragraph 1 of this notice shall also be exempt from the production of permits when they are imported under rebate of customs duty under the Third, Fourth and Fifth Schedules to the Customs and Excise Act, No. 91 of 1964.

NOTE 2.—The meaning to be ascribed to any description of articles in paragraph 1 of this notice shall be the meaning attached to similarly numbered items in the First Schedule to the Customs and Excise Act, No. 91 of 1964.

NOTE 3.—All goods mentioned in this paragraph shall include maintenance spares therefor, provided such spares do not fall under the items in respect of which a specific permit is required in terms of paragraph 5 of this notice.

Paragraph 2.—Capital Plant and Equipment and Raw materials.—Import permits will be granted for importation of capital plant and equipment and raw materials required by—

- (i) industry;
- (ii) agriculture; and
- (iii) mining,

on the following basis:—

- (i) In the case of merchants who import such goods for re-sale—according to such quotas as may be authorised from time to time;
- (ii) in the case of manufacturers who import such goods for their own use—
 - (a) for raw materials—on the basis of consumption. (Upon receipt of such applications, import permits will be granted for an amount equal to the difference between the cost of the stock on hand of similar goods at the time of application and the cost of six months' stock at the current rate of consumption), and

Paragraaf 2.—Kapitaalgoedere en -toerusting en grondstowwe.—Invoerpermitte sal toegestaan word vir die invoer van kapitaalgoedere en -toerusting en grondstowwe nodig vir—

- (i) die nywerheid;
- (ii) die landbou; en
- (iii) die mynwese;

en wel op die volgende basis:—

- (i) In die geval van handelaars wat sodanige goedere vir herverkoop invoer—ooreenkomstig sodanige kwotas as wat van tyd tot tyd gemagtig mag word;
- (ii) in die geval van vervaardigers wat sodanige goedere vir eie gebruik invoer—
 - (a) ten opsigte van grondstowwe op 'n verbruiks-basis. (Na ontvangs van sodanige aansoeke, sal invoerpermitte toegestaan word vir 'n bedrag wat gelyk is aan die verskil tussen die koste van die voorraad voorhande van soortgelyke goedere ten tyde van 'n aansoek en die koste van 'n voorraad vir ses maande teen die heersende verbruikstempo), en

(b) for capital plant and equipment—on a basis of essentiality.

NOTE 1.—Manufacturers may apply for such import facilities at any time by submitting an application on form Excon 82 in respect of raw materials, and on form Excon 81 in respect of capital plant and equipment. (Both forms are appended to this notice).

NOTE 2.—In all cases, however, both manufacturers and merchants are expected to obtain their requirements of the goods and capital plant and equipment covered by this paragraph from local sources whenever it is possible to do so.

Paragraph 3.—Permits for the importation of the following will be issued to registered importers in accordance with such import quotas as may be authorised from time to time:—

- (i) Motor cars;
- (ii) commercial vehicles;
- (iii) motor cycles;
- (iv) motor scooters;
- (v) mopeds and auxiliary engines, including outboard motors;
- (vi) pedal cycles;
- (vii) C.K.D. material for motor vehicles; and
- (viii) maintenance spares and accessories for the above.

Permits will be issued to individuals to provide for the importation of built-up motor vehicles on the following basis:—

- (a) in the case of motor vehicles with an f.o.b. cost not exceeding R1,900—provided the motor vehicle has been used by the applicant for a period of not less than two (2) calendar months outside the Republic of South Africa and has been registered in the name of the applicant during that period; and
- (b) in the case of a motor vehicle with an f.o.b. cost exceeding R1,900—at any time on application.

Paragraph 4.—Quotas for the importation of the goods mentioned in this paragraph will be determined from time to time, and the relevant import permits will be issued to registered importers in accordance with such quotas.

(a) The undermentioned goods:—

- (ii) handelsvoertuie;
- (iii) motorfietsse;
- (iv) bromponies;
- (v) kragfietsse en hulp-enjins, met inbegrip van buite-boordmotore;
- (vi) trapfietsse;
- (vii) T.N.G.-materiaal vir motorvoertuie; en
- (viii) onderhoudsreserwedele en -toebehorens vir bo genoemde.

Permitte sal uitgereik word aan individue om voorsiening te maak vir die invoer van opgeboude motorvoertuie op die volgende basis:—

- (a) In die geval van motorvoertuie met 'n v.a.b.-koste van hoogstens R1,900—mits die motorvoertuig buite die Republiek van Suid-Afrika vir 'n tydperk van minstens twee (2) kalendermaande deur die applikant gebruik was en dit geregistreer was in die naam van die applikant gedurende daardie tydperk; en
- (b) in die geval van 'n motorvoertuig met 'n v.a.b.-koste van meer as R1,900—te eniger tyd op aansoek.

Paragraaf 4.—Kwotas vir die invoer van die goedere in hierdie paragraaf genoem, sal van tyd tot tyd vasgestel word, en die betrokke invoerpermitte sal in ooreenstemming met hierdie kwotas aan geregistreerde invoerders uitgereik word.

EXPLANATORY NOTE.

1. Government Notice No. R. 1937 dated 10th December, 1965, applies to 1966 import permits and the notice now published above, applies to 1967 import permits.

2. The attention of importers is directed to the goods grouped in paragraph 1 which may be imported without an import permit. This list now includes an additional number of items which were brought under import quotas by Government Notice No. R. 1238, dated 25th August, 1965, and which have now been transferred back to the free list.

3. The initial 1967 allocations for raw materials imported by merchants will be 50 per cent of the importer's imports during the calendar year 1964 for which the importer can produce stamped customs prime bills of entry.

4. The initial 1967 allocation for merchants for the importation of capital plant and equipment is as follows:—

- Merchant importers of capital plant and equipment with an f.o.b. price not exceeding R1,000 per single unit will be granted a first round allocation equivalent to 50 per cent of their 1964 imports.
- Merchant importers of capital plant and equipment with an f.o.b. price in excess of R1,000 per single unit must apply on the prescribed form Excon 81 which is appended to this notice.
- Merchant importers of machine tools will be granted a first round allocation equivalent to 50 per cent of their 1964 imports and thereafter will be permitted to maintain a stock level equal to six months, based on current sales.

Discussions are now taking place regarding the importation for stock purposes of printing machinery and road making and earthmoving equipment, and certain concessions in this respect will be made to merchant importers of these goods.

5. The attention of importers is directed to the list of goods in paragraph 4 (a). These goods include goods which, before 25th August, 1965, could have been imported without an import permit, as well as certain other items of general merchandise and goods which have now been removed from the restricted list.
