### GOVERNMENT NOTICES.

#### DEPARTMENT OF AGRICULTURAL TECHNICAL SERVICES.

No. R. 716.] [12 May 1967.  
NEWCASTLE DISEASE.—RESTRICTIONS—MOVE-  
MENT OF POULTRY, ETC.

Under the powers vested in him by section *twenty-seven* of the Animal Diseases and Parasites Act, 1956 (Act No. 13 of 1956), the Minister of Agricultural Technical Services has made the following regulations to prevent the introduction, occurrence or spread of Newcastle Disease:—

1. For the purposes of these regulations—

- (i) "dressed poultry", means the carcass of any poultry prepared for human consumption and from which the intestines, liver, feathers, head and feet have been removed;
- (ii) "place", means a farm or subdivision of a farm; and
- (iii) "poultry", means all domestic and non-domestic varieties of ducks, fowls, geese, guineafowls, partridges, peafowls, pheasants, pigeons and turkeys and the young of all such poultry.

2. No person shall move or cause or permit to be moved any poultry into, out of, through or from one place to another place within the area defined in the Schedule hereto except under the authority of a written permit issued by a State veterinarian, or otherwise than in accordance with the conditions specified in such permit. This prohibition shall not apply in the case of poultry intended for slaughter in the area defined in the Schedule hereto and despatched by rail or motor transport from an area outside or within the said area, provided such poultry is consigned to a municipal or other abattoir approved by a State veterinarian, or to a communal slaughtering place approved by a State veterinarian, and situated within a municipal area.

3. No person shall move or cause or permit to be moved any poultry carcass or portion thereof, or any poultry manure or feathers (except feathers contained in manufactured articles) into, out of, through or from one place to another place within the area defined in the Schedule hereto except under the authority of a written permit issued by a State veterinarian, or otherwise than in accordance with the conditions specified in such permit. This prohibition shall not apply in the case of dressed poultry carcasses moved into or within the said area from non-infected premises and consigned under contract to butchers, fishmongers, poulterers, hotels, restaurants, boarding-houses, grocers, distributors and consumers within the said area.

NEWCASTLESIEKTE.—BEPERKINGS—BEWEGING  
VAN PLUIMVEE, ENS.

Die Minister van Landbou-tegniese Dienste het, kragtens die bevoegdheid hom verleen by artikel *sewe-en-twintig* van die Wet op Dieresiektes en -parasiete, 1956 (Wet No. 13 van 1956), die volgende regulasies uitgevaardig om die inbring, voorkoms of verspreiding van Newcastle siekte te voorkom:—

1. Vir die toepassing van hierdie regulasies beteken—

- (i) „skoongemaakte pluimvee”, die karkas van enige pluimvee voorberei vir menslike verbruik, waarvan die binnegoed, vere, kop en pote verwyder is;
- (ii) „plek”, 'n plaas of onderverdeling van 'n plaas; en
- (iii) „pluimvee”, die mak en wilde soorte eende, hoenders, ganse, tarentale, patryse, poue, fisante, duiwe en kalkoene en die kleintjies van sodanige pluimvee.

2. Niemand mag enige pluimvee beweeg, laat beweeg of die beweging daarvan toelaat nie in, uit, deur of van een plek na 'n ander binne die gebied omskryf in die Bylae hiervan, uitgesonderd op gesag van 'n skriftelike permit deur 'n Staatsveearts uitgereik, en ook nie op 'n ander wyse as volgens die voorwaardes in sodanige permit gestel nie. Hierdie verbodsbepaling geld nie in die geval van pluimvee bestem vir slag in die gebied omskryf in die Bylae hiervan en per spoor of motorvervoer versend uit 'n gebied buite of binne gemelde gebied nie; met dien verstande dat sodanige pluimvee versend word na 'n munisipale of ander abattoir deur 'n Staatsveearts goedgekeur, of na 'n gemeenskaplike slagplek deur 'n Staatsveearts goedgekeur en binne 'n munisipale gebied geleë.

3. Niemand mag enige pluimveekarkas of 'n gedeelte daarvan of pluimveemis of -vere (uitgesonderd vere bevat in vervaardigde artikels) in, uit, deur of van een plek na 'n ander binne die gebied omskryf in die Bylae hiervan, beweeg, laat beweeg of die beweging daarvan toelaat nie, uitgesonderd op gesag van 'n skriftelike permit deur 'n Staatsveearts uitgereik en ook nie op 'n ander wyse as volgens die voorwaardes in sodanige permit gestel nie. Hierdie verbodsbepaling is nie van toepassing op skoongemaakte pluimveekarkasse wat na of binne gemelde gebied van niebesmette persele beweeg word en ooreenkomstig 'n kontrak aan slagters, vishandelaars, pluimveehandelaars, hotelle, restaurants, losieshuise, kruideniers, distribueerders en verbruikers binne gemelde gebied versend word nie.

4. No person shall move or cause or permit to be moved from the area defined in the Schedule hereto any eggs of poultry for hatching except under the authority of a written permit issued by a State veterinarian, or otherwise than in accordance with the conditions specified in such permit.

5. All owners or persons in charge of poultry within the area defined in the Schedule hereto shall confine such poultry in poultry-houses, pens, crates, runs or cages.

6. Every owner or person in charge of domestic ducks, fowls, geese, guineafowls, peafowls, turkeys and the young over one month old of such poultry in the area defined in the Schedule hereto, shall inoculate each head of such poultry with a Newcastle Disease Live Virus Vaccine approved by a State veterinarian, or such other vaccine as may be approved by the Director of Veterinary Services, and at such time during that period as may be fixed by a State veterinarian.

AMENDMENT OF BEERHALL REGULATIONS.

I, BARZILLAI COETZEE, Deputy-Minister of Bantu Administration and Education, hereby amend, on behalf of the Minister of Bantu Administration and Development under the powers vested in him by section 15 (1) (c) and (d) of the Bantu Beer Act, 1962 (Act No. 63 of 1962), Government Notice No. R. 1837, dated 13th November, 1964, as set out in the Schedule hereto, with effect from the date of publication hereof.

SCHEDULE.

Government Notice No. R. 1837, dated 13th November, 1964, is hereby amended as follows:—

By the substitution of the following regulation for regulation 2:—

“2. (1) Subject to the provisions of subregulations (2) and (3) Bantu beer may be sold or supplied on Mondays to Saturdays not earlier than 10 a.m. and not later than 10 p.m.

(2) Bantu beer may be sold or supplied on Sundays and the Day of the Covenant between the hours 2 p.m. and 5 p.m. only.

(3) Bantu beer may not be sold or supplied on Christmas Day, Good Friday or Ascension Day.”

4. Niemand mag enige pluimvee-broei-eiers beweeg, laat beweeg of die beweging daarvan toelaat nie uit die gebied omskryf in die Bylae hiervan, uitgesonderd op gesag van 'n skriftelike permit deur 'n Staatsveearts uitgereik en ook nie op 'n ander wyse as volgens die voorwaardes in sodanige permit gestel nie.

5. Alle eienaars of persone in beheer van pluimvee binne die gebied omskryf in die Bylae hiervan, moet sodanige pluimvee in pluimveehuise, hokke, kratte, kampe of koue hou.

6. Alle eienaars of persone in beheer van mak eende, hoenders, ganse, tarentale, poue, kalkoene en die kleintjies, ouer as een maand, van sodanige pluimvee binne die gebied omskryf in die Bylae hiervan, moet elkeen van sodanige pluimvee inent met 'n lewende virusentstof teen Newcastle-siekte, goedgekeur deur 'n Staatsveearts, of die ander entstof wat deur die Direkteur van Veeartsenydiens goedgekeur mag word, en op die tyd gedurende daardie tydperk wat deur 'n Staatsveearts bepaal mag word.

**1. PART IV.**

Regulation 29 is hereby amended by the addition of the following subregulation, the existing regulation becoming subregulation (1):—

“(2) No person shall by any method capture, attempt to capture, disturb or remove any rock lobster except for his own use in quantities not exceeding five per day: Provided that this subregulation shall not apply to any registered fishing boat”.

**2. PART VII.**

Regulation 76 is hereby amended by the addition of the following subregulation, the existing regulation becoming subregulation (1):—

“(2) No person shall use any trawl net within a distance of five nautical miles seawards from the coast line in the area bounded by a line (270° true) from the most southerly point at Cape Point and a line (270° true) opposite the mouth of the Orange River”.

AMENDMENT TO THE REGULATIONS FOR  
THE SOUTH AFRICAN POLICE.

The State President has been pleased, under the powers vested in him by section 33 of the Police Act, 1958 (Act No. 7 of 1958), to approve the following amendment to the Regulations for the South African Police promulgated under Government Notice No. R. 203 in *Government Gazette Extraordinary* No. 719 (Regulation Gazette No. 299) of the 14th February, 1964:—

- (1) *Regulation 18 (7)*.—Delete the whole subregulation and substitute therefor the following:—

"(7) On his initial appointment as a commissioned officer and on any subsequent promotion, a member shall be paid such amount for the purchase of the uniform equipment prescribed for his rank as from time to time may be determined by the Commissioner in consultation with the Treasury."

- (2) *Regulation 23 (3) (e) (ii)*.—Delete the word "motor" in the second line of the English version.

- (3) *Schedule C III (b)*.—After the words "Special Grade Chief Sergeant" under the heading "non-Whites" delete the words "A Castle mounted within a semi-circular laurel wreath" and substitute therefor the following words:—

"A three-bar chevron below the Coat of Arms of the Republic of South Africa within a laurel wreath."

„(7) By sy eerste aanstelling as offisier en by iedere daaropvolgende bevordering, word 'n bedrag soos van tyd tot tyd deur die Kommissaris in oorleg met die Tesourie bepaal mag word, aan 'n lid betaal vir die aankoop van die uniformuitrusting wat vir sy rang voorgeskryf is."

- (2) *Regulasie 23 (3) (e) (ii)*.—Skrap die woord „Motor" in die tweede reël van die Engelse teks.

- (3) *Bylae C III (b)*.—Na die woorde „Spesiale graad hoofersant" onder die opskrif „nie-Blankes", skrap die woorde „'n Kasteel binne 'n halfronde lourierkrans" en vervang dit deur die volgende woorde:—

„'n Driestreep-chevron onder die wapen van die Republiek van Suid-Afrika binne-in 'n lourierkrans."
