PRICE CONTROL.

**MAXIMUM PRICES OF MINERAL WATERS AND
FRUIT JUICES.**

I, Gabriël Josef Johannes Fourie Steyn, Price Controller, acting under the powers vested in me by section 4 of the Price Control Act, 1964 (Act No. 25 of 1964), do hereby prescribe that regulations 2 and 3 of Government Notice No. R. 1239, dated 18 August 1967 (maximum prices of mineral waters and fruit juices), shall not apply to fresh fruit juices marketed in containers of a half gallon or more.

SCHEDULE.

The Schedule to Government Notice No. R. 981 of 24 June 1966, is hereby amended by the substitution for clauses 1 to 5, inclusive under the heading "Part A—Durban" of the following clauses:—

"Maximum price."

1. Bottled milk sold by licence holder of restaurant, refreshment room or tea-room:—
 - (i) In half-pint bottles..... 5c per halfpint.
 - (ii) In pint or quart bottles..... 8c per pint.
2. Bottled milk delivered by a dairyman to persons other than persons referred to in items 3 and 4 hereof:—
 - (a) In half-pint bottles..... 5c per half-pint.
 - (b) In pint or quart bottles:—
 - (i) Credit..... 7·5c per pint.
 - (ii) Coupon..... 7·275c per pint.
 - (iii) Cash..... 7·5c per pint.
3. Bottled milk sold and delivered by a dairyman to a licensed boarding-house keeper or licensed hotel-keeper:—
 - (i) In half-pint bottles..... 64c per gallon.
 - (ii) In pint or quart bottles..... 58c per gallon.
4. Bottled milk sold and delivered by a dairyman to the holder of a licence authorising him to resell milk:—
 - (i) In half-pint bottles..... 64c per gallon.
 - (ii) In pint or quart bottles..... 56c per gallon.
5. Milk sold in cans in quantities of two gallons or more at any one time..... 54c per gallon.
6. Milk sold in cartons containing one pint or more:—
 - (i) When sold to the holder of a licence authorising him to resell milk..... 66c per gallon.
 - (ii) When sold to any other person..... 9c per pint."

BYLAE.

Die Bylae van Goewermentskennisgewing No. R. 981 van 24 Junie 1966 word hierby gewysig deur klousules 1 tot en met 5 onder die opskrif „Deel A—Durban” deur die volgende klousules te vervang:—

„Maksimum prys.

1. Melk, in bottels, deur lisensiehouer van restaurant, verversingskamer of teekamer verkoop:—
 - (i) In halfpintbottels..... 5c per halfpint.
 - (ii) In pint- of kwartbottels..... 8c per pint.
2. Melk, in bottels wat deur 'n melkery afgelewer word aan ander persone as die genoem in items 3 en 4 hiervan:—
 - (a) In halfpintbottels..... 5c per halfpint.
 - (b) In pint- of kwartbottels:—
 - (i) Krediet..... 7·5c per pint.
 - (ii) Koepon..... 7·275c per pint.
 - (iii) Kontant..... 7·5c per pint.
3. Melk, in bottels, verkoop en gelewer aan 'n gelisensieerde losieshuishouer of gelisensieerde hotelhouer:—
 - (i) In halfpintbottels..... 64c per gelling.
 - (ii) In pint- of kwartbottels..... 58c per gelling.
4. Melk, in bottels, verkoop en gelewer aan 'n houër van 'n lisensie wat houër magtig om melk te herverkoop:—
 - (i) In halfpintbottels..... 64c per gelling.
 - (ii) In pint- of kwartbottels..... 56c per gelling.
5. Melk in kanne verkoop in hoeveelhede van twee gellings of meer op 'n keer..... 54c per gelling.
6. Melk verkoop in kartonhouers wat een pint of meer bevat:—
 - (i) Wanneer verkoop aan die houër van 'n lisensie wat hom magtig om melk te herverkoop..... 66c per gelling.
 - (ii) Wanneer aan enige ander persoon verkoop..... 9c per pint."
