WYSIGING VAN DIE GELDEREGULASIES VIR SEKERE OPNEMINGSDIENSTE, 1968

AMENDMENTS TO THE FEES REGULATIONS FOR CERTAIN SURVEY SERVICES, 1968

Die Minister van Vervoer het, kragtens die bepalings van artikel 356 (1) van die Handelskeepvaartwet, 1951 (Wet No. 57 van 1951), soos gewysig, die regulasies in bygaande Bylae vervat met ingang van die datum van afkondiging hiervan gemaak.

The Minister of Transport has in terms of section 356 (1) of the Merchant Shipping Act, 1951 (Act No. 57 of 1951), as amended, made the regulations contained in the Schedule hereto, with effect from the date of promulgation hereof.

Die Gelderegulasies vir sekere Opnemingsdienste, 1968, soos afgekondig by Goewermentskennisgewing No. R.66 van 19 Januarie 1968, word soos volg gewysig:

1. Regulasie 7 (1) word hierby gewysig deur die uitdrukking „regulasie 13” deur die uitdrukking „regulasies 13 en 21 (12)” te vervang.
2. Regulasie 7 (2) word hierby gewysig deur na die woord „veiligheidsertifikaat” die woorde „'n laslyn-sertifikaat of 'n laslynvrystellingsertifikaat” in te voeg.
3. Regulasie 7 (4) (a) word hierby gewysig deur na die woord „veiligheidsertifikaat” die woorde „'n laslyn-sertifikaat of 'n laslynvrystellingsertifikaat” in te voeg.

The Fees Regulations for certain Survey Services, 1968 as promulgated by Government Notice No. R.66 of 19 January 1968 are amended as follows:

1. Regulation 7 (1) is hereby amended by the substitution for the expression “regulation 13” of the expression “regulations 13 and 21 (12)”.
2. Regulation 7 (2) is hereby amended by the insertion after the word “certificate” of the words “a load line certificate or a load line exemption certificate”.
3. Regulation 7 (4) (a) is hereby amended by the insertion after the word “certificate” of the words “a load line certificate or a load line exemption certificate”.

4. Die volgende regulasie word hierby na regulasie 20 ingevoeg:

„21. OPNEMING VAN 'N SKIP VIR 'N LASLYNSERTIFIKAAT

- (1) Behoudens die oorblywende bepalings van hierdie regulasie, moet die betrokke geld, ooreenkomstig onderstaande Tabele bereken, vir die opneming van 'n skip vir 'n laslynsertifikaat, met of sonder 'n laslynvrystellingsertifikaat, betaal word.

4. The following regulation is hereby inserted after regulation 20:

“21. SURVEY OF A SHIP FOR A LOAD LINE CERTIFICATE

- (1) Subject to the remaining provisions of this regulation, the appropriate fee calculated in accordance with the following tables shall be paid for the survey of a ship for a load line certificate with or without a load line exemption certificate.

(2) Wanneer 'n opnemer dit nodig vind om meer as een besoek aan 'n skip van meer as 300 ton te bring vir doeleindes van 'n tussentydse opneming wat by een geleentheid voltooi word, word die betrokke geld in Tabel A of Tabel B, na gelang van die geval, met R20 verhoog.

(3) Wanneer 'n opnemer 'n tussentydse opneming uitvoer wat nie by een geleentheid voltooi word nie, word die betrokke geld in Tabel A of Tabel B, na gelang van die geval, met R20 verhoog: Met dien verstande dat, indien die opnemer dit in die geval van 'n skip van meer as 300 ton nodig vind om meer as een besoek aan die skip te bring, die betrokke geld met R37.50 verhoog word.

(4) Wanneer 'n opneming van 'n geklassifiseerde skip vir hernuwing van die laslynsertifikaat deur 'n opnemer uitgevoer word en die opneming nie

(2) Where a surveyor finds it necessary to make more than one visit to a ship of over 300 tons for the purpose of an intermediate survey which is carried through in one operation, the appropriate fee in table A or table B, as the case may be, shall be increased by R20.

(3) Where a surveyor conducts an intermediate survey which is not carried through in one operation, the appropriate fee in table A or table B, as the case may be, shall be increased by R20: Provided that in the case of a ship of over 300 tons, if the surveyor finds it necessary to make more than one visit to the ship, the appropriate fee shall be increased by R37.50.

(4) Where a surveyor carries out a survey of a classed ship for the renewal of the load line certificate

- (5) Wanneer 'n opneming vir die uitreiking of hernuwing van 'n laslynsertifikaat deur 'n opnemer uitgevoer word en die opneming gelyktydig met die opneming vir 'n passasierskipveiligheidsertifikaat geskied—
 - (a) word geen geld ten opsigte van 'n geklassifiseerde skip betaal nie;
 - (b) moet die helfte van die geld in kolom 4 of 5 van Tabel B, na gelang van die geval, ten opsigte van 'n ongeklassifiseerde skip betaal word.
- (6) Wanneer 'n opneming vir die uitreiking of hernuwing van 'n laslynsertifikaat deur 'n opnemer uitgevoer word en die opneming gelyktydig met 'n opneming vir die uitreiking of hernuwing van 'n vragskipveiligheidskonstruksiesertifikaat geskied, moet die helfte van die betrokke geld in Tabel A of Tabel B, na gelang van die geval, betaal word.
- (7) Wanneer 'n tussentydse opneming deur 'n opnemer gelyktydig met 'n tussentydse vragskipveiligheidskonstruksie-opneming of 'n opneming vir 'n passasierskip se veiligheidsertifikaat uitgevoer word, word geen geld betaal nie.
- (8) Wanneer 'n opneming, wat nie 'n volle opneming is nie, vir verandering van vryboord as gevolg van geringe wysigings ten opsigte van 'n geklassifiseerde of ongeklassifiseerde skip deur 'n opnemer uitgevoer word, moet die geld in kolom 2 van Tabel A betaal word.
- (9) Wanneer 'n opneming, wat nie 'n volle opneming is nie, vir die uitreiking of hernuwing van 'n laslynsertifikaat waarvan die geldigheidsduur 12 maande of minder is, in 'n uitsonderlike geval deur 'n opnemer uitgevoer word, moet die helfte van die betrokke geld in kolom 1 of 4 van Tabel A of Tabel B, na gelang van die geval, betaal word.
- (10) 'n Bedrag van R10.75 is betaalbaar vir die verskaffing van inligting betreffende die waterdiepgang van 'n skip wat van 'n Suid-Afrikaanse hawe af op 'n besondere reis vaar.
- (11) Die betrokke geld in kolom 1 of 4 van Tabel A of Tabel B, na gelang van die geval, is betaalbaar vir 'n voorlopige aanwysing van vryboord: Met dien verstande dat geen geld vir 'n daaropvolgende opneming vir die eerste uitreiking van die laslynsertifikaat gevorder word nie.
- (12) 'n Bedrag van R10 is betaalbaar vir die uitreiking van 'n algehele laslynvrystellingsertifikaat, sonder 'n laslynsertifikaat".

when such survey is not concurrent with a classification survey, half the appropriate fee in column 1 of table A shall be paid.

- (5) Where a surveyor carries out a survey for the issue or renewal of a load line certificate at the same time as a survey for a safety certificate for a passenger ship—
 - (a) no fee shall be paid in respect of a classed ship;
 - (b) half the fee in column 4 or 5, as the case may be, in table B shall be paid in respect of an unclassified ship.
- (6) Where a surveyor carries out a survey for the issue or renewal of a load line certificate at the same time as a survey for the issue or renewal of a cargo ship safety construction certificate, half the appropriate fee in table A or table B, as the case may be, shall be paid.
- (7) Where a surveyor carries out an intermediate survey at the same time as an intermediate cargo ship safety construction survey or a survey for a safety certificate for a passenger ship, no fee shall be payable.
- (8) Where a surveyor carries out a partial survey for a change of freeboard consequent upon minor alterations to a classed or unclassified ship, the fee in column 2 of table A shall be paid.
- (9) Where a surveyor in a special case carries out a partial survey for the issue or renewal of a load line certificate with a validity of 12 months or less, half of the appropriate fee in column 1 or 4 of table A or table B, as the case may be, shall be paid.
- (10) A fee of R10.75 shall be paid for the supply of information concerning the draught of water of a ship on her proceeding from a South African port on a particular voyage.
- (11) The appropriate fee in column 1 or 4 of table A or table B, as the case may be, shall be paid for a provisional assignment of freeboard: Provided that no fee shall be paid for the subsequent survey for the first issue of the load line certificate.
- (12) A fee of R10 shall be paid for the issue of a total load line exemption certificate without a load line certificate".
