AMENDMENT OF THE FARMERS' SPECIAL
RELIEF PROCLAMATION, 1948 (PROCLAMATION
NO. 13 OF 1948), OF THE ADMINISTRATOR OF
SOUTH-WEST AFRICA

IN terms of the powers vested in me by section 20 of the South-West Africa Affairs Act, 1969 (Act No. 25 of 1969), I hereby amend the Farmers' Special Relief Proclamation, 1948 (Proclamation No. 13 of 1948), of the Administrator of South-West Africa, as set forth in the Schedule hereto, with effect from the first day of April, 1969, and I hereby prescribe that the transitory provisions relating to the administration of the said Proclamation, as set forth in the Schedule, shall apply.

SCHEDULE.

ADMINISTRATION OF THE FARMERS' SPECIAL RELIEF PROCLAMATION, 1948
(PROCLAMATION NO. 13 OF 1948), OF THE ADMINISTRATOR OF SOUTH-WEST AFRICA.

Interpretation of "manager" and "manager of the Land and Agricultural Bank of South West Africa" in Proclamation No. 13 of 1948 (South-West Africa).

Transitory provisions.

1. Any reference in the Farmers' Special Relief Proclamation, 1948, of the Administrator of South-West Africa, to "manager" or "manager of the Land and Agricultural Bank of South-West Africa", shall be construed as a reference to the Secretary of the Department of Agricultural Credit and Land Tenure of the Republic of South Africa or an officer or the incumbent of a post in the said Department designated by the said Secretary.

2. Anything done under the Proclamation referred to in section 1 prior to the commencement of this Schedule, by or in relation to the "manager" or the "manager of the Land and Agricultural Bank of South-West Africa", shall be deemed to have been done under the said Proclamation, as amended by this Proclamation, by or in relation to the Secretary for Agricultural Credit and Land Tenure referred to in section 1 of this Schedule.

SCHEDULE.

AMENDMENT OF THE PROMOTION OF FARMING INTERESTS ORDINANCE, 1952
(ORDINANCE NO. 29 OF 1952, OF THE TERRITORY OF SOUTH-WEST AFRICA).

1. In this Schedule "principal Ordinance" means the Promotion of Farming Interests Ordinance, 1952 (Ordinance No. 29 of 1952, of the Territory of South-West Africa).
2. Section 1 of the principal Ordinance is hereby amended—
 - (a) by the substitution of the following definition for the definition of "Accounting Officer": "*'accounting officer'* means the accounting officer of the Department of Agricultural Credit and Land Tenure of the Republic of South Africa;";
 - (b) by the substitution for the definition of "Secretary" of the following definition: "*'Secretary'* means the Secretary for Agricultural Credit and Land Tenure of the Republic of South Africa;".
3. Section 4 of the principal Ordinance is hereby amended by the substitution for paragraph (i) of subsection (1) of the following paragraph:
 - "(i) the chairman and vice-chairman of the State Settlement and Farmers' Assistance Board established in terms of section 2 of the Farmers' Assistance Ordinance, 1962 (Ordinance No. 11 of 1962), who shall act as chairman and vice-chairman respectively;".
4. Section 8 of the principal Ordinance is hereby amended by the substitution for subsection (1) of the following subsection:
 - "(1) the chairman and vice-chairman of the State Settlement and Farmers' Assistance Board established in terms of section 2 of the Farmers' Assistance Ordinance, 1962 (Ordinance No. 11 of 1962), who shall act as chairman and vice-chairman respectively;".

BYLAE.

WYSIGING VAN DIE ORDONNANSIE OP DIE BEVORDERING VAN BOERDERYBELANGE, 1952 (ORDONNANSIE NO. 29 VAN 1952, VAN DIE GEBIED SUIDWES-AFRIKA).

1. In hierdie Bylae beteken „Hoofordonnansie” die Ordonnansie op die Bevordering van Boerderybelange, 1952 (Ordonnansie No. 29 van 1952, van die gebied Suidwes-Afrika).

2. Artikel 1 van die Hoofordonnansie word hierby gewysig—

(a) deur die omskrywing van „rekenpligtige amptenaar” deur die volgende omskrywing te vervang:

„rekenpligtige amptenaar” die rekenpligtige amptenaar van die Departement van Landboukrediet en Grondbesit van die Republiek van Suid-Afrika;”;

(b) deur die omskrywing van „Sekretaris” deur die volgende omskrywing te vervang: „Sekretaris” die Sekretaris van Landboukrediet en Grondbesit van die Republiek van Suid-Afrika;”.

3. Artikel 4 van die Hoofordonnansie word hierby gewysig deur paragraaf (i) van subartikel (1) deur die volgende paragraaf te vervang:

(i) die voorsitter en ondervoorsitter van die Staatsnedersetting- en Boerebystandsraad ingestel kragtens artikel 2 van die Boerebystandsordonnansie, 1962 (Ordonnansie No. 11 van 1962), wat onderskeidelik as voorsitter en ondervoorsitter optree;”.

4. Artikel 8 van die Hoofordonnansie word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

"(1) All administrative work, including the payment and receipt of money, in connection with the performance of the functions or the exercise of the powers of the board, shall be performed by officers of the Department of Agricultural Credit and Land Tenure of the Republic of South Africa, unless this Ordinance otherwise determines."

5. Section 8bis of the principal Ordinance is hereby amended by the deletion of paragraph (b) of subsection (2).

6. The following section is hereby substituted for section 8ter of the principal Ordinance:

"8A. The board shall be a body corporate and shall under its own name be capable in law of suing and being sued, and subject to the provisions of this Ordinance of acquiring and alienating property, entering into contracts and generally transacting its business, and any transaction in connection with any of the said matters shall be transacted by the chairman or vice-chairman, duly authorized thereto in terms of a resolution of the board."

7. Section 14 of the principal Ordinance is hereby amended—

(a) by the substitution for subsection (4) of the following subsection:

"(4) Any such advance and the interest thereon shall be recoverable by the chairman or vice-chairman on behalf of the Fund and the board may consent to the cancellation of any mortgage bond or hypothec registered under section 15 and to the registration of any part payment in respect thereof."

(b) by the substitution for paragraph (v) of subsection (5) of the following paragraph:

"(v) waive the preferential right granted by the registration of a mortgage bond in terms of section 16."

8. For the purposes of sections 9, 10, 15, 16, 17, 18, 19, 20, 23, 24, 26, 27 and 28 of the principal Ordinance, a reference therein to the chairman or vice-chairman shall be construed as a reference to the Secretary or an officer or the incumbent of a post in the Department of Agricultural Credit and Land Tenure of the Republic of South Africa, designated by the Secretary.

SCHEDULE.

ADMINISTRATION OF THE FARMERS' SPECIAL RELIEF ORDINANCE, 1959 (ORDINANCE NO. 16 OF 1959, OF THE TERRITORY OF SOUTH-WEST AFRICA).

1. Section 1 of the Farmers' Special Relief Ordinance, 1959, South-West Africa (hereinafter called "the principal Ordinance"), is hereby amended by the deletion of subsection (1).

2. The principal Ordinance shall be construed—

(a) as if any reference therein to "board", is a reference to the State Settlement and Farmers' Assistance Board established in terms of section 2 of the Farmers' Assistance Ordinance, 1962 (Ordinance No. 11 of 1962, of the Territory of South-West Africa); and

„(1) Alle administratiewe werk, met inbegrip van die uitbetaling en ontvangs van geld, in verband met die verrigting van die werksaamhede of die uitoefening van die bevoegdheid van die raad, word, tensy hierdie Ordonnansie anders bepaal, verrig deur beampies van die Departement van Landboukrediet en Grondbesit van die Republiek van Suid-Afrika.”

5. Artikel 8bis van die Hoofordonnansie word hierby gewysig deur paragraaf (b) van subartikel (2) te skrap.

6. Artikel 8ter van die Hoofordonnansie word hierby deur die volgende artikel vervang:

„8A. Die raad is 'n regspersoon wat onder sy eie naam as eiser en as verweerde in regte kan optree en behoudens die bepalings van hierdie Ordonnansie goed kan verkry en vervaam, kontrakte kan aangaan en in die algemeen sy sake kan verrig, en enige handelinge in verband met enige van genoemde sake word verrig deur die voorstuur of ondervoorstuur, behoorlik daartoe gemagtig ooreenkomsdig 'n besluit van die raad.”.

(b) deur paragraaf (v) van subartikel (5) deur die volgende paragraaf te vervang:

„(v) afstand doen van die voorkeurreg verleen deur 'n verband geregistreer ingevolge artikel 16.”.
