PROHIBITION OF THE SALE OF CITRUS FRUIT IN THE REPUBLIC UNLESS GRADED, PACKED AND MARKED IN A PRESCRIBED MANNER

UNDER the powers vested in me by section 84 of the Marketing Act, 1968 (No. 59 of 1968), I hereby—

- (a) declare that the sale of citrus fruit in the Republic by any person is prohibited unless such citrus fruit—
(i) is sold according to the grades and size groups (if any) prescribed in respect thereof by regulation under section 89 of the said Act;
(ii) is packed into containers and in a manner so prescribed (excluding citrus fruit which is sold in loose quantities directly to the public);
(iii) is marked with particulars and in a manner so prescribed;
(b) declare that the provisions of this Proclamation shall not apply to citrus fruit in respect of which the Chief of Inspection Services has approved in writing that, subject to the conditions determined by him, it be sold as an experiment, and in respect of which such conditions have been complied with.

DECIDUOUS FRUIT SCHEME

PROHIBITION OF THE SALE OF APPLES IN CERTAIN AREAS EXCEPT SELECTED GRADE, CHOICE GRADE AND STANDARD GRADE APPLES

In terms of section 79 (b) of the Marketing Act, 1968 (No. 59 of 1968), I, DIRK CORNELIS HERMANUS Uys, Minister of Agriculture, hereby make known that the Deciduous Fruit Board, referred to in section 3 of the Deciduous Fruit Scheme, published by Proclamation R.288 of 1962, as amended, has, in terms of section 17 (r)^{bis} of that Scheme, with my approval and with effect from the date of publication hereof, imposed the prohibition set out in the Schedule hereto.

SCHEDULE

REGULATIONS RELATING TO THE GRADING, PACKING AND MARKING OF POTATOES INTENDED FOR SALE IN CERTAIN AREAS OF THE REPUBLIC OF SOUTH AFRICA

The Acting State President has, under the powers vested in him by section 89 of the Marketing Act, 1968 (No. 59 of 1968), made the regulations set out in the Schedule hereto in substitution of the regulations published by Government Notice R.3020 of 1 August, 1969, as amended, which is hereby repealed.

SCHEDULE

Definitions

1. In these regulations, unless inconsistent with the context, a word or expression to which a meaning has been assigned in the Act, shall have a corresponding meaning, and—

“consignment”, in relation to potatoes, means a quantity of potatoes of the same cultivar and of the same grade delivered at any one time under cover of the same consignment note, delivery note or receipt note, or from the same vehicle, or if any such quantity of the same grade is subdivided into different size groups, each quantity of each of the different size groups;

“decay” means a state of decomposition or fungus development, partly or completely affecting the quality of the potato;

“Department” means the Department of Agricultural Economics and Marketing;

„die Wet”, die Bemarkingswet, 1968 (No. 59 van 1968); „gesond”, vry van insekbeskadiging, insekbesmetting of uitwendige of inwendige gebreke; „groot houer”, 'n houer in regulasie 8 (2) voorgeskryf; „inspekteur”, 'n persoon aangewys as 'n inspekteur ingevolge artikel 85 van die Wet; „klein houer”, 'n houer in regulasie 8 (3) voorgeskryf; „misvormd”, dat die fatsoen van 'n aartappel van enige cultivar nie kenmerkend van daardie cultivar is nie.

DEEL I

ALGEMEEN

Doel van regulasies

2. Hierdie regulasies is gemaak vir die doel van die verbod wat kragtens artikel 84 van die Wet op die verkoop van aartappels in sekere gebiede opgelê is.

Inspeksie

3. (1) 'n Inspekteur kan in 'n besending aartappels soveel houers oopmaak en die inhoud daarvan ondersoek en monsters van sodanige inhoud neem vir die doel van verdere ondersoek of ontleding as wat hy nodig mag ag: Met dien verstande dat 'n inspekteur vir die doeleindeste van regulasie 7, die hele inhoud van elke individuele houer deur hom oopgemaak, moet inspekteer.

(2) Wanneer aartappels vir inwendige kwaliteit ondersoek word, moet die inspekteur 'n steekproefmonster aartappels van 3 000 g uit die houer neem en hiervan minstens 750 g wat volgens sy mening die swakste kwaliteit in die monster is, sny. Die massa van die aartappels wat gesny is wat nie aan die vereistes van die besondere graad voldoen nie, in verhouding tot die totale massa van die 3 000 g monster, word dan op 'n persentasie-basis bepaal.

(3) 'n Inspekteur se bevinding met betrekking tot die houers deur hom oopgemaak uit hoofde van die bepalings van subregulasies (1) en (2) en die inhoud van sodanige houers, geld as 'n beslissing ten opsigte van die hele besending waaruit sodanige houers getrek is.

Appèl

4. (1) Iemand wat hom deur 'n beslissing of optrede van 'n inspekteur veronreg ag, kan appèl aan teken teen sodanige beslissing of optrede deur binne 24 uur nadat hy van daardie beslissing of optrede in kennis gestel is, 'n kennisgewing van appèl by sodanige inspekteur in te handig, en binne genoemde tydperk by die inspekteur of by enige kantoor van die Afdeling Inspeksiedienste van die Departement, 'n deposito van $7\frac{1}{2}$ c ten opsigte van elke 15 kg aartappels of gedeelte daarvan, waaroor die appèl gaan, te deponeer: Met dien verstande dat die minimum bedrag van genoemde deposito R3 en die maksimum bedrag R20 is, en 'n afsonderlike deposito gestort moet word ten opsigte van elke afsonderlike besending, en met dien verstande verder dat indien die kennisgewing van appèl en deposito nie binne die voorgeskrewe tydperk van 24 uur ingedien en gedeponeer word nie, die appellant sy reg van appèl ingevolge hierdie regulasie verbeur.

(2) 'n Inspekteur kan aan aartappels ten opsigte waarvan 'n appèl aangeteken is, of aan die houers daarvan, enige merk of merke aanbring wat hy vir uitkenningsdoeleindes mag nodig ag, en sodanige besending aartappels mag nie sonder sy toestemming van die plek waar dit geïnspekteer is, of waar dit opgeberg is, verwyder word nie.

“inspector” means a person designated as an inspector in terms of section 85 of the Act; “large container” means a container prescribed in regulation 8 (2); “malformed” means that the shape of a potato of any cultivar is not typical of that cultivar; “potato” means the bulb of the plant *Solanum tuberosum*; “small container” means a container prescribed in regulation 8 (3); “sound” means free from insect damage, insect infestation or external or internal defects; “the Act” means the Marketing Act, 1968 (No. 59 of 1968).

PART I

GENERAL

Purpose of regulations

2. These regulations have been made for the purpose of the prohibition of the sale of potatoes in certain areas imposed under section 84 of the Act.

Inspection

3. (1) An inspector may in any consignment of potatoes, open as many containers and examine the contents thereof and remove samples of such contents for the purpose of further examination or analysis, as he deems necessary: Provided that an inspector shall, for the purpose of regulation 7, inspect the whole of the contents of each individual container opened by him.

(2) Whenever potatoes are examined for internal quality, the inspector shall take a sample at random of not more than 3 000 g from the container and cut not less than 750 g of those potatoes in the sample which he considers to be the poorest in quality. The mass of the potatoes which are cut, and which do not comply with the requirements of the particular grade, in relation to the total mass of the 3 000 g sample, is determined on a percentage basis.

(3) An inspector's finding in regard to the containers opened by him by virtue of the provisions of subregulations (1) and (2), and the contents of such containers, shall apply as a finding in respect of the whole consignment from which such containers were drawn.

Appeal

4. (1) Any person who feels aggrieved as a result of any decision or action taken by an inspector, may appeal against such decision or action by submitting a notice of appeal to an inspector within 24 hours after he has been notified of that decision or action, and depositing within the said period with such inspector, or at any office of the Division of Inspection Services of the Department, a deposit of $7\frac{1}{2}$ c in respect of every 15 kg potatoes or part thereof, which is the subject of appeal: Provided that the minimum amount of the said deposit shall be R3 and the maximum R20, and a separate deposit shall be lodged in respect of each separate consignment, and provided further that if the notice of appeal and deposit are not submitted and deposited within the prescribed period of 24 hours, the appellant shall lose his right of appeal in terms of this regulation.

(2) An inspector may apply to potatoes in respect of which an appeal has been lodged, or to the containers thereof, any mark or marks which he may consider necessary for identification purposes and such consignment of potatoes shall not without his consent, be removed from the place where it was inspected or where it is stored.

(3) Die Sekretaris van die Departement of 'n beampete van die Departement deur hom benoem, wys 'n persoon of persone aan deur wie oor so 'n appèl beslis moet word, en sodanige persoon of persone moet daaroor beslis binne 72 uur (uitgesonderd Sondae en publieke vakansiedae) na indiening daarvan, en die beslissing van die aldus aangewese persoon of persone is afdoende.

(4) Die aldus aangewese persoon of persone moet die appellant of sy agent minstens twee uur kennis gee van die tyd en plek bepaal vir die verhoor van die appèl, en mag, nadat die betrokke aartappels vertoon en uitgeken is en alle belanghebbendes aangehoor is, alle persone (met inbegrip van die appellant en sy agent en die inspekteur) gelas om die plek waar die appèl oorweeg word, te verlaat.

(5) (a) Indien 'n appèl gehandhaaf word, word die bedrag wat ten opsigte daarvan gedeponeer is aan die appellant terugbetaal.

(b) Indien 'n appèl van die hand gewys word, of as die aartappels waarop dit betrekking het, nie vertoon word nie op die tyd en plek bepaal deur die persoon of persone wat aangewys is om oor die appèl te beslis, word die bedrag wat ten opsigte daarvan gedeponeer is, verbeur.

DEEL II

GRADERING, VERPAKKING EN MERK

Gradering

5. (1) Daar is vier grade aartappels, naamlik Graad 1, Graad 2, Graad 3, en Ondergraad.

(2) Behoudens die toelaatbare afwykings in regulasie 7 voorgeskryf, is die vereistes vir die verskillende grade aartappels soos volg:—

(a) *Graad 1.—Die aartappels—*

- (i) moet gesond, vry van grond en uitloopsels en nie misvormd wees nie;
- (ii) moet vry van bederf wees;
- (iii) mag nie vergroen, verlep of waterig wees nie;
- (iv) mag nie deur son of hitte verskroei of deur ryp beskadig wees nie; en
- (v) mag nie deur uintjies, holhart of bruinvlek aangetas wees nie.

(b) *Graad 2.—Die aartappels—*

- (i) moet gesond en redelik vry van grond en uitloopsels wees en nie misvormd wees nie;
- (ii) moet vry van bederf wees;
- (iii) mag nie vergroen, verlep of waterig wees nie;
- (iv) mag nie deur son of hitte verskroei of deur ryp beskadig wees nie; en
- (v) mag nie deur uintjies, holhart of bruinvlek aangetas wees nie:

Met dien verstande dat aartappels wat effens verlep, waterig, deur son of hitte verskroei, misvormd, deur ryp beskadig of deur uintjies, holhart of bruinvlek aangetas is, of waarvan die knoppe verwijder is, by hierdie graad ingesluit mag word indien die intensiteit daarvan, van so 'n geringe aard is dat dit nie opmerklik afbreuk doen aan die algemene inwendige en uitwendige voorkoms van die aartappels nie.

(c) *Graad 3.—Die aartappels—*

- (i) moet gesond wees;
- (ii) moet vry van bederf wees;
- (iii) moet redelik vry van grond wees;
- (iv) mag nie vergroen, verlep of waterig wees nie;
- (v) mag nie deur son of hitte verskroei of deur ryp beskadig wees nie; en
- (vi) mag nie deur uintjies, holhart of bruinvlek aangetas wees nie:

(3) The Secretary of the Department or an officer of the Department nominated by him, shall designate a person or persons who shall decide such an appeal, and such person or persons shall decide such an appeal within 72 hours (excluding Sundays and public holidays) after it was lodged, and the decision of the person or persons so designated shall be final.

(4) The person or persons so designated, shall give the appellant or his agent at least two hours notice of the time and place determined for the hearing of the appeal, and may, after the potatoes have been produced and identified and all the interested parties have been heard, instruct all persons (including the appellant and his agent and the inspector), to leave the place where the appeal is being considered.

(5) (a) If an appeal is upheld, the amount deposited in respect thereof, shall be refunded to the appellant.

(b) If an appeal is dismissed, or if the potatoes to which it relates are not produced at the time and place determined by the person or persons designated to decide the appeal, the amount deposited in respect thereof, shall be forfeited.

PART II

GRADING, PACKING AND MARKING

Grading

5. (1) There shall be four grades of potatoes, namely Grade 1, Grade 2, Grade 3 and Undergrade.

(2) Subject to the allowable deviations prescribed in regulation 7, the requirements for the different grades of potatoes shall be as follows:—

(a) *Grade 1.—The potatoes shall—*

- (i) be sound, free from soil and sprouts, and not be malformed;
- (ii) be free from decay;
- (iii) not be greened, wilted or watery;
- (iv) not be scorched by the sun or heat or damaged by frost; and
- (v) not be affected by watergrass, hollow heart or brown fleck.

(b) *Grade 2.—The potatoes shall—*

- (i) be sound, reasonably free from soil and sprouts and not be malformed;
- (ii) be free from decay;
- (iii) not be greened, wilted or watery;
- (iv) not be scorched by the sun or heat or damaged by frost; and
- (v) not be affected by watergrass, hollow heart or brown fleck:

Provided that potatoes which are slightly wilted, watery, scorched by the sun or heat, malformed, damaged by frost or affected by watergrass, hollow heart or brown fleck or from which the knobs have been removed, may be included in this grade if the intensity thereof is of such a slight nature that the general internal and external appearance of the potatoes is not markedly detracted from.

(c) *Grade 3.—The potatoes shall—*

- (i) be sound;
- (ii) be free from decay;
- (iii) be reasonably free from soil;
- (iv) not be greened, wilted or watery;
- (v) not be scorched by the sun or heat or damaged by frost; and
- (vi) not be affected by watergrass, hollow heart or brown fleck:

Met dien verstande dat aartappels wat—

(aa) nie gesond is nie of deur uintjies of bruinvlek aangetas is by hierdie graad ingesluit mag word indien die intensiteit daarvan van so 'n aard is dat dit nie nodig is om meer as 25% van so 'n aartappel weg te sny vir die verwydering van dié aangetaste of beskadigde gedeeltes nie; en

(bb) verlep, waterig, deur die son of hitte verskroei, deur ryp beskadig of deur holhart aangetas is, by hierdie graad ingesluit mag word indien die intensiteit daarvan van so 'n aard is dat dit nie aansienlik afbreuk doen aan die algemene voor-koms van die aartappels nie.

(d) *Ondergraad.*—Aartappels wat nie aan die vereistes voorgeskryf vir enige van die voormalde grade vol-doen nie.

Groottegroepe

6. Behoudens die toelaatbare afwykings in regulasie 7 voorgeskryf, moet Graad 1 en Graad 2 aartappels in die volgende groottegroepe ingedeel word:—

- (a) *Groot.*—Aartappels wat minstens 200 g elk weeg;
- (b) *Medium.*—Aartappels wat minstens 55 g en hoogstens 200 g elk weeg.
- (c) *Klein.*—Aartappels wat minstens 20 g en hoogstens 85 g elk weeg.

Afwykings

7. Die maksimum afwykings van die vereistes voorgeskryf kragtens regulasies 5 en 6 wat ten opsigte van Graad 1, Graad 2 en Graad 3 toegelaat mag word, is soos volg:—

Houers

8. (1) Groot houers wat aartappels bevat, moet geskik, heel, skoon en vry van vreemde reuke wees en moet bestaan uit of goingsakkies of papiersakkies.

Provided that potatoes which are—

(aa) not sound or affected by watergrass or brown fleck, may be included in this grade if the intensity thereof is of such a nature that it is not necessary to cut away more than 25% of any such potato for the complete removal of the affected or damaged portions; and

(bb) wilted, watery, scorched by the sun or heat, damaged by frost or affected by hollow heart, may be included in this grade if the intensity thereof is of such a nature that the general appearance of the potatoes is not seriously detracted from.

(d) *Undergrade.*—Potatoes which do not comply with the requirements prescribed for any of the afore-mentioned grades.

Size Groups

6. Subject to the allowable deviations prescribed in regulation 7, Grade 1 and Grade 2 potatoes shall be divided into the following size groups:—

- (a) *Large.*—Potatoes that weigh at least 200 g each.
- (b) *Medium.*—Potatoes that weigh at least 55 g and not more than 200 g each.
- (c) *Small.*—Potatoes that weigh at least 20 g and not more than 85 g each.

Deviations

7. The maximum deviations from the requirements prescribed under regulations 5 and 6 that may be allowed in respect of Grade 1, Grade 2 and Grade 3 shall be as follows:—

Containers

8. (1) Large containers containing potatoes shall be suitable, unbroken, clean and free from foreign odours and shall consist of either hessian pockets or paper pockets.

(2) Die spesifikasies vir die onderskeie groot houers is soos volg:

(a) *Goiingsakkies.*—Die sakkies moet—

- (i) 'n kapasiteit vir die verpakking van minstens 16 kg aartappels hê;
- (ii) vervaardig wees van materiaal wat minstens 185 g en hoogstens 215 g per vierkante meter weeg;
- (iii) binnewante van 685 mm in lengte en 368 mm in breedte hê; en
- (iv) met gesikte tou toegewerk of toegeryg word en nie toegebond word nie; draad word nie toegelaat nie.

(b) *Papiersakkies.*—Die sakkies moet—

- (i) 'n kapasiteit vir die verpakking van minstens 16 kg aartappels hê;
- (ii) die volgende mate hê: 285 mm by 100 mm by 810 mm;
- (iii) vervaardig wees volgens—
 - (aa) S.A.S. en H. Spesifikasie C.P. 2/8; en
 - (bb) die Byvoegsel van S.A.B.S. Spesifikasie 694—1967; en
- (iv) toegemaak word deur dit krop te bind met draad waarvan die minimum deursnee 1,25 mm is; slegs draadstrikke wat spesiaal vir die doel vervaardig is, mag gebruik word.

(3) Klein houers wat aartappels bevat, moet—

- (a) gesik, skoon en vry van vreemde reuke wees; en
- (b) 'n kapasiteit vir hoogstens 8 kg aartappels hê.

Verpakking

9. (1) Slegs groot of klein houers mag vir die verpakking van aartappels gebruik word.

(2) Aartappels van verskillende grade of van verschillende groottegroep mag nie saam in dieselfde houer verpak word nie.

(3) Aartappels wat in dieselfde houer verpak is, moet min of meer ooreenstem in ryheid, cultivar en voorkoms.

(4) Die netto massa aartappels per groot houer moet minstens 15 kg wees.

(5) Die netto massa aartappels per klein houer mag hoogstens 8 kg wees.

Merk van Houers

10. (1) Groot houers wat aartappels bevat, moet duidelik en leesbaar in drukskrif op 'n etiket wat stewig daaraan geheg is, met die volgende gegewens gemerk wees:—

- (a) Die naam en adres van die produsent of verpakker of van die eienaar, indien laasgenoemde nie die produsent of verpakker is nie;
- (b) die graad van die aartappels;
- (c) die groottegroep van die aartappels in die geval van Graad 1 en Graad 2; en
- (d) die netto voorgeskrewe minimum massa van die aartappels in die houer.

(2) Etikette wat aan groot houers wat aartappels bevat, geheg moet word, moet van wit of vaal manillapapier minstens 80 mm lank en 40 mm breed en hoogstens 85 mm lank en 50 mm breed, wees en—

- (a) in die geval van Graad 1 aartappels, moet die etikette gemerk wees met 'n blou vertikale streep minstens 4 mm breed op albei kante daarvan, nie meer as 20 mm van die vasbindkant nie, en alle ander drukwerk daarop moet met blou ink wees;

(2) Specifications for the respective large containers are as follows:—

(a) *Hessian pockets.*—The pockets shall—

- (i) have a capacity for the packing of not less than 16 kg potatoes;
- (ii) be manufactured from material weighing not less than 185 g and not more than 215 g per square meter;
- (iii) have inside dimensions of 685 mm in length and 368 mm in width; and
- (iv) be closed by sewing or threading with suitable string and not by tying; wire shall not be allowed.

(b) *Paper pockets.*—The pockets shall—

- (i) have a capacity for the packing of not less than 16 kg potatoes;
- (ii) be of the following dimensions: 285 by 100 mm by 810 mm;
- (iii) be manufactured according to—
 - (aa) S.A.R. and H. Specification C.P. 2/8; and
 - (bb) the Supplement to S.A.B.S. Specification 694—1967; and
- (iv) be closed by bunch tying with wire with a minimum diameter of 1,25 mm; only wire ties manufactured specially for this purpose shall be used.

(3) Small containers containing potatoes shall—

- (a) be suitable, clean and free from foreign odours; and
- (b) have a capacity for not more than 8 kg potatoes.

Packing

9. (1) Only large or small containers shall be used for the packing of potatoes.

(2) Potatoes of different grades or different size groups shall not be packed together in the same container.

(3) Potatoes packed in the same container, shall more or less correspond in ripeness, cultivar and appearance.

(4) The net mass of potatoes per large container shall be not less than 15 kg.

(5) The net mass of potatoes per small container, shall be not more than 8 kg.

Marking of Containers

10. (1) Large containers containing potatoes, shall be marked clearly and legibly in printed letters on a label affixed securely to the container, with the following particulars:—

- (a) The name and address of the producer or packer or of the owner, if the latter is not the producer or packer;
- (b) the grade of the potatoes;
- (c) the size group of the potatoes in the case of Grade 1 and Grade 2; and
- (d) the prescribed minimum net mass of the potatoes in the container.

(2) Labels which shall be affixed to large containers containing potatoes, shall be of white or buff coloured manilla paper, not less than 80 mm long and 40 mm wide, and not more than 85 mm long and 50 mm wide, and—

- (a) in the case of Grade 1 potatoes, the labels shall be marked on both sides with a blue vertical line not less than 4 mm in width, not more than 20 mm from the tying end, and all other printing thereon shall be in blue ink;

- (b) in die geval van Graad 2 aartappels, moet die etikette gemerk wees met 'n groen horizontale streep minstens 4 mm breed op albei kante sodat dit in die lengte deur die middel daarvan loop, en alle ander drukwerk daarop moet met groen ink wees;
- (c) in die geval van Graad 3 aartappels, moet alle drukwerk op die etikette met rooi ink wees; en
- (d) in die geval van Ondergraad aartappels, moet alle drukwerk op die etikette met swart ink wees.

(3) Klein houers wat aartappels bevat, moet duidelik en leesbaar in drukskrif van minstens 5 mm hoog of op die houer self of op 'n etiket wat stewig op die houer aangebring is, gemerk wees met die volgende gegewens:—

- (a) Die naam en adres van die produsent, eienaar of verpakker van die aartappels;
- (b) die graad van die aartappels; en
- (c) die groottegroep van die aartappels in die geval van Graad 1 en Graad 2:

Met dien verstande dat indien klein houers wat aartappels bevat in groot houers verpak is, moet elke sodanige klein houer aldus met die genoemde gegewens gemerk wees.

(4) Die etikette op houers met aartappels, moet heel, skoon en netjies wees en mag nie bo-oor ander etikette aangebring wees nie.

(5) Wanneer aartappels in houers vir verkoop uitgestal word, moet sodanige houers geplaas word op 'n wyse om te verseker dat die voorgeskrewe merktekens op die houers of op die etikette, na gelang van die geval, duidelik sigbaar is.

(6) Wanneer aartappels anders as in groot of klein houers vir verkoop uitgestal word—

- (a) mag 'n hoeveelheid daarvan van 'n bepaalde graad of bepaalde groottegroep nie deurmekaar met aartappels van 'n ander graad of groottegroep aldus uitgestal word nie; en
- (b) moet die graad en, in die geval van Graad 1 en Graad 2, ook die groottegroep van so 'n hoeveelheid aartappels met duidelik leesbare drukskrif van minstens 10 mm hoog aangetoon word op 'n kennisgewingbord wat prominent by die betrokke hoeveelheid aartappels geplaas is.

(7) Geen bewoording, uitdrukking, ontwerp, illustrasie of devies wat moontlik, direk of by implikasie, 'n misleidende indruk kan skep van die inhoud, of van die gehalte, graad of groottegroep daarvan, mag op 'n houer wat aartappels bevat, op 'n etiket wat aan so 'n houer geheg is, of op 'n kennisgewingbord wat by sodanige aartappels geplaas is, gemerk word nie.

**REGULASIES BETREFFENDE DIE GRADING,
VERPAKKING EN MERK VAN SAGTEVRUGTE.—
WYSIGING**

Die Waarnemende Staatspresident het, kragtens die bevoegdheid hom verleen by artikel 89 van die Bemarkingswet, 1968 (No. 59 van 1968), die regulasies afgekondig by Goewermentskennisgewing R.1530 van 8 Oktober 1965, soos gewysig, verder gewysig soos in die Bylae hiervan uitgeseis.

BYLAE

Die Bylae van Goewermentskennisgewing R.1530 van 8 Oktober 1965, soos gewysig, word hierby soos volg verder gewysig:—

1. Regulasies 5 en 6 word hierby deur die volgende regulasies vervang:—

- (b) in the case of Grade 2 potatoes, the labels shall be marked on both sides with a green horizontal line not less than 4 mm in width passing along the length through the centre thereof, and all other printing thereon shall be in green ink;
- (c) in the case of Grade 3 potatoes, all the printing on the labels shall be in red ink; and
- (d) in the case of Undergrade potatoes, all the printing on the labels shall be in black ink.

(3) Small containers containing potatoes, shall be marked clearly and legibly in printed letters of at least 5 mm in height, either on the container itself, or on a label affixed securely to the container with the following particulars:—

- (a) The name and address of the producer, owner or packer of the potatoes;
- (b) the grade of the potatoes; and
- (c) the size group of the potatoes in the case of Grade 1 and Grade 2:

Provided that, if small containers containing potatoes are packed into large containers, each such small container shall so be marked with the said particulars.

(4) The labels on containers containing potatoes, shall be unbroken, clean and neat and shall not be affixed over other labels.

(5) Whenever potatoes are displayed for sale in containers, such containers shall be placed in such a manner to ensure that the prescribed markings on the containers, or on the labels, as the case may be, are clearly visible.

(6) Whenever potatoes are displayed for sale otherwise than in large or small containers—

- (a) any quantity of a particular grade or particular size group, shall not be so displayed mixed with potatoes of any other grade or size group; and
- (b) the grade and in the case of Grade 1 and Grade 2, also the size group of such quantity of potatoes shall be displayed in clear legible printed letters of at least 10 mm in height on a notice board prominently placed with such quantity of potatoes.

(7) No wording, expression, design, illustration or device which may possibly, directly or by implication create a misleading impression of the contents, or of the quality, grade or size group thereof, shall be marked on a container containing potatoes, on a label attached to such a container or on a notice board which is placed with such a quantity of potatoes.

**REGULATIONS RELATING TO THE GRADING,
PACKING AND MARKING OF DECIDUOUS
FRUIT.—AMENDMENT**

The Acting State President has, under the powers vested in him by section 89 of the Marketing Act, 1968 (No. 59 of 1968), further amended the regulations published by Government Notice R.1530 of 8 October 1965, as amended as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R.1530 of 8 October 1965, as amended, is hereby further amended as follows:—

1. The following regulations are hereby substituted for regulations 5 and 6:

,Houers

5. (1) *Algemeen.*—Houers wat sagtevrugte bevat, moet—

- (a) skoon, geskik en in 'n goeie toestand wees;
- (b) indien dit vir 'n tweede of daaropvolgende keer gebruik word, voor hergebruik deeglik skoongemaak word en al die ou etikette moet heeltemal verwyder of deur nuwe etikette bedek wees;
- (c) indien gemaak van veselbord, sterk en stewig genoeg wees om te verseker dat die oorspronklike vorm behoue sal bly en dit nie uitbult of indruk tydens normale hantering en vervoer nie; en
- (d) na gelang van die soort sagtevrugte daarin verpak, bestaan uit type A, B, C, D, E, F, G, H, I, J of K houers.

(2) *Spesifikasies.*—Behoudens die bepalings van sub-regulasie (1), is die spesifikasies vir die onderskeie type houers soos volg:

- (a) *Type A.*—'n Platkissie vervaardig van hout of gerifelde veselbord met binnemate van 432 mm lank, 292 mm breed en waarvan die diepte optioneel is volgens die bepaalde vereistes van elke geval;
- (b) *Type B.*—'n Houer vervaardig van hout of gerifelde veselbord met binnemate van 457 mm lank, 290 mm breed en 270 mm diep: Met dien verstande dat die mate effens mag awyk van die voorafgaande om vir sel-verpakking of rak-verpakking voorsiening te maak;
- (c) *Type C.*—'n Dubbellaag rak-verpakking of sel-verpakking, vervaardig van dubbelvlakrifvelveselbord van B-groef met binnemate van 502 mm lank, 302 mm breed en of 152 mm of 130 mm diep;
- (d) *Type D.*—'n Houthouer met buitemate van 441 mm lank, 232 mm breed en 'n nominale diepte van 190 mm. Sodanige houer moet vervaardig word van ten minste Graad 2 kwaliteit plankies soos omskryf in S.A.B.S.-Spesifikasie 452 van 1956, Standaardspesifikasie vir Landboukisplanke en -plankies. Die hoeveelheid en grootte van die plankies wat gebruik moet word vir die vervaardiging van die houer, is soos volg:

- (e) *Type E.*—'n Draadgebinde houthouer met binnemate van 403 mm lank, 264 mm breed en 264 mm diep. Die houers moet vervaardig word van geskilde, gesnyde of gesaagde plankies van geskikte kwaliteit, saamgebond met vier drade wat reghoekig met die deksel-, bodem- en syplankies gekram is; die draad en kramme moet van 'n geskikte dikte wees en die ente van die houer moet bestaan uit ongetemperde hardebord;
- (f) *Type F.*—'n Houer vervaardig van hout of gerifelde veselbord met binnemate van 457 mm lank, 292 mm breed en 222 mm diep: Met dien verstande dat die mate effens mag awyk van die voorafgaande om vir sel-verpakking en rak-verpakking voorsiening te maak;

"Containers

5. (1) *General.*—Containers containing deciduous fruit shall—

- (a) be clean, suitable and in a sound condition;
- (b) if used for a second or subsequent time, be effectively cleaned before being re-used and all old labels shall be completely removed or covered by new labels;
- (c) if made from fibreboard, be sufficiently strong and rigid so as to retain its original shape without bulging or becoming stove-in during the course of normal handling and transport; and
- (d) according to the kind of deciduous fruit packed therein, consist of Type A, B, C, D, E, F, G, H, I, J or K containers.

(2) *Specifications.*—Subject to the provisions of sub-regulation (1), the specifications for the respective types of containers are as follows:

- (a) *Type A.*—A tray manufactured from wood or corrugated fibreboard with internal dimensions of 432 mm in length, 292 mm in width and the depth of which shall be optional according to the particular requirements of each case;
- (b) *Type B.*—A container manufactured from wood or corrugated fibreboard with internal dimensions of 457 mm in length, 290 mm in width and 270 mm in depth: Provided that the dimensions may deviate slightly from the foregoing to provide for cell-packing or tray-packing;
- (c) *Type C.*—A double-layer tray-pack or cell-pack manufactured from double-faced corrugated fibreboard of B flute with internal dimensions of 502 mm in length, 302 mm in width and either 152 mm or 130 mm in depth;
- (d) *Type D.*—A wooden container with external dimensions of 441 mm in length, 232 mm in width and a nominal depth of 190 mm. Such container shall be manufactured from at least Grade 2 quality shooks as defined in S.A.B.S. specification 452 of 1956, Standard Specification for Agricultural Box shooks and Box Boards. The quantity and size of the shooks to be used for the manufacturing of the container shall be as follows:

- (e) *Type E.*—A wire-bound wooden box with internal dimensions of 403 mm in length, 264 mm in width and 264 mm in depth. The boxes shall be manufactured from peeled, sliced or sawn slats of suitable quality, bound together by four wires which shall be stapled at right angles to the top, bottom and side slats; the wire and staples shall be of a suitable gauge and the ends of the box shall consist of untempered hardboard;
- (f) *Type F.*—A container manufactured from wood or corrugated fibreboard with internal dimensions of 457 mm in length, 292 mm in width and 222 mm in depth: Provided that the dimensions may deviate slightly from the foregoing to provide for cell-packing or tray-packing;

- (g) *Tipe G.*—'n Platkissie met binnemate van 381 mm lank, 241 mm breed en waarvan die diepte opioneel is ooreenkomsdig die bepaalde vereistes van elke geval;
- (h) *Tipe H.*—'n Halfplukkis of plukkis;
- (i) *Tipe I.*—'n Paraffienkis;
- (j) *Tipe J.*—'n Houer met 'n netto kapasiteit vir hoogstens 2 kg sagtevrugte en wat gemaak is van fineerhout, geperste houtvesel, polietileen of ander soortgelyke of gesikte materiaal; en
- (k) *Tipe K.*—Houers vervaardig van polietileen of ander gesikte materiaal of papierhouers en waarvan die netto massa minstens 1,36 kg of hoogstens 2,27 kg moet wees.

(3) *Toemaak van Tipes A, B, C, D en F houers.*—Die houers moet voorsien word van deksels wat na verpakking in die geval van—

- (a) 'n houthouer, stewig aan sodanige houer vasgespyker is; en
- (b) 'n gerifelde veselbord-houer of soortgelyke tipe houer, aan die houer vasgeheg is deur middel van gompapier, kleefflint of krammetjies, of deur middel van enige ander gesikte metode.

(4) *Toemaak van Tipe E houers.*—Die houers moet voorsien word van deksels wat na verpakking stewig toegemaak is met draadlusse wat spesiaal vir hierdie doel gemaak is.

(5) *Toemaak van Tipe G houers.*—Die houers moet voorsien word van deksels wat na verpakking stewig aan sodanige houer vasgespyker is: Met dien verstande dat, indien die houers bo-op mekaar gepak en aanmekaar vasgespyker word, hoogstens 5 houers sodanig gepak en vasgespyker mag word en in so 'n geval moet slegs die boonste houer 'n deksel hê wat na verpakking stewig aan die houer vasgespyker is.

(6) *Toemaak van Tipes H en I houers.*—Die houers moet of van deksels voorsien word of elke sodanige houer moet uitgevoer word met 'n vel of velle skoon papier wat ook die vrugte in die boonste laag van die houer heeltemal bedek met 'n oorslag van sodanige papier.

Verpakking

6. (1) *Algemeen.*—Die algemene verpakkingsvereistes vir Uitsoekgraad, Keurgraad, Kaapsegraad en Standardgraad sagtevrugte is soos volg:—

- (a) Houers moet volverpak wees.
- (b) Vrugte moet stewig in die houers verpak word.
- (c) Vrugte in die boonste laag moet verteenwoordigend wees van die res van die vrugte in die houer.
- (d) Verskillende soorte of cultivars van sagtevrugte mag nie saam in dieselfde houer verpak word nie: Met dien verstande dat in die geval van druwe, meer as een cultivar in 'n houer verpak mag word indien die woorde 'GEMENGDE CULTIVARS' op sodanige houer gemerk word, tesame met die ander voorgeskrewe merkvereistes.

(2) *Appels.*—Behoudens die bepalings van subregulasie (1), is die spesifikasies vir die verpakking van appels soos volg:—

- (a) *Tipe houers.*—Die tipes houers vir die verskillende grade appels is soos volg:—

(g) *Type G.*—A tray with internal dimensions of 381 mm in length, 241 mm in width and the depth of which shall be optional according to the particular requirements of each case;

(h) *Type H.*—A half-lug or lug;

(i) *Type I.*—A paraffin box;

(j) *Type J.*—A container with a net capacity for not more than 2 kg deciduous fruit and which is made from wood veneer, moulded paper pulp, polyethylene or other similar or suitable material; and

(k) *Type K.*—Containers manufactured from polyethylene or other suitable material or paper carrier bags and of which the net mass shall be not less than 1,36 kg or more than 2,27 kg.

(3) *Closing of Types A, B, C, D and F containers.*—The containers shall be supplied with lids which shall after packing in the case of—

- (a) a wooden container, be securely nailed to such container; and
- (b) a corrugated fibreboard container or a container of a similar type, be attached to the container by means of gummed paper, adhesive tape or staples, or by any other suitable means.

(4) *Closing of Type E containers.*—The containers shall be supplied with lids which shall after packing be securely closed with wire loops specially made for this purpose.

(5) *Closing of Type G containers.*—The containers shall be supplied with lids which shall after packing be securely nailed to such container: Provided that if the containers are packed on top of each other and nailed together, not more than 5 containers shall be so packed and nailed together and in such case only the top container shall have a lid which shall after packing be securely nailed to such container.

(6) *Closing of Types H and I containers.*—The containers shall either be supplied with lids or each such container shall be lined with a sheet or sheets of clean paper which shall also completely cover the fruit in the top layer of the container by an overlapping portion of such paper.

Packing

6. (1) *General.*—The general packing requirements for Selected Grade, Choice Grade, Cape Grade and Standard Grade deciduous fruit shall be as follows:—

- (a) Containers shall be packed to capacity.
- (b) Fruit shall be packed firmly into containers.
- (c) Fruit in the top layer shall be representative of the fruit in the rest of such container.
- (d) Not more than one kind or cultivar of deciduous fruit shall be packed into the same container: Provided that in the case of grapes, more than one cultivar may be packed into one container if the words 'Mixed Cultivars' are marked on such container together with the other prescribed marks.

(2) *Apples.*—Subject to the provisions of subregulation (1), the specifications for the packing of apples are as follows:—

- (a) *Types of containers.*—The types of containers which shall be used for the different grades of apples are as follows:—

Selected Grade and Choice grade	Type A, B, C, D or J
Standard Grade	Type A, B, C, D, E, F or J
Undergrade	Type K or any other suitable container.

- (b) *Voering van houers.*—Die verskillende tipes houers waarin Uitsoekgraad, Keurgraad en Standaardgraad appels verpak word, moet soos volg uitgevoer word:
- Tipe A houers moet uitgevoer word met houtwol of rifelpapiervoering of ander geskikte materiaal, om die vrugte tydens vervoer en normale hantering teen beskadiging te beskerm.
 - Tipe B, D en E houers wat van hout vervaardig is, moet voor verpakking uitgevoer word met groen geglasuurde kraft papier, of 'n bruin rifelvoering van masjinaal-geglasuurde sage groepapier. Die voering moet van sy tot sy in die houer geplaas word, dwarsoor die bodem en moet 'n oorslag van 10 mm onder die deksel van die houer toelaat.
- (c) *Toedraai.*—Alle Uitsoekgraad en Keurgraad appels moet toegedraai word in geskikte sneespapier, behalwe wanneer dit verpak word in self of rak-verpakking in veselbord houers van Types B en C in welke geval die vrugte toegedraai of ontoegedraai mag wees. Standaard-graad appels mag op dieselfde manier toegedraai word of ontoegedraai wees.
- (d) *Sel- of Rak-verpakking.*—Alle Uitsoekgraad, Keurgraad of Standaardgraad appels moet—
 - indien verpak in Tipe B houers, of op 'n geskikte wyse verpak word in selle of rakkies in sodanige houers, of toegedraai word soos gespesifieer in paragraaf (c); en
 - indien verpak in Tipe C houers, as volg verpak word: Elke laag appels moet verpak word in 'n geskikte gevormde polistireenrakkie. 'n Verdere polistireenrakkie wat geskik is vir die bepaalde telling appels wat verpak is, moet onderstebo op die boonste laag van die appels geplaas word voordat die houer toegemaak word.
- (e) *Tellings en Metode van Verpakking.*—Appels moet soos volg in die verskillende tipes houers, verpak word:
 - Tipe A houers.*—Uitsoekgraad, Keurgraad en Standaardgraad appels moet in rye in enkellae verpak word;
 - Tipe B houers.*—Uitsoekgraad en Keurgraad appels moet in rye in meerlae verpak word. Standaardgraad appels moet of in rye in meerlae of deurmekaar verpak word: Met dien verstande dat indien die appels deurmekaar verpak is, die minimum deursnee van sodanige appels 50 mm moet wees;
 - Tipe C houers.*—Uitsoekgraad, Keurgraad en Standaardgraad appels moet in rye in meerlae verpak word. Die toelaatbare telling en grootte van die appels vir die verskillende dieptes van die houer is soos volg:

- (b) *Lining of containers.*—The different types of containers into which Selected Grade, Choice Grade and Standard Grade apples are packed, shall be lined as follows:
- Type A containers shall be lined with wood-wool or corrugated paper liners or other suitable material to protect the fruit from damage during transport and in the course of normal handling;
 - Type B, D and E containers which are manufactured from wood, shall be lined prior to packing with glazed green kraft paper, or a brown corrugated liner of machine-glazed soft fluting paper. The liner shall be placed from side to side inside the container, across the bottom and shall allow an overlap of at least 10 mm beneath the lid of the container.
- (c) *Wrapping.*—All Selected Grade and Choice Grade apples shall be wrapped in suitable tissue paper, except when packed in cell or tray-pack in fibreboard containers of type B and C in which case the fruit may be wrapped or unwrapped. Standard Grade apples may be so wrapped or unwrapped.
- (d) *Cell or Tray Pack.*—All Selected Grade, Choice Grade or Standard Grade apples shall—
 - if packed in Type B containers, either be suitably packed in cells or trays in such containers or be wrapped as specified in paragraph (c); and
 - if packed in Type C containers, be packed as follows: Each layer of apples shall be packed in a suitable moulded polystyrene tray. A further polystyrene tray suitable for the particular count of apples packed, shall be placed upside down over the top layer of apples before closing the container.
- (e) *Counts and Method of Pack.*—Apples shall be packed as follows into the different types of containers:—
 - Type A containers.*—Selected Grade, Choice Grade and Standard Grade apples shall be packed in rows in single layers;
 - Type B containers.*—Selected Grade and Choice Grade apples shall be packed in rows in multiple layers. Standard Grade apples shall either be packed in rows in multiple layers or be jumble packed: Provided that if the apples are jumble packed, the minimum diameter of such apples shall be 50 mm;
 - Type C containers.*—Selected Grade, Choice Grade and Standard Grade apples shall be packed in rows in multiple-layers. The allowable counts and sizes of the apples, for the different depths of the container shall be as follows:

- (c) *Wrapping.*—Selected Grade, Choice Grade and Standard Grade nectarines and peaches may either be wrapped in tissue paper or may be packed unwrapped.
- (d) *Method of pack.*—Selected Grade, Choice Grade and Standard Grade—
 (i) nectarines shall be packed in rows in single or double layers: Provided that if such fruit are packed in double layers, a sheet of clean paper shall be placed between each layer of fruit; and
 (ii) peaches shall be packed in rows in single layers.

(5) *Pears.*—Subject to the provisions of subregulation (1), the specifications for the packing of pears are as follows:—

- (a) *Types of containers.*—The types of containers which shall be used for the different grades of pears are as follows:—

Grade	Type of Container
Selected Grade and Choice Grade	Type A, E or J
Standard Grade	Type A, F, H or J
Undergrade	Type K or any other suitable container.

- (b) *Lining of containers.*—Type A and F containers into which Selected Grade, Choice Grade and Standard Grade pears are packed shall be lined with woodwool or a corrugated paper liner or other suitable material to protect the fruit from damage during transport and during the course, of normal handling.
- (c) *Wrapping.*—All Selected Grade and Choice Grade pears shall be wrapped in suitable tissue paper, except when packed in cell or tray-pack fibreboard containers of Type F in which case the fruit may be packed wrapped or unwrapped. Standard Grade pears may be so wrapped or unwrapped.
- (d) *Cell or Tray-Pack.*—All Selected Grade, Choice Grade or Standard Grade pears shall if packed in fibreboard containers of Type F, either be suitably packed in cells or trays in such containers, or be wrapped as specified in paragraph (c).
- (e) *Method of Pack.*—Pears shall be packed as follows into the different types of containers:—
 (i) *Type A containers.*—Selected Grade, Choice Grade and Standard Grade pears shall be packed in rows in single layers;
 (ii) *Type F containers.*—Selected Grade, Choice Grade and Standard Grade pears shall be packed in rows in multiple layers; and

(iii) *Tipe H houers.*—Standaardgraad pere moet of in rye in meerlae of deurmekaar verpak wees.

(6) *Pruime en Pruimedante.*—Behoudens die bepalings van subregulasie (1), is die vereistes vir die verpakking van pruime en pruimedante soos volg:—

(a) *Tipes houers.*—Die tipes houers wat vir die verskillende grade pruime en pruimedante gebruik moet word, is soos volg:—

Graad	Tipe van Houer
Uitsoekgraad en Keurgraad	Tipe A of J
Standaardgraad	Tipe A, H of J
Ondergraad	Tipe K of enigeerand geskikte houer.

(b) *Voering van houers.*—Tipe A houers waarin Uitsoekgraad, Keurgraad en Standaardgraad pruime en pruimedante verpak word, moet uitgevoer word met houtwol of rifelpapiervoering of ander geskikte materiaal om die vrugte tydens vervoer en normale hantering teen beskadiging te beskerm: Met dien verstande dat wanneer Keurgraad en Standaardgraad pruime en pruimedante in Tipe A houers met 'n diepte van 140 mm, verpak word, die voorsiening van sodanige voeringmateriaal opsioneel is.

(c) *Toedraai.*—Uitsoekgraad, Keurgraad en Standaardgraad pruime en pruimedante mag of in sneespapier toegedraai of ontoegedraai wees.

(d) *Metode van verpakking.*—Pruime en pruimedante moet soos volg in die verskillende tipes van houers verpak wees:—

(i) *Tipe A houers.*—Uitsoekgraad, Keurgraad en Standaardgraad pruime en pruimedante moet in rye in enkel- of dubbel- of trippellae verpak wees: Met dien verstande dat indien sodanige vrugte in dubbel of in trippellae verpak is 'n vel skoon papier tussen elke laag vrugte geplaas moet word; en

(ii) *Tipe H houers.*—Standaardgraad pruime en pruimedante moet of in rye in enkel- of dubbel- of trippellae of deurmekaar verpak wees.”.

2. Regulasie 9 (1) word hierby gewysig deur paragraaf (d) deur die volgende paragraaf te vervang:—

„(d) in die geval van Uitsoekgraad, Keurgraad en Standaardgraad appels, kaalperskes, perskes, pere en pruime, met die getal vrugte in sodanige houer, en in die geval van pruimedante met die netto massa of getal pruimedante in die houer: Met dien verstande dat—

(i) waar appels, kaalperskes en perskes in Tipe J houers en pere, pruime en pruimedante in tipe H en J houers verpak is, hierdie vereiste nie nagekom hoef te word nie; en

(ii) indien Standaardgraad appels deurmekaar verpak is in Tipe B, E en F houers, en die groottegroep, soos in regulasie 6 (2) (f) gespesifiseer, op sodanige houer aangebring is, hierdie vereiste nie nagekom hoef te word nie.”.

(iii) *Type H containers.*—Standard Grade pears shall either be packed in rows in multiple layers or be jumble packed.

(6) *Plums and Prune-Plums.*—Subject to the provisions of subregulation (1), the requirements for the packing of plums and prune-plums are as follows:—

(a) *Types of containers.*—The types of containers which shall be used for the different grades of plums and prune-plums are as follows:—

Grade	Type of Container
Selected Grade and Choice Grade	Type A or J
Standard Grade	Type A, H or J
Undergrade	Type K or any other suitable container.

(b) *Lining of containers.*—Type A containers into which Selected Grade, Choice Grade and Standard Grade plums and prune-plums are packed shall be lined with woodwool or a corrugated paper liner or other suitable material to protect the fruit from damage during transport and in the course of normal handling: Provided that if Choice Grade and Standard Grade plums and prune-plums are packed in Type A containers with a depth of 140 mm, the provision of such lining material shall be optional.

(c) *Wrapping.*—Selected Grade, Choice Grade and Standard Grade plums and prune-plums may either be wrapped in tissue paper or may be unwrapped.

(d) *Method of Pack.*—Plums and prune-plums shall be packed as follows into the different types of containers:—

(i) *Type A containers.*—Selected Grade, Choice Grade and Standard Grade plums and prune-plums shall be packed in rows in single or double or triple layers: Provided that if such fruit are packed in double or triple layers, a sheet of clean paper shall be placed between each layer of fruit, and

(ii) *Type H containers.*—Standard Grade plums and prune-plums shall either be packed in rows in single or double or triple layers, or be jumble packed.”.

2. Regulation 9 (1) is hereby amended by the substitution for paragraph (d) of the following paragraph:

“(d) in the case of Selected Grade, Choice Grade and Standard Grade apples, nectarines, peaches, pears and plums with the number of fruits in such container and in the case of prune-plums with the net mass or number of prune-plums in such container: Provided that—

(i) where apples, nectarines and peaches are packed in Type J containers and pears, plums and prune-plums in Type H and J containers, this requirement need not be complied with; and

(ii) if Standard Grade apples are jumble packed in Type B, E and F containers and the size group, as specified in regulation 6 (2) (f), is marked on such container, this requirement need not be complied with.”.

3. Regulation 13 is hereby deleted.
