**MAXIMUM PRICES OF DRIED FRUIT.—
AMENDMENT**

In terms of section 79 (b) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Dried Fruit Board, referred to in section 3 of the Dried Fruit Scheme, published by Proclamation R. 302 of 1962, as amended, has in terms of section 20 of that Scheme, with my approval and with effect from the date of publication hereof, amended the prohibition published by Government Notice R. 118 of 25 January 1974, as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R. 118 of 25 January 1974, as amended, is hereby further amended by the addition after clause 3 of the following clause:

"4. The foregoing prices do not apply to processed prunes, pitted or unpitted, imported in prepacked consumer packs under trade mark of the supplier."
